During ICM Helsinki: 12 Groups reporting Legal Tandems

During ICM Brno: Also 12 Groups reporting Legal Tandems

There's been developments both in *number* and also in *format*

- More physical Legal Tandem events
- More events organised for the purpose of a Legal Tandem

So, what is a Legal Tandem?

Legal Tandem defined in the ICM Decision Book:

4.1 Legal Tandem is a project during which two or more ELSA Groups from different countries organise a joint session for their members with the purpose of:

- a. discussing their legal systems;
- b. exploring the differences in their paths to becoming a legal professional;
- c. comparing the practices of their legal work culture or;
- d. engaging with other topics aimed at enhancing the skills needed for entering the job market.

4.2 The session may be carried out online or in person.

The Aim of Legal Tandems are to:

“Help law students and young lawyers navigate the increasingly international job market by expanding their knowledge on the topics of Legal Tandem. Additionally, the project supports the awareness of comparative legal research. The engagement of members from different ELSA Groups supports the fulfilment of ELSA’s vision in the PD area.”

1. Finding a Group to organise with
2. Deciding on the Topic
3. Deciding on Speakers & Interactive Element
4. Marketing
5. Conducting
6. Reviewing the event
