## Verification

#### What is Verification



Verification is the process through which all applications to ELSA Traineeships are subjected before being presented to the TNP (Traineeship Provider)

- done by Local Officers, National Officers and the ELSA Traineeships EIT
- all TAFs need to be reviewed, and accepted/declined by the Local and/ or National Officers in the SOS
- Local Officers are the first in line, closest to the applicant

### Why Verification is important



- Maintain quality standards for the programme by only allowing the higher quality applications and potentials trainees to be sent to the TNP
- improves overall quality of applications
- saves applications from getting eliminated
- eases the Matching process for the EIT

#### **Your Job**



- You help the applicants to have the best possible application
  - You need to reach out to them through email, calls, meetings
  - o Tip: set deadlines so YOU have enough time
- Keep an eye on the SOS throughout the whole SH period
- Your deadline is the «Internal Student Hunting Deadline»
  - All applications that are verified late will not get processed
- Leave a comment in the comment section in the SOS



### **Verification Criteria**

#### **Verification Criteria**

#### If an application scores 0 in any category, it must be rejected. The maximum score is 30.

Points	Motivation Letter	CV	Legal Skills	Language Skills	Proof of Legal Skills

1	Very poor ML, one sentence	Very poor CV, one sentence.	60% Match	Possesses required language	Basic description

3	Below average ML, between five and ten sentences with spelling/grammar mistakes	Below average CV, errors, non-English elements etc.	80% Match		
4	Average MI., one to two paragraphs. Generic content, some spelling/grammar mistakes	Average CV, little formatting but largely error-free	90% Match		
5	Mid-range ML, generic, possibly copied. good spelling/grammar	Mid-range CV, few errors, consistent format	100% Match		
6	Above average MI <sub>n</sub> relevant content, shows customisation, little to no spelling/grammar mistakes	Above average CV, well-formatted, little to no errors.	Exceeds skill level on required legal skills.		
7	Good ML, relevant content and specific to the TNP, not copied, no evident spelling/grammar mistakes	Good CV, formatted very well, no errors			
8	Very good ML, specific to TNP with clear customisation, well-formatted, no spelling/grammar mistakes	Very good CV, only relevant information, no errors			
9	Outstanding ML, relevant, customised with a clear application of skills to the requirements of the TNP	Outstanding CV, shows customisation for ET and no errors			
10	Flawless ML, excellent format, no errors, shows extensive research of the TNP and clear application of skills.	Flawless CV			



#### **Verification Criteria**

#### **Membership and Internationality**



- absolute requirements
- only members of ELSA can participate in ELSA Traineeships
- no substantial link between the country the trainee resides and the country the traineeship will take place
  - o problem with exchange students and international students
- TN-EI is open to everyone

#### **Education Level (Study Level)**



- absolute requirement
- must be met at the time the traineeship starts
- contact the trainee if unsure and leave a comment
- problem with differentiations between Bachelor and Masters
  - o go by (1) your Internal Guidelines (2) the Bologna System:
    - 180 ECTS = Bachelor
    - $\blacksquare$  +90 ECTS = Master

#### Language Skills



- Absolute requirement; only languages the TNP wants
- Basic: A1-A2; Good: B1-B2; Fluent: C1-C2
- Verify that the applicant possesses the skill through CV/certificates/study path/ a call

#### LANGUAGE SKILLS REQUIRED

English - Fluent

OR

Russian - Fluent

OR

Turkish - Good

#### LANGUAGE SKILLS REQUIRED

English - Fluent

AND

Russian - Fluent

OR

Chinese - Fluent

### **Legal Skills and Poof**



- at least 60% of legal skill required
  - only the skills the TNP wants are relevant
- proof of legal skills is an absolute requirement
  - o see next slide
- Skills:
  - o General: bachelor module
  - o Advanced: bachelor + master module/ SELS/WELS/thesis/papers...

- absolute requirement
- in English (name and places are exceptions)
- look out for spelling mistakes (the European Law <u>Student's Association</u>) and formatting issues
- ELSA has an offer for enhancing your ML
- ML(s) need to be individualised
  - o no copy paste ML, no copy paste structures
  - $\circ$  there is another issue..

#### CV



- absolute requirement
- in English (name and places are exceptions)
- look out for spelling mistakes (the European Law <u>Student's Association</u>) and formatting issues
- only relevant information (drivers licence, listing of published materials)
  - problem with Europass CV
