3. Number of Applications per ELSA National Group from September Call 2019

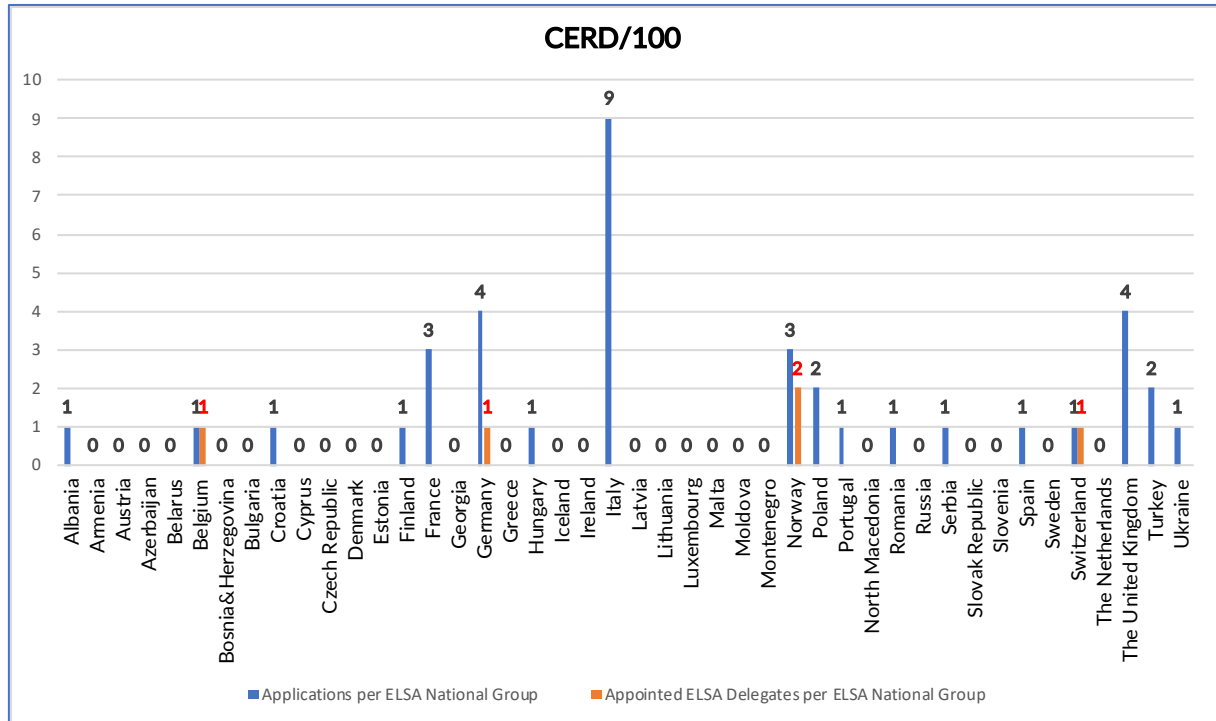

3. Number of Applications per ELSA National Group from November Call 2019

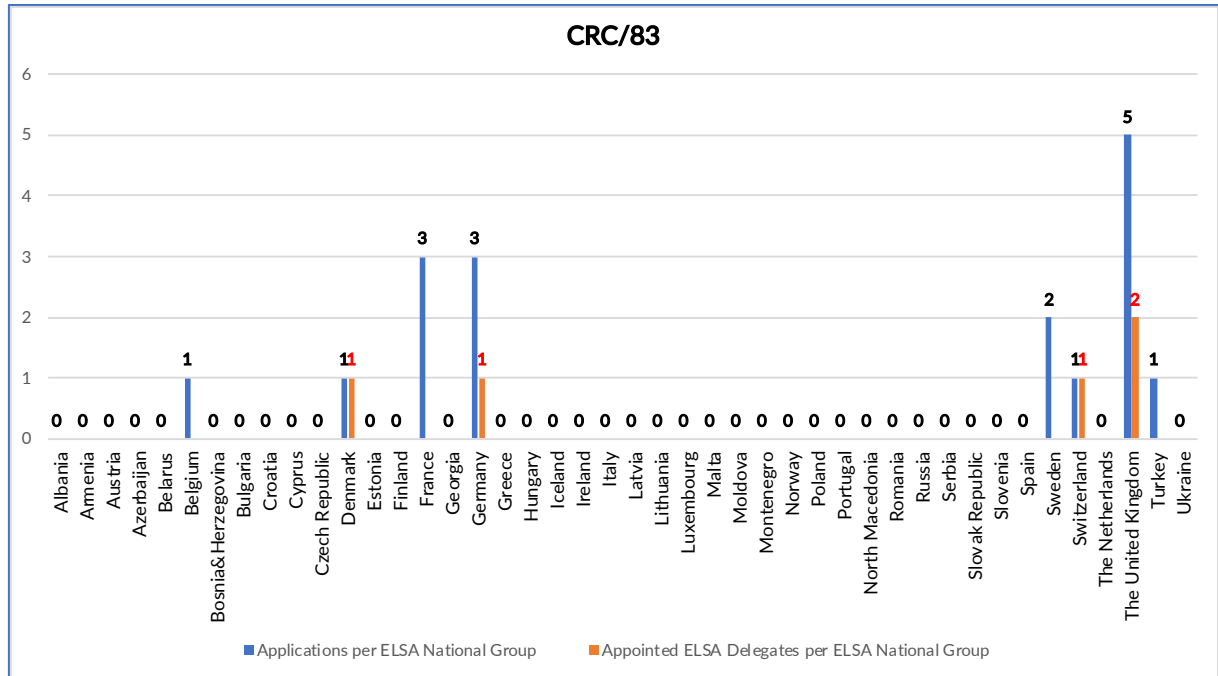

3. Number of Applications per ELSA National Group from January Call 2020

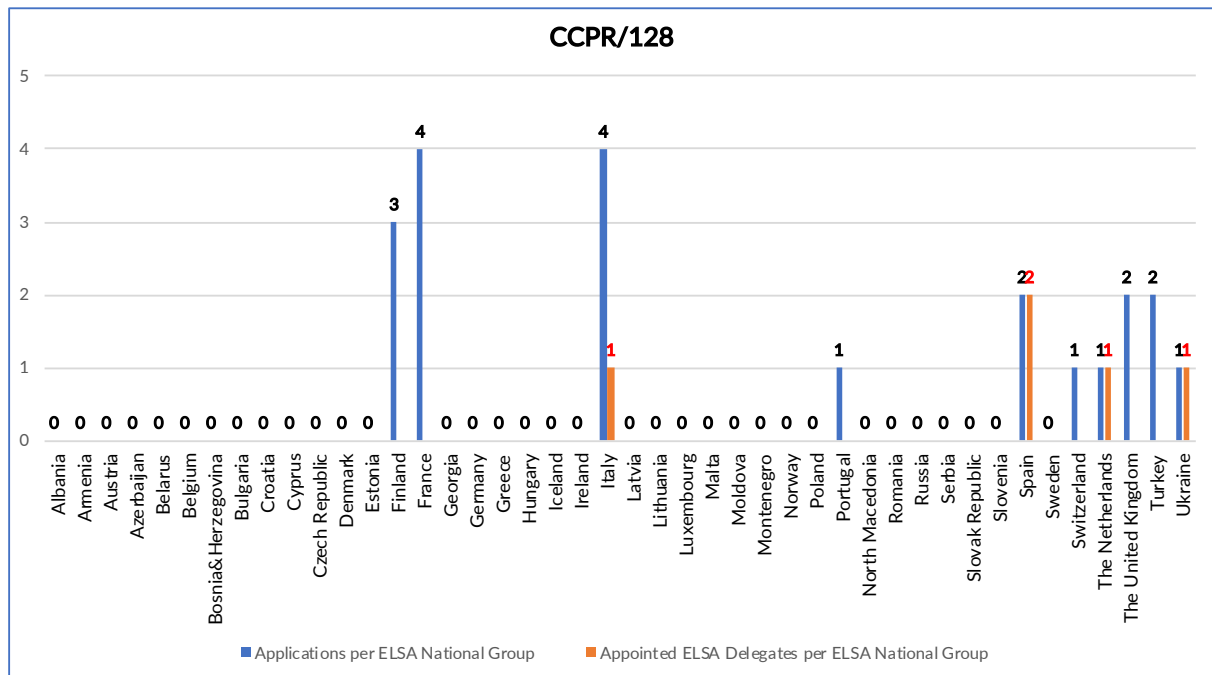
