This part is going to be focused on intellectual property on the Internet – filesharing and legal protection of software. Sharing of files is nowadays quite a regular activity that offers effortless access to digital information and sources, including documents, multimedia (audio/video), graphics, computer programs, etc. This concerns private and public distribution of data and sources, but also illegal operation and downloading. What can be still tolerated and what is considered as an infringement of the Intellectual Property Law? At the forenoon the lesson is going to be led by JUDr. Matěj Myška from the Institute of Law and Technologies from Faculty of Law, Masaryk University in Brno, whereas at the afternoon by Mgr. Lucie Straková from Administraton MU Department who will take over with Open Data Access.

#### WORK CAFÉ

Academic program is planned to be closed with an unusual event – a meeting of Czech start-up businessmen and the participants of the Brno Summer School to discuss IT Law issues in practise together. This will be the why, how the students will built a bridge from all the knowledge and skills they gained throughout the whole week to the practical usage of these. This mutually beneficial meeting will tak place in South Moravian Innovation Center, which serves as an "incubator" for Czech start-up business.

### **INSTITUTIONL VISITS**

Brno Summer School is designed for 30 foreign and Czech students who should meet at least seven lecturers from the Czech Republic as well as Belgium, Hungary or France. To show how practise is connected to discussed matters, students will visit several institutions in Brno.

#### The Public Prosecutor's Office – cyber criminality Wednesday August 5<sup>th</sup> (morn.)

With advance of informatics society a new challenge for public action also grows – cybercrime. How the Public Prosecutor's Office is handling this subject matter will participants learn during visit of this institution, which gained excellent responses.

#### Faculty of Informatics - cybernetics polygon Wednesday August 5<sup>th</sup> (morning)

Cybernetics polygon is a "how to manage cybernetics attacks" trainer which was developed in cooperation with ISC MU and LaSarIS. Most of the visit is going to be devoted to practical online illustration and all the participants are going to take part in.



## ECTS CREDITS

Granting these credits is conditioned with minimal attendance, which will be controlled at every lesson.
