## **FOREWORD**

The Helga Pedersen Moot Court Competition grows in relevance and importance with every year that passes. This outstanding opportunity to experience pleading a human rights case under rigorously realistic conditions concerns ever-growing numbers of young lawyers and it should be born in mind that thanks to the regional heats, this is extended to a large - and growing - number of students.

First, the 10th edition took place live, in-person, with teams confronting one another across the room, before a bench of judges and supervised by time-keepers. At the 7th competition, this would have been no novelty, but at the 10th, it was an agreeable change.

The author of the Foreword to last year's report wrote of the advantages of the online experience, and I agree entirely with what he says. In organising online competitions for two years, ELSA has established a viable concept which gave competitors concrete experience of a form of proceedings which will inevitably become more current in the future, as the lessons learned during the pandemic exert their influence over the evolution of the future judicial practice.

But the immediacy of 'in-presence' proceedings - their ability to generate palpable atmosphere and tension - enabled competitors to demonstrate their skills more fully and contributed to an excitement quite equivalent to that of a major sports event. What is more, the possibility for competitors to meet and spend time together, developing mutual understanding and forming friendships is something an online event can never offer.

The return to the in-presence format also brought the Competition back to the familiar premises of the Council of Europe and the European Court of Human Rights; the active support of both these bodies is, as ever, highly appreciated.





The 10th competition is also memorable for the quality of the case of Velez against Norland. This was a case which obliged competitors to venture beyond the familiar territory of human rights protection. It asks important questions about the nature of a government's responsibility and how it should be exercised in relation to a global phenomenon for which it is partially but not quantifiably responsible. Courts at all levels will have to grapple with such questions in various forms, preferably without rearguing the origins of climate change for every case they hear.

The case authors deserve our congratulations for issuing such an important challenge; the competitors responded to it with outstanding skill and imagination.

The 10th edition was one of the best, not only for the quality of its debates but also for the smoothness of its running. As organisers, the ELSA team had much to deal with, not least the inclusion of a 19th team as a result of international developments beyond their control.

War - or whatever you choose to call it if you dare not speak its name - is the ultimate violation of human rights. No norm, national or international, can stand in the presence of this monstrosity whose only aim is destruction.

As a consequence of war, the 10th edition of the Helga Pedersen Moot Court Competition missed certain teams whose predecessors had marked former editions with their great skill and motivation. We hope that the members of those past teams and their associates, together with the millions of their fellow citizens who have not forgotten the ideals of respect for human life and dignity, will soon find a way to restore normality.

The 10th edition was, in this writer's view, the best-ever: fairly fought, with an impressive blend of forensic insight, skill and imagination. To judge by the competitors' performances, the future of advocacy in the field of international humanitarian law should be in safe hands.

The Competition is a light in the obscurity of the present world landscape, darkened not only by war but by the re-emergence of ancient paranoias. After the 10th edition, it burns more brightly still.

## OVERVIEW OF THE COMPETITION

The 10th Helga Pedersen Moot Court Competition (HPMCC) was launched on the 20th of September 2021. The Case was written by Zuzana Kovalova and Slavica Čubrić, addressing present-day legal matters related to natural disasters and environmental protection. 59 teams registered from 26 different countries, and 54 teams fulfilled their responsibilities to continue with their participation in the Competition. The registration period lasted until the 10th of November, 2021.

For the first time, ELSA organised a Mooting 101 Webinar during the registration period on how to improve mooting skills. Our speaker, Ms Dr Amaya Ubeda de Torres, who works at the Council of Europe as a Senior Legal Officer, delivered the Webinar.

After all the teams completed their registration by the deadline, they had the opportunity of submitting up to 3 clarification questions to the case authors by the 25th of November 2021. Our case authors answered all relevant clarification questions following the deadline, and the answers were made publicly available on the website of the Competition as well as were sent to the teams via email.

Following the change of the structure of the Competition in the 8th Edition of the EHRMCC, this year, the Competition had also three stages: Written Round, Regional Rounds and the Final Oral Round. For the stage of the Written Round, the main task of the teams was to submit their Written Submissions both on behalf of the Applicant and Respondent by the 22nd of December 2021. As set in the Rules of the Competition, each Written Submission was scored by two different experts in the field of human rights, making an average Written Submission score of 4 gradings (two scores for the Applicant Written Submission and two scores for the Respondent Written Submission), which was followed by the Penalty Scoring done by the Helga Pedersen Moot Court Competition Team.





Upon successfully submitting their Written Submissions, teams had the chance to practice their oral pleading skills during the Regional Round phase. Due to the ongoing Covid-19 pandemic and related restrictions, the three Regional Rounds of the 10th HPMCC were held online, on the Coderblock platform. However, the Regional Rounds were organised by ELSA Kyiv and ELSA Ukraine (Virtual Regional Round Kyiv), ELSA Athens and ELSA Greece (Virtual Regional Round Athens) and ELSA Wrocław (Virtual Regional Round Wrocław). Each team had to plead twice during the assigned Regional Round – once on behalf of the Applicant and once on behalf of the Respondent - and each pleading was observed and scored by the Bench consisting of three human rights experts serving as Judges. We are grateful for all the contributions made by the Organising Committees of the Regional Rounds, Judges for the Regional Rounds as well as the participants. With their help, we had the opportunity to gather teams on one virtual platform and to ensure the academic quality of the event despite all the challenges faced.

For the last stage - the Final Oral Round of the Competition, we had the honour of welcoming the best 19 teams to Strasbourg, France - to the Headquarters of the Council of Europe and the European Court of Human Rights after two years of online editions. The Rules of the Competition allow the Organising Committee to invite only the best 18 teams based on their Written Submissions and Regional Round scores; however, for the 10th Edition, the Rules were amended to allow 19 teams to participate in the Final Oral Round to include one more team from Ukraine. The measure has been taken in the light of the ongoing war in Ukraine to provide equal opportunities to our Ukrainian participants with the rest of the participants to continue participating in the Competition even during these challenging times. The Final Oral Round took place for five days, from 9 May to 13 May 2022, with its Opening Ceremony and Academic Programme taking place on the first day, Preliminary Rounds taking place on the second and third days, Quarter and Semi-Finals taking place on the fourth day and the Grand Final taking place on the last, fifth day. The Grand Final was followed by the Closing and Awards Ceremony, which also took place at the European Court of Human Rights.





### WRITTEN ROUND

The Written Round is one and first of the three stages of the HPMCC. In order to be eligible to participate in the further stages of the Competition - Regional Rounds and the Final Oral Round registered teams had to submit their two Written Submissions on behalf of the Applicant and on behalf of the Respondent. For the 10th Edition, 54 teams out of 59 submitted their Written Submissions within the deadline set by ELSA International and got the chance to plead in the Regional Rounds.

Each Written Submission was scored by two independent human rights experts. The scoring of Written Submissions was organised in two rounds – the first round of scoring was organised between 4 and 23 January 2022, while the second round of Written Submissions scoring took place between 27 January and 21 February 2022.

32 human rights experts contributed to the 10th Edition of the Helga Pedersen Moot Court Competition by acting as a Judge and evaluating the Written Submissions. The Written Submissions were scored on four criteria, each weighing 25% of the written submission score. These criteria were:

- 1. **Identification of legal issues and relevant legal framework:** This ground sought to assess the team's general understanding of the case and the issues it raises.
- 2. **Knowledge of ECHR and relevant case law:** This ground sought to judge the extent of the team's technical ECHR knowledge.
- 3. **Quality of legal analysis and persuasiveness of arguments:** This ground concerned the overall persuasiveness of the team's pleadings and legal analysis.
  - 4. **Style:** This ground addressed issues of presentation and accessibility.

In addition to fulfilling the criteria set out above, teams also had to format the Written Submissions to comply with the criteria set out in the Rules of the 10th HPMCC.



According to the Appendix A of the Rules of the 10th HPMCC, the Written Submission Score is calculated as follows:

Based on the scores, Team 34 from Université Saint-Louis Bruxelles (Belgium) was awarded the prize for the Best Applicant Written Submission, while Team 16 from University of Passau; Chair of German, European and International Criminal Law, Criminal Procedure Law and White-Collar Crime (Germany) was awarded the prize for the Best Respondent Written Submission.

#### REGIONAL ROUNDS

Teams who submitted their Written Submissions on time move to the second stage of the Competition - Regional Rounds, where they present their legal arguments orally in front of the 3-members Bench of human rights experts. Regional Rounds are weighting 50% of the Qualification score to the Final Oral Round.

46 teams participated in one of three Regional Rounds, randomly assigned. Each Regional Round took place over three days and consisted of the Opening Ceremony, and Academic Programme on the first day, while two other days were reserved for the oral pleadings. Finally, each Regional Round ended with an Awards Ceremony on the evening of the third and final day, during which we handed out the prizes for the Best Applicant, Best Respondent and the Best Orator of the Regional Round.

Although the fact that the Regional Rounds were planned to be organised in a physical format on the launch of the 10th Edition, after constantly evaluating the ongoing Covid-19 situation in all of the three countries and lengthy discussions with the Organising Committees and within the International Board of ELSA, it was decided on proceeding with the virtual Regional Rounds in January 2022. During this evaluation, teams also had the opportunity to state their preference via the Covid-19 Feedback Form provided to them by ELSA International, which was taken into consideration while making the final decision. The decision was communicated to the teams on the official website of the Competition and via emails. Switching the format from physical to virtual did not result in any change of responsibilities or risk to the academic excellence of the Regional Rounds, and they were still organised by ELSA Kyiv and ELSA Ukraine (Virtual Regional Round Kyiv), ELSA Athens and ELSA Greece (Virtual Regional Round Athens) and ELSA Wrocław (Virtual Regional Round Wrocław). In this edition, we tried a different platform than the previous years - Coderblock , which received positive feedback from most teams and judges involved in the Regional Rounds.

Each team participating in the Regional Rounds had the chance of pleading twice – once on behalf of the Applicant party and once on behalf of the Respondent party and was scored on four criteria, namely:




## AN ORGANISER'S PERSPECTIVE

On Thursday, 10 March 2022, ELSA Greece and ELSA Athens were delighted to virtually welcome students from all across Europe for the Athens Regional Round of the 10th Helga Pedersen Moot Court Competition. Although we had initially set out to host this Regional Round on the premises of the National and Kapodistrian University of Athens, the ongoing pandemic rendered it impossible to carry out our original plan. Thus, the decision to transition into a digital format was made in early January. As the Regional Round, spanning over three days, was brought to a close on Saturday, 12 March, our six-month-long efforts had come to fruition.

The first day of the Competition entailed the Opening Ceremony and the Academic Programme. During the Opening Ceremony, the participants were greeted by the Organising Committee and the International Board of ELSA. Subsequently, Professor Maria Gavouneli delivered some constructive remarks on the importance of human rights in legal education and addressed recent developments in the field. We then proceeded to the drawing of lots to determine the pleading order for the following days. In the Academic Programme, we were honoured to welcome the Registrar of the European Court of Human Rights, Marialena Tsirli, whose enlightening presentation delved into the Court's response to the pandemic of COVID-19 and its reformed strategy for a more targeted case-processing mechanism.

Starting from Friday 11 March and carrying on to Saturday 12 March, the teams had the opportunity to present their pleadings both in respect of the Applicant and the Respondent States. 30 renowned experts, particularly well-versed in the subject matter of this year's case, thoroughly listened to the pleadings, posed insightful questions to the oralists, evaluated their performance and delivered valuable feedback. The Judges' scores, along with the ones in the Written Submissions phase, contributed toward the qualification of 18 teams for the Final Oral Round.

On Friday evening, we hosted a virtual Social Programme, where participants had the chance to unwind and network after a long day of pleadings. Ms Myrto Stavridi, a former winner of the Competition, offered advice on furthering one's legal career in an international environment. In turn, the Organising Committee attempted to convey elements of Greek culture that the participants would have experienced in person in the historical city of Athens.





The Regional Round Athens concluded on Saturday evening with the Closing Ceremony. Much to our pleasure, Professor Photini Pazartzis, Chair of the UN Human Rights Committee, joined us and addressed a meaningful closing statement to the participants. We then proceeded with the announcement of the awards. Team 19 was awarded Best Applicant, Team 17 was awarded Best Respondent, and Ella Grodzinski from Team 17 was announced as the Best Orator of the Athens Regional Round.

Last but not least, we could not be more honoured to have been trusted with the responsibility to host part of the largest English-speaking human rights-oriented moot court competition. Despite the long hours and hard work, organising this Regional Round was an incredibly fulfilling and rewarding experience for everyone involved. 

When we put forward our candidatures at the National Council Meeting of ELSA Ukraine, organising this event was one of the biggest and most important of our plans. As soon as our candidature was approved, we knew the responsibility which lay on our shoulders and wanted everything to proceed as perfectly as possible.

Soon, when our term started, we began our preparations. It was the first event of such a level for all of us, and we knew that it would not be easy. We had different options to decide on, such as the Supreme Court of Ukraine, the High Anti-Corruption Court of Ukraine etc. In the end, we agreed to proceed to the High Anti-Corruption Court, one of the most modern and well-equipped judicial bodies with whom we have already had cooperation experience in the previous events of ELSA Ukraine. We would like to express our deepest gratitude to the administration of the Court for their help and assistance, as well as their youthful readiness to help law students be better professionals.

One of our main desires was to hold the Regional Round in person, where people from all over the world could share their professional experiences and exchange their cultural backgrounds. The first strike for us was when it was decided to hold the Regional Round online based on the evaluation of the Covid-19 pandemic despite all the preparations which had been made to hold it in person. Following this decision, in February, a full-scale war broke out in Ukraine, which did not allow us to organise the Regional Round Kyiv by ourselves. As a result, we had to hand over all the organisational duties to ELSA International upon the agreement of both sides. This event meant a lot to us, and we were excitedly looking forward to holding it and welcoming law students and young lawyers to our capital, Kyiv. I hope that one day when the war ends, we will have such an opportunity, and Kyiv will accept all of its guests with great pleasure and hospitality. Between 18 and 20 March 2022, the second virtual Regional Round of the 10th HPMCC - Regional Round Kyiv - took place on the virtual platform Coderblock. When we launched the Competition, the Regional Round Kyiv was announced to all externals as the first Regional Round in the row and in our timeline, which was supposed to take place between 4 and 6 March 2022. ELSA Kyiv and ELSA Ukraine started their preparations very early as other Regional Round Organisers and through this period, ELSA International showed its support through regular calls and helping with all possible difficulties. 

## AN ORGANISER'S PERSPECTIVE

The HPMCC Regional Round in Wrocław was a project of ELSA Wrocław that we have all been waiting for, the highlight of our term. The Organising Committee consisted of Maciej Łodziński, President of ELSA Wrocław, Kaja Niewęgłowska, the Director in charge of Human Resources of ELSA Wrocław, Emilia Maćkowiak, the Vice President in charge of Marketing of ELSA Wrocław, and numerous ELSA Wrocław members. In addition, the Academic Programme was put together by Maurycy Oroń, the Vice President in charge of Academic Activities of ELSA Wrocław and Maciej Łodziński, the President of ELSA Wrocław.

We began preparations in October 2021 by establishing the Organising Committee, dividing tasks, and setting deadlines. Initially, we were planning to host the Regional Round physically in Wrocław. However, we kept regular contact with the International Board of ELSA, and due to the ongoing pandemic, we decided to execute the event in the virtual format in early January 2022.

After changing the format, we focused on finding and contacting judges and speakers for the Academic Programme of Helga Pedersen Moot Court Competition Regional Round Wrocław. Having moderate success with finding judges, we received help from the international Organizing Committee and could fulfil all the judges' roles.

Throughout the preparation phase, we were in constant contact with participants of our Round by i.a., responding to questions and providing updates on the competition. We also planned the Social Programme, which consisted of online games, quizzes, and conversations during this time.

This year we faced another challenge in the shape of a new platform used to conduct the event - Coderblock. Having not worked with the platform before the competition, we made sure that we did our research, participated in the training, and tested the platform ourselves before the Opening Ceremony. In order to allow the event to run smoothly, we provided the judges and participants with a series of video tutorials on how to use the platform, as well as materials regarding the Competition, which included rules and guidelines.

On 25 March 2022, we officially welcomed all participants, judges, and guests of the Regional Round Wrocław. At the beginning of the event, we conducted the Opening Ceremony through the Coderblock platform. During the ceremony, Samira Safarowa, Vice President in charge of Academic Activities of the International Board of ELSA, greeted all attendees, which was later followed by a short speech by Maciej Łodziński, Head of the Organizing Committee. Here, the Organising Committee proceeded with a drawing ceremony and talked everyone through the structure of the weekend. The Ceremony ended with the Organizing Committee wishing everyone the best of luck throughout the competition.

After a lunch break, we proceeded with the Sponsor's Fair, during which we heard a presentation done by Ms Justyna Piasecka from the Bailiffs Chamber in Wrocław. During the presentation, the speaker briefly described the functions of the Chamber, and the job of a bailiff and highlighted the use of new technologies in their work. ELSA Wrocław is grateful for the support they received in order to achieve the highest level of the event and quality awards for the best participants/teams. Then, the participants had the unique opportunity to attend the Academic Programme - lecture on



'LGBT+ rights in Europe in relation to ECHR jurisprudence". Karolina Gierdal, renowned Polish ECHR human rights lawyer and lgbtq+ activist, shared her experiences with her international practice. She also explained how the ECHR interprets the European Convention on Human Rights and other international acts to achieve equality of rights for non-heteronormative people.

During the following days, Saturday and Sunday, 26 and 27 March 2022, each participating team pleaded before the juries of human rights scholars and practitioners. During each of the sessions, the members of the Organising Committee acted as timekeepers. They "presented the case before the court", kept track of the time and rules of the competition and assisted in solving technical problems.

In addition to the pleadings we also planned the Social Programme, which took place on the evening of 25 and 26 March. It was an opportunity for participants and organisers to meet in a more casual atmosphere. On 25 March, the participants were presented with online sightseeing of Wrocław - a substitute for physical sightseeing, followed by a quiz on knowledge of the city. On 26 March, there was even more time for getting to know each other and playing online games like "hangman" or "puns game".

Finally, the Closing and the Awards Ceremony took place on Sunday evening. Once again, on the virtual stage, the participants "met" on a virtual stage with the organisers. The organisers announced the Best Applicant and the Best Respondent of the Regional Round, followed by the Best Oralist and made short speeches thanking participants, judges, and the Organising Committee. Afterwards, we listened to a speech by one of the judges - prof. Marcin Marcinko from Jagiellonian University, who summed up the event, once again praised the participants and congratulated everyone involved for showing a high level of professionalism in organising this event. This was thus the end of a very intense weekend.

In the end, we would like to thank everyone involved in the organisation of the Regional Round, starting from the International Board of ELSA and the Helga Pedersen Moot Court Competition Team, for their massive support throughout the whole preparation period, as well as the Judges and Speakers who took their precious time to guide the participants with their knowledge and experience in the field of human rights. We send our congratulations to all participating teams. It was a pleasure to listen to your performances!

## **QUALIFICATION SCORES**

Based on their scores in the Written Submissions and the Regional Rounds, each weighting 50% of the Qualification Score, 18 teams were selected for the Final Oral Round. In the 10th Edition, ELSA International has adopted a measure of allowing 19 teams to the Final Oral Round instead of 18, namely allowing one additional team from Ukraine to participate directly in the Final Oral Round without meeting the requirement of participating in one of the Virtual Regional Rounds.

## FINAL ORAL ROUND

For its 10th Anniversary, the Final Oral Round of the HPMCC welcomed 19 teams from 12 countries in Europe to Strasbourg, after facing the global challenge of the Covid-19 pandemic which did not allow us to be together for 2 years in a row. Following the tradition of years, the Final Oral Round took place at the Palais de l'Europe, with its Grand Final taking place at the European Court of Human Rights.



The Final Oral Round took place between 9 and 13 May 2022 and was opened by the speech of the Ambassador Extraordinary and Plenipotentiary Permanent Representative of Spain, Mr Manuel Montobbio, on behalf of the Winning team of the 9th Edition, which was followed by the speech of the Vice President in charge of Academic Activities of the International Board of ELSA - Ms Samira Safarova. During the Opening Ceremony, the order and the team roles for the Preliminary Rounds of the Final Oral Round were decided by the draw conducted by ELSA International. The first day of the Final Oral Round also marked the Academic Programme which was delivered by two current Judges of the European Court of Human Rights. The first speaker was Ms Anja Seibert-Fohr from Germany and she shared her knowledge and experience on the topic of "Upholding the Rule of Law through Interregional Human Rights Dialogue". Mr Latif Huseynov from Azerbaijan delivered the second part of the Academic Programme on the topic of "The European Court of Human Rights and Global challenges". In the end, participants were given the opportunity to address their questions to both speakers during the Q&A session.



# Helga Pedersen Moot Court Competition

For the second and third days of the Final Oral Round, the Preliminary Rounds took place where all of the qualified teams pleaded once on behalf of each party - Applicant and Respondent before the 3-members Bench. As a result of the scores of the Preliminary Rounds, only 8 teams were qualified for the Quarter-Finals. On the third day, 11 May, all participants were invited to the Mid-Ceremony organised by the City of Strasbourg in the City Hall. The Mid-Ceremony was opened by the speech of the Deputy Mayor of Strasbourg, Ms Christelle Wierder, followed by the announcement of the teams that qualified for the Quarter Finals. The fourth day of the Final Oral Round started with the Quarter Finals, and during the lunch break, the Semi-Finalists were announced by ELSA International. After the announcement, the Semi-Finals took place on the second part of the day and during the Semi-Finals, team performances were evaluated by the Bench consisting of 7 esteemed Judges. Finally, the last day started with the Strasbourg tour for the participants, which was provided by the Office De Tourisme De Strasbourg Et Sa Région. The Grand Final took place at the European Court of Human Rights and was evaluated by the 9-member Bench consisting of Ms Zuzana Kovalova, Ms Slavica Cubrić, Ms Anna Maralyan, Ms Geanina Munteanu, Mr Dmytro Tretyakov, Mr Kresimir Kamber, Mr Mark Clough QC and it was presided by Mr Latif Huseynov who has been acting as a Judge of the European Court of Human Rights from 2017. As the official ending of the Final Oral Round, the Closing and Award Ceremony was held which was opened by the Mr Daniel Holtgen, Director for Communications, on behalf of the Secretary-General of the Council of Europe which was followed by the welcoming speeches of the Deputy to the Permanent Representative of Italy, Chair of the Ministers' Deputies, Mr Raffaele Festa and Permanent Representative of Spain, Mr Ambassador Manuel Montobbie. Following the speeches, the Award Ceremony was held where the Winner of the 10th HPMCC was announced by ELSA International.







The Judges score the teams based on 4 individual criteria in all the phases of the Final Oral Round, each weighting equally:

- 1. **Identification of legal issues and relevant legal framework:** This ground sought to assess the team's general understanding of the case and the issues it raises.
- 2. **Knowledge of ECHR and relevant caselaw:** This ground sought to judge the extent of the team's technical ECHR knowledge.
- 3. **Quality of legal analysis and persuasiveness of arguments:** This ground concerned the overall persuasiveness of the team's pleadings and legal analysis.
  - 4. **Style:** This ground addressed issues of presentation and accessibility.

For each criterion, the possible scores ranged between 0 (the lowest) and 40 (the highest). The Applicant/Respondent score of each Judge was calculated by adding up the points for each criterion and dividing them by 4.

In its 10th Edition, 34 Judges contributed to the Final Oral Round with their time, energy and knowledge. # WINNER'S PERSPECTIVE

We were thrilled to participate in the 10th edition of the Helga Pedersen Moot Court Competition on behalf of the University of Oxford - the opportunity to plead in the Council of Europe and the European Court of Human Rights was a truly unforgettable experience.

We began to prepare for our HPMCC journey, with the immeasurable support of our coach Ashleigh Barnes, right after learning we were selected to represent Oxford in late October 2021. As none of us had, at that point, much background knowledge of the fine details of environmental law, we greatly enjoyed the process of familiarising ourselves with a completely new branch of law.

We spent the weeks that followed attempting to balance case-law research with our studies and participating in seemingly endless Teams meetings, some of which ran well into the evening hours. Despite the challenges of, at one point, having to accommodate our meetings to fit 12-hour time differences, divergences between the team members' opinions on what strategy to adopt, and, finally, the task of ensuring all of our footnotes were in the right place, we successfully submitted our written pleadings in December.

After the Christmas break, we began preparing for the Regional Rounds. We held many practice pleading sessions, with the shape of our submissions improving from moot to moot. As we were informed in advance that the pleadings would take place remotely, we yet again relied on technology to adapt our manner of presentation to the demands of online mooting.

We, together with the entire world, were shocked by the Russian invasion of Ukraine in February 2022. As one of the teams assigned to the Kyiv Regional Round, we quickly realised that in light of the tragic events and the primacy of ensuring the safety of Ukrainian organisers of the Regional Round, the competition schedule will have to be amended. We would like to thank everyone from ELSA for their efforts in ensuring the Regional Round could still proceed and that Ukrainian teams still had the means of participating in the competition despite the events which have unfolded since.





During the rescheduled Regional Rounds, we faced teams from Austria and Turkey. Despite the challenges of pleading in a virtual environment heavily reliant on the strength of all participants' internet connections, we were very happy to see that all teams have adapted well and have done their best during the pleadings. Being able to compete against teams from other countries and argue both sides of our case against an opponent with a completely new set of arguments was a very valuable learning exercise for us.

Upon receiving the news we had ranked 1st in the Regional Rounds, we immediately began preparing for the Final Rounds and planning our trip to Strasbourg. However, as soon as we entered the Council of Europe, we knew that all our months of preparation were worth it. Being able to meet and plead against other teams from all over Europe, as well as learn about the Court's case law and Council of Europe's operation from experts in the field, was a true joy - in the Preliminary Rounds, Quarter-finals and Semi-finals we had the pleasure of competing against teams from Ukraine, Slovenia, Austria, and Spain.

After the closely-contested Semi-finals, we were thrilled to learn that we have progressed to the Grand Final - knowing that we managed to improve our university's placement in comparison to the 9th edition gave us even more motivation to do our best in the Grand Final, where we plead against a team from Germany. It is difficult to describe the experience of arguing a case in the Grand Chamber of the European Court of Human Rights; standing in front of the bench, we could truly feel the gravitas of the Court's task.

We would like to thank all organisers of the Helga Pedersen Moot Court Competition, as well as all of the judges who adjudicated the moot proceedings, for taking the time to organise the competition. We are truly honoured to have been declared the winners of this year's edition and cannot wait to come back to Strasbourg to participate in our internships and learn more about the Council of Europe and its mission.

Our Helga Pedersen Moot Court journey started in July 2021, when the four of us were elected to represent the University of Passau for the 10th edition of the competition. We were very excited about the opportunity to participate and to learn more about the European Convention of Human Rights. During our first meeting, we quickly realised that we were a very motivated and passionate team. Reaching the Final Round in Strasbourg was set as our primary goal, for which we were ready to invest time and effort. However, we also agreed that we would not sacrifice our team spirit for success but rather enjoy our common moot journey. Throughout this journey, we were accompanied by our invaluable coaches, Romina Milles and Veronika Kolitz, who provided us with immense support. None of us had had any mooting experience, so we were very excited to see how far we would come as a team.

The hard work started right when the case was published in September. As Climate Change is a new and complex phenomenon, this year's topic was a unique and especially interesting one. After reading and analysing the case for the first time, we knew creativity was needed to face these exceptional legal issues. Hence, what followed were months of hard work consisting of many coffee cups, endless (but very entertaining) legal discussions and detailed formatting of footnotes. Finally, as we submitted our Written Submissions in December, we were confident that we had given ourselves a chance to achieve our big goal of reaching the Final Round.

The new year brought new challenges. Guided by our two coaches, we drafted our oral pleadings and started practising for the virtual Regional Round in Wrocław. This was a whole new experience, but we enjoyed our weekly practice sessions, all the tricky questions from our coaches and the new arguments we were able to defend on both sides. It was very rewarding to see how we all developed our pleading skills during this time.





When the virtual Regional Round in Wrocław arrived at end of March, it was very exciting to finally meet the other teams and to respond to their arguments, as well as to discuss with the judges. Our hard work was rewarded, and our team won the Best Respondent Team of the Regional Round award in Wrocław.

Shortly after, we were thrilled to find out that we reached the 3rd place in the Regional Rounds and thus qualified for the Final Oral Round in Strasbourg. The week in Strasbourg was one of the best yet most challenging experiences we have had during our studies so far. To meet so many motivated teams, to be able to argue and discuss with leading human rights experts, and to experience the atmosphere of pleading in front of the judges truly was an unforgettable experience. The highlight was the qualification for the Grand Final and the possibility to plead in the Grand Chamber of the European Court of Human Rights. Here, we enjoyed a great legal battle with the University of Oxford in front of 9 judges, who challenged us with tricky, but interesting questions.

In the end, we left Strasbourg as the Runner-Up team of the 10th Helga Pedersen Moot Court Competition. On top of that, we won the prize for the Best Written Submission of the Respondent. Our two wonderful orators, Lorenz von Westerholt and Konstantin Lang, also won individual prizes for best orators of the Quarter-, Semi- and Grand Final. But we have won far more than "only" the official awards. The competition gave us the opportunity to pursue our passion for human rights, grow as a team and discover our strengths. Last but not least, it motivates us to follow the journey of human rights in the future. While our Moot Court journey has come to an end, we do believe that another professional journey is only starting. With this, we want to sincerely thank ELSA International for creating this great possibility.
