Date new	Action	Description
15 May 2023	Open call for National Research Groups and International Academic Board	The call for national researchers and editors will be opened at legalresearch.elsa.org.
5 June 2023	Academic Framework published	The Academic Framework is expected to be posted no later than this date.
9 June 2023	Close applications for NRGs	The call for national researchers and editors will be closed.
25 June 2023	Confirmation of all National Research Group positions	National researchers and editors will be notified whether they were confirmed for their applied positions.
August - October	Research period for 1 <sup>st</sup> draft of chapters	The research period commences. It is for the National Coordinators to distribute the work internally and set deadlines to make sure that the work is delivered in time.
August/September 2023	Kick-off webinar	During this webinar, the International Coordination Team will explain the process of the Legal Research Group, the timeline and the Academic as well as Editorial Frameworks.
September 2023	Webinar: How to do Legal Writing?	The deadlines and order of the webinars are subject to change.
September 2023	Webinar: Academic Framework + Guidelines – Q&A	The deadlines and order of the webinars are subject to change.
