Recently, we have established cooperation with Sertifier - an entity for issuing certificates and other documents related to the project management. The entire Network will be able to take advantage of the benefits, so please, read the following:



1. Each National and Local Group will have access to its own account on the Sertifier platform.

2. Accounts will be created on the emails of the Presidents. National Officers, please make sure you send me an up-to-date list of your local Presidents' emails.

3. Issuing is free of charge and each account can produce up to 3,000 documents per year.

The second new partnership is with WeProofread.it - a start-up providing with proofreading for the legal community , especially non-native speakers.



1. ELSA Officers have free access to proofreading of private, non-ELSA related documents in English (CVs, motivational letters etc.)

2. We have secured 800 orders for national Officers (if you are a member of ELSA International Team you can use a separate limit for ELSA International).

3. Go to the website weproofread.it and click on the "Order" tab. There you can put your details and upload a document. In the "Comment" box please add "Free proofreading for ELSA [National Group] / ELSA International Team".
