What we have been doing on the international level

- Giving back to the community by stressing on the issues important for different groups other than law students and young lawyers:
 - Surveys on privacy in the digital age
 - First edition of the Mental Health Project
- Working on the tools to provide to the Network for knowledge management
- Researching ways to be more socially responsible

Yes, we have some events, but...

- Biggest part of the Network is not familiar with the concept of social responsibility;
- We cannot be socially responsible with the initiatives happening only on the international level, but we also know that it takes time for Nationals and Locals to prepare their own projects;
- Our events are not directed at society as a whole - we mainly focus on the legal community;
- We are focusing only on one route - educating/raising awareness.

To sum up the main problems...

- Problems in knowledge management and guidance from the IB;
- Lack of Network involvement/national and local projects;
- Lack of impact (society engagement);
- Lack of focus on the various elements of social responsibility.

Now what we should start working on is...

Social Responsibility Planning, meaning:

- Defining the position who will be responsible for social responsibility and the scope of the obligations;
- Ensuring that the IB can efficiently guide the National Groups on how to do these projects;
- Establishing both short and long term goals on all levels;
- Developing international initiatives National and Locals Groups may participate in, such as what happens with other Key Area projects (HPMCC, JHJMCC, WELS/SELS);
- Addressing the problems in society **on time**.

- Etc.

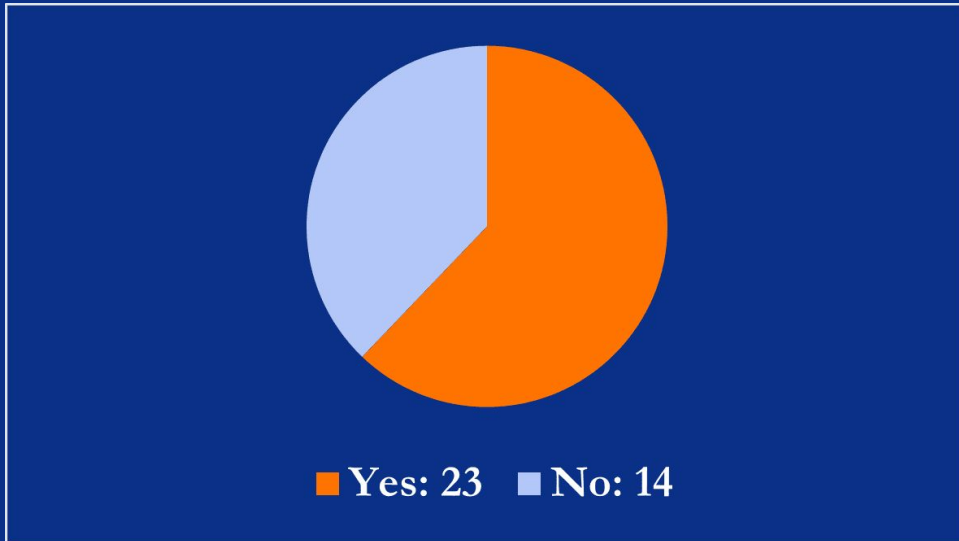

Are you planning to organise social responsibility initiatives this term?



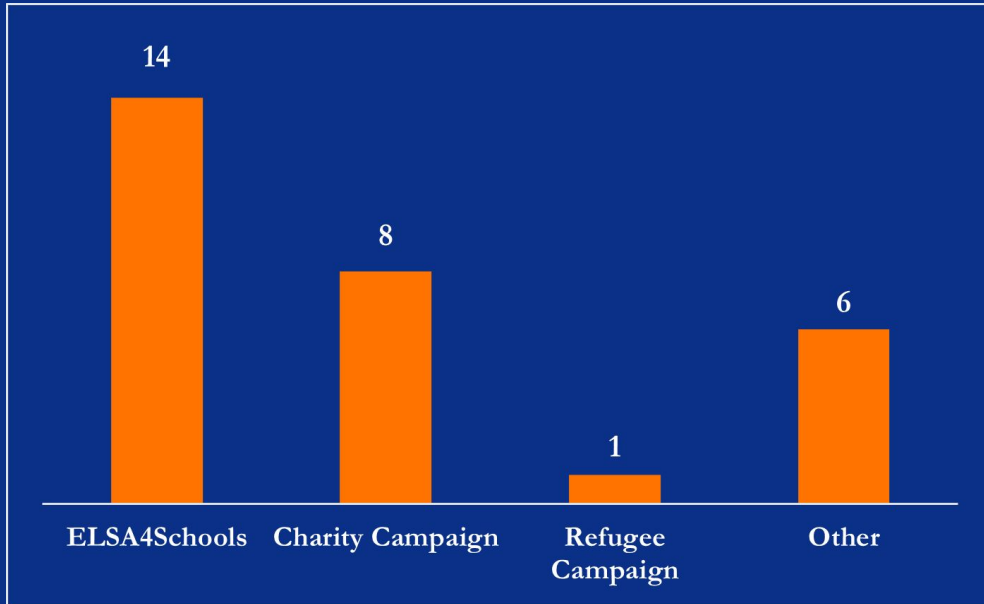
More than half the Groups that responded want to organise these projects!

International	Implementation of VP S.R. on the IB level ROLE (14 countries) Annual Human Rights Campaign Solidify other International Advocacy Campaigns Assist in the implementation of National S.R. Projects
National/Local	ROLE (14 countries) Annual Human Rights Campaign and other advocacy campaigns Start preparing small-scale projects with the support of the IB

First Year

International	ROLE (8 countries) Annual Human Rights Campaign - solidify structure Other Advocacy Campaigns (ex. Diversity & Inclusion) Creation of tools for the Network Development of new project structures and coaching NGs/LGs
National/Local	ROLE - start/continuing participating Annual Human Rights Campaign

Third Year

International	ROLE (20+ countries) Sustainable international advocacy campaigns Regulated/harmonised S.R. projects Regular support to the Network regarding S.R. (ex. coaching)
