- Researching of new possible grants for ELSA International.

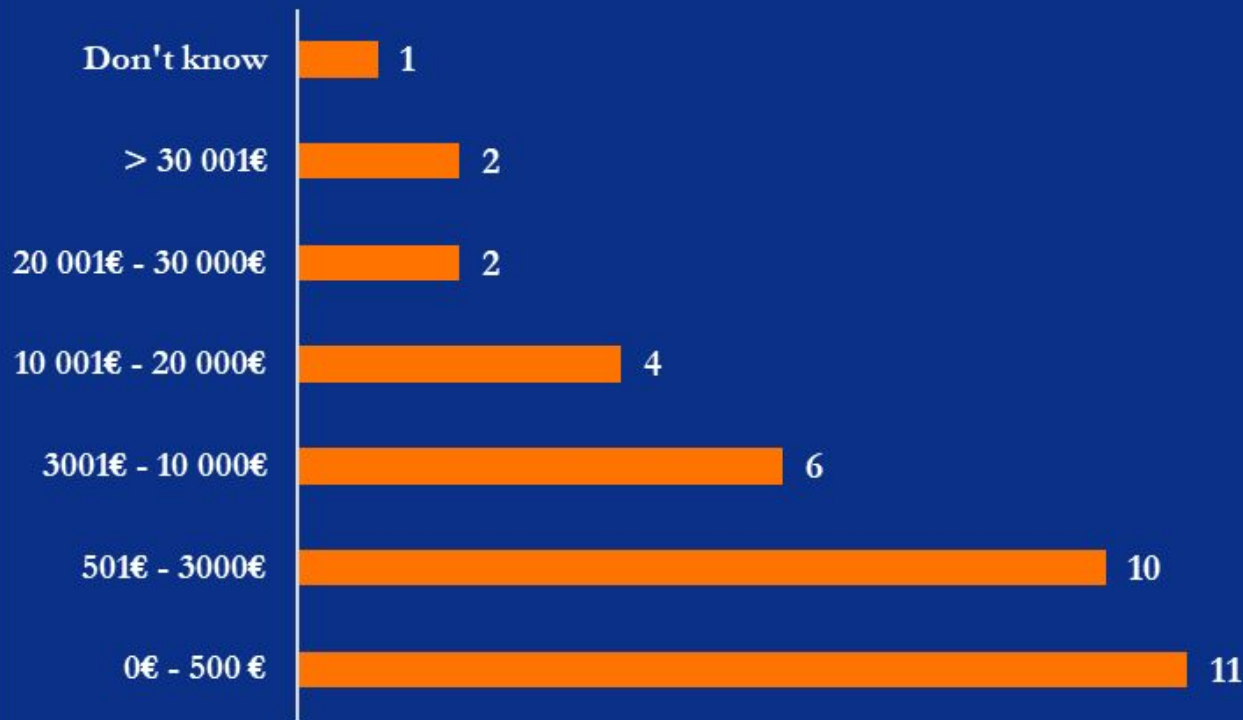

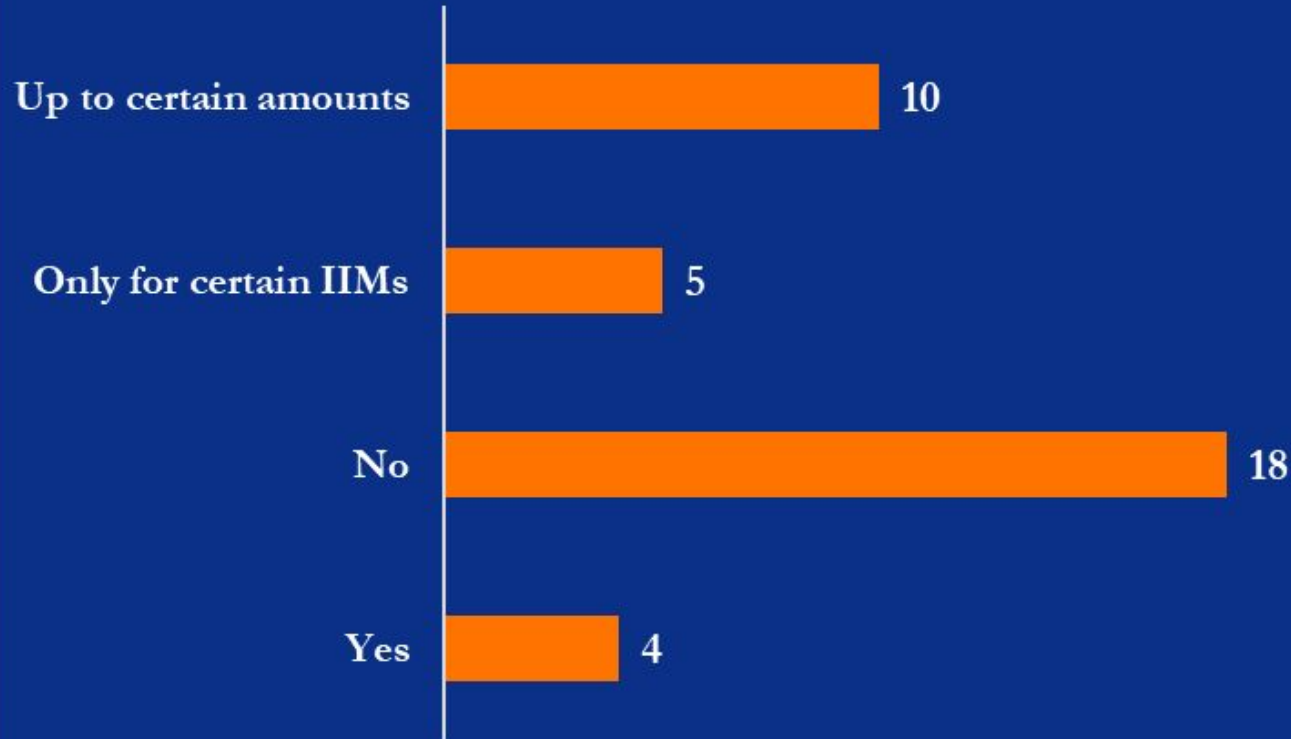

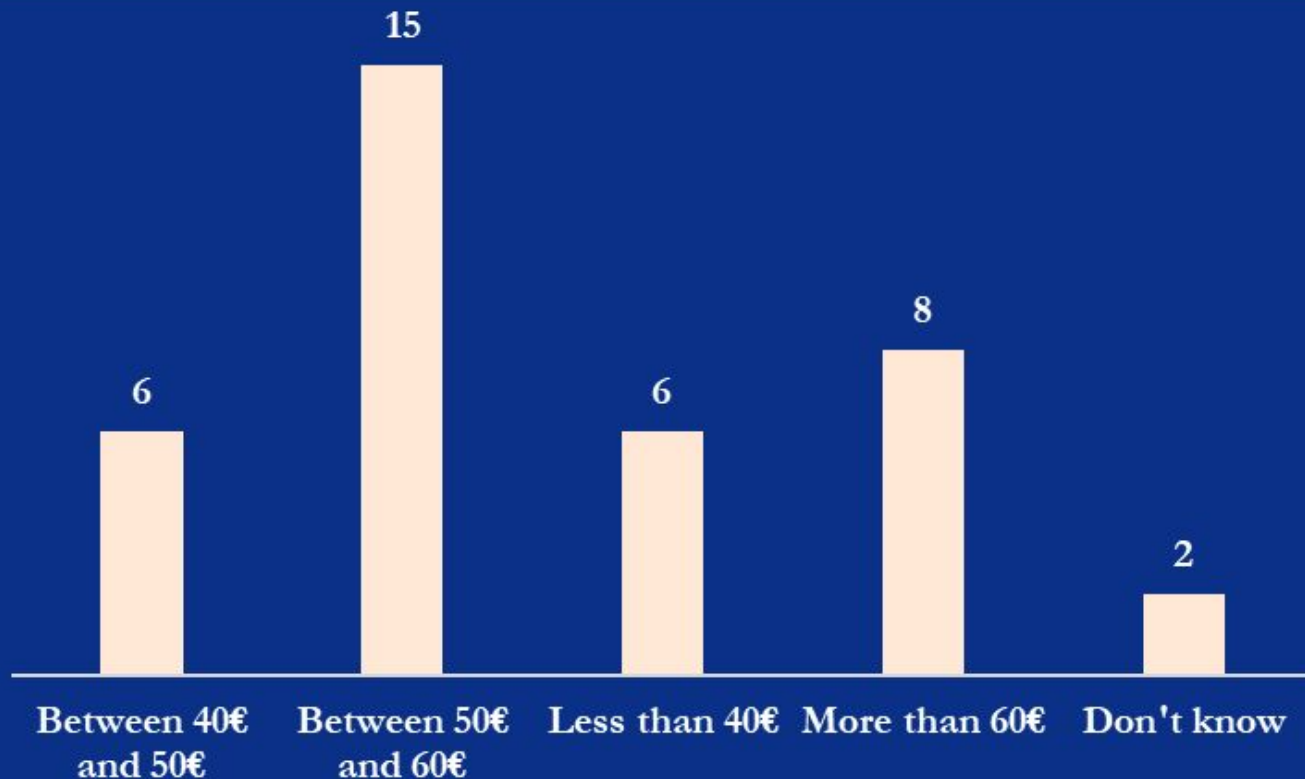
6. How much is the “Annual General Income” of your National Group gathered in the immediate previous financial year expressed in EURO?
