

## Grants

It is the beginning of the new term (1st of September 2021), and you are the Treasurer of ELSA Happyland (one of the first ELSA groups). This year your ELSA group is planning to organise SELS, which will take place from 17th of July to 24th of July 2022, and you will be the Head of Finances.

For your budget, you already know that:

- There will be 30 participants (22 from non-favoured countries and 8 from favoured countries), and you want from them the maximum participation fee according to the Decision book of ELSA International
- 15 participants want to buy a transport which you are offering for 25 euro
- 25 participants want to go to the gala ball which you are offering for the 50 euro
- 18 participants want to buy a T-shirt which you are offering for 15 euro
  
- The hotel room costs 25 euro per night for one participant (including breakfast)
- The lunch will cost 6 euro
- The dinner will cost 7 euro
- You also have to accommodate 7 speakers each of them just for one night, and the hotel room will cost 35 euro per speaker (including breakfast)
- Each of the speakers will get one lunch and one dinner for the same price as a participant
- You will buy the flight ticket for all speakers - one flight ticket is for 100 euro
  
- The coffee breaks will cost 150 euro for the whole week
- The rent for the room for the academic program will cost 400 euro per whole week
- The benzine/fuel will cost 400 euro for the SELS
- You are planning to have a social program every day, and it will cost 1000 euro in total
- The Gala Ball will cost 759 euro
- For the whole marketing, you will pay 200 euro
- Making the T-shirt which you are going to sell, you have to pay first, and it will be 10 euro per T-shirt
- The administration fee is 250 euro
- Operating costs are 150 euro in total

You know that with this income and expenses you can organise the SELS. Still, when the Head of the academic program was trying to find the best speakers, he found (besides those seven) two that are the best in the whole world, and every person on the planet is dying to attend their workshop. Even that the speakers said they would be happy to have a seminar on your SELS, there is one problem. Besides the free meal and flight tickets for both speakers, they also want a monetary reward of 1000 euro.

Because you know that there is no way your National group could afford to spend this money, you decided to find a grant for this SELS.

Because you don't know if you find the proper grant and even if you do, you can't be sure if they will give you all the money you are asking for.

So the plan is to find a grant, apply for the grant, and if they accept your application and give you the money, you will replace two-speakers who don't want a monetary reward with the two who want and which will make your SELS the best of all.

# Grant n. 1 - Free money for everyone

## 1. Description of the grant:
