# ABOUT HELGA PEDERSEN MOOT COURT COMPETITION

The Helga Pedersen Moot Court Competition ("HPMCC") (formerly known as the "European Human Rights Moot Court Competition" - "EHRMCC") was founded in 2012 in cooperation with the Council of Europe. Discussions had been ongoing for some time to create a moot court in the field of human rights. Finally, after negotiations and a lot of preparations consisting of gathering Case Authors, Judges, and other helpers, were able to launch the first edition of the European Human Rights Moot Court Competition in 2012, with the Final Oral Round ("FOR") taking place in spring of 2013.

Since 2012, a lot of changes have been made. Rules have changed, stages have been introduced and adapted, and the structure has become more sustainable to keep up with the development of the HPMCC. For the Academic Year 2019/2020, ELSA introduced an additional stage in the Competition: Regional Rounds. For previous editions, some ELSA groups organised "Pre-Rounds" in which teams could participate to practise their oral pleading skills and prepare in the event that they would qualify for the Final Oral Round. However, the Written Submissions scores were still the only thing taken into account to determine the qualifying teams for the Final Oral Round. Following the overwhelming success of the Pre-Rounds, ELSA International decided to introduce official Regional Rounds, mandatory for all teams. With this introduction, the teams were scored on their Oral Pleadings skills, in addition to their Written Submissions. The scores from both the Written Submissions and the Regional Rounds were then combined to determine the best teams who would qualify for the Final Oral Round.



In the term 2020/2021, as the Competition was coming close to its 10<sup>th</sup> anniversary, there were discussions if the Competition should be renamed, perhaps in honour of an important person within the Human Rights field. One of the names being circulated was that of Helga Pedersen. Helga Pedersen was a Danish judge who had a remarkable and inspirational legal career. She was a student at Slagelse Gymnasium in 1930 and earned her M.Sc. from the University of Copenhagen in 1936. She was Secretary to the Ministers of Justice in Denmark during World War II, and after the war, Pedersen attended Columbia University in New York, which was funded by an International Study Grant from the American Association of University Women. After returning to Denmark, she became a Copenhagen District Court judge from 1947 to 1950. She was elected to the Danish Parliament in 1950 and was appointed Minister of Justice from 1950 to 1953. She continued to be a Member of Parliament until 1964, when she distinguished herself as an advocate of prison and penal reform and the advancement of women's legal status. During this time, she was also a judge for both the District Court and the Appeals Court. She was later appointed as a judge to the Supreme Court. She was also named chairman of the Danish Women's National Council. In 1950, she participated in the United Nations Commission on the Status of Women and served as a delegate at the UNESCO General Assembly. In 1971, she was appointed as the first female judge at the European Court of Human Rights. Other highly prestigious achievements of Pedersen include being a recipient of a gold medal from the Association of World Peace Through Law, becoming the first female commander of the Order of the Dannebrog. To this day, she serves as a role model to law students across Europe and beyond. To honour Helga Pedersen, we named this Competition after her.



# HELGA PEDERSEN MOOT COURT COMPETITION

12<sup>TH</sup> EDITION - 2023/2024

The registration period lasted until the 30<sup>th</sup> of October, 2023, and by then, **68 teams** from **28 countries** across Europe had registered.



The registered Teams had until the 15<sup>th</sup> of November to submit up to **3 Clarification Questions** to the Case. The questions were sent to the Case Authors, whose answers were then made publicly available on the website of the Competition.



The next step was for the teams to submit their Written Submissions on behalf of the Applicant and Respondent in the matter. Out of the 68 registered teams, 61 Teams had fulfilled all requirements and successfully submitted their Written Submissions by the deadline on the 11<sup>th</sup> of December 2024. These Written Submissions were then scored by a group of human rights experts. Each Written Submission is scored two times by four different experts (2 scores for Applicant and 2 scores for Respondent) and the team score is the average score out of these four deducting the penalty points. The Penalties are based on the list from the Rules of the Competition and checked for formalistic errors, plagiarism, and violations of other provisions of the Rules.

Teams that fulfil the requirements and submit their Written Submissions get the chance to showcase their Oral Pleading skills in one of three Regional Rounds. This year, we had the privilege of organising the Regional Rounds in three cities across Europe. The first Regional Round was organised in Ankara, Türkiye, by ELSA Ankara between the 2<sup>nd</sup> - 4<sup>th</sup> of February 2024; the second one in St. Gallen, Switzerland, by ELSA Switzerland between the 15<sup>th</sup> - 17<sup>th</sup> of February 2024; and the third and final one was organised in Dublin, Ireland, by ELSA Ireland between the 23<sup>th</sup> - 25<sup>th</sup> of February 2024. We wish to express our congratulations and gratitude to ELSA Ankara, ELSA Switzerland, and ELSA Ireland for their hard work and successful organisation of these Regional Rounds. They created a great environment in which teams had the chance to demonstrate their Oral Pleading skills, learn from experts within the field, as well as learn from each other and get to know fellow students that share their interest in human rights law.

# Regional Rounds 12<sup>th</sup> edition



We of course also express our thanks to the Judges who took time out of their weekends to provide feedback to the teams and helped ensure the event's academic quality. Based on the Written Submission scores and the Regional Round Oral Pleading scores, the best 18 teams were selected to compete in the Final Oral Round in the beautiful city of Strasbourg.

This year, the Final Oral Round took place between the 27<sup>th</sup> - 31<sup>st</sup> of May 2024 and, as always, we welcomed the Teams to the Council of Europe for the Preliminary Rounds, Quarter-Final Rounds and Semi-Final Rounds and to the European Court of Human Rights for the Grand Final Round.

During these 5 days, we hosted an Opening Ceremony and an Academic Programme on the first day; the Preliminary Rounds and Mid-Ceremony on the second and third day; Quarter-Finals and Semi-Finals on the fourth day; and the Grand Final on the fifth. The Grand Final was then followed by the Awards Ceremony and the Closing Reception, which also took place at the European Court of Human Rights in the Grand Hearing room and the cafeteria. You may read more about the different stages of the Competition in the following sections of this report.



European Court of Human Rights

#### **SCORING SYSTEM**

The Written Submissions and the Oral Submissions are scored based on the following criteria, each weighing 25% of the final score. These criteria were:

- 1. **Identification of legal issues and relevant legal framework:** This ground sought to assess the team's general understanding of the case and the issues it raises.
- 2. **Knowledge of ECHR and relevant case law:** This ground sought to judge the extent of the team's technical ECHR knowledge.
- 3. **Quality of legal analysis and persuasiveness of arguments:** This ground concerned the overall persuasiveness of the team's pleadings and legal analysis.
- 4. Style: This ground addressed issues of presentation and accessibility.

The **Written Submission scores** and the **Oral Pleading scores** each comprise 50% of the overall Qualification Score.

For each criterion, the possible scores ranged between 0 (the lowest) and 40 (the highest). The Applicant/Respondent score of each Judge was calculated by adding up the points for each criterion and dividing them by 4.

The scores have been calculated in accordance with the scoring system outlined in the Appendix A. of the Rules of the Competition, as below:

## Appendix A - Calculation of Scores

The Written Submission Score shall be calculated in accordance with the following formula:

$$\frac{\left(\frac{WSA1+WSA2-PA}{2}\right)+\left(\frac{WSR1+WSR2-PR}{2}\right)}{2}$$

The Regional Round Score shall be calculated in accordance with the following formula:

$$\frac{\left(\frac{A1+A2+A3}{3}\right)+\left(\frac{R1+R2+R3}{3}\right)}{2}$$

The Qualification Score shall be calculated in accordance with the following formula:

$$\frac{WSS + RRS}{2}$$

The Preliminary Round Score shall be calculated in accordance with the following formula:

$$\frac{\left(\frac{A1+A2+A3}{3}\right)+\left(\frac{R1+R2+R3}{3}\right)}{2}$$

#### WRITTEN ROUND

The first challenge teams face in the Helga Pedersen Moot Court Competition is submitting their **Written Submissions**. Each team must provide two Written Submissions: one on behalf of the **Applicant** and one on behalf of the **Respondent**.

This stage is mandatory to qualify for the oral Regional Rounds. After the Regional Rounds conclude, the Written Submissions' scores are factored into the Qualification Score, which determines the top 18 teams that will advance to the Final Oral Round in Strasbourg.

For the 12<sup>th</sup> edition, 61 out of 68 teams submitted their Written Submissions by the deadline set by ELSA International on the 15<sup>th</sup> of December 2023. In total, 36 experts in the human rights field generously scored each Written Submission. ELSA International ensures that all submissions are scored twice by organising two stages of scoring. This year, the first round of scoring took place between the 5<sup>th</sup> - 19<sup>th</sup> of January 2024, and the second round between the 2<sup>nd</sup> - 17<sup>th</sup> of February 2024.

The Written Submissions scores were scored in accordance with the formula that can be found in Appendix A of the Rules of the 12<sup>th</sup> HPMCC, as well as in the Scoring System part of this report. Additionally, the teams had to format their Written Submissions according to the criteria set out in the Rules of the 12<sup>th</sup> HPMCC. The ELSA International team conducted "penalty scoring", where points were deducted from the overall score for rule infractions based on the formal requirements in the Rules. This is marked as PA (Penalty Applicant) and PR (Penalty Respondent).

#### **REGIONAL ROUNDS**

Teams that submitted their Written Submissions on time advanced to the second stage of the competition: the Regional Rounds. Here, they presented their legal arguments orally before a panel of three human rights experts.

The scores from the Regional Rounds contribute 50% of the Qualification Score for the Final Oral Round. A total of 54 teams participated in one of three Regional Rounds, assigned randomly. These rounds took place in Ankara, Türkiye; St. Gallen, Switzerland; and Dublin, Ireland, in February 2024. Each Regional Round spanned three days, beginning with an Opening Ceremony, followed by two days of Oral Pleadings. Additionally, all rounds featured a rich cultural and social program designed to facilitate networking among the teams. This aspect is particularly significant as it aligns with ELSA's goal of promoting mutual understanding and friendship among law students across Europe.

The Regional Rounds concluded with an Awards Ceremony on the evening of the third and final day, where prizes were awarded for the Best Team and the Best Orator of each Regional Round. Each Regional Round also recognized the team that best embodied the ELSA spirit, honouring those who displayed good sportsmanship, adherence to ELSA's philosophy, and a genuine interest in building connections across Europe. Additional awards were given at the discretion of the Regional Round Organisers in collaboration with ELSA International.

The first Regional Round of the 12<sup>th</sup> HPMCC was organised by ELSA Ankara from the 2nd-4th of February 2024. ### **QUALIFICATION SCORES**

Based on their scores in the Written Submissions and the Regional Rounds, each weighing 50% of the Qualification Score, in accordance with provision 5.4 of the Rules of the Helga Pedersen Moot Court Competition, 18 teams were selected for the Final Oral Round. The Rules provide the following guidance on the selection of the qualifying Teams:

#### "5.4. Qualification to the Final Oral Round

18 Teams that qualify to the Final Oral Round shall be determined as follows:

- a) 12 of these 18 Teams shall be selected based on their Qualification Score proportionally to the number of Teams at the Regional Rounds. The number of Teams qualifying from each Regional Round will correspond to the number of Teams at that Regional Round as a percentage of the overall number of Teams participating in Regional Rounds. Where that percentage results in a number of Teams which is not a whole number, ELSA International shall exercise its discretion in the final determination of the number of teams qualifying from each Regional Round.
- b) ELSA International shall create a unified list of the Teams from all Regional Rounds based on their Qualification Scores excluding the qualified 12 Teams under Rule 1.3.4 (a). The remaining 6 Teams qualifying to the Final Oral Round shall be the Teams with the highest Qualification Scores based on this list.
- c) The Qualification Score shall be calculated in accordance with Rule 8.2.5, according to the formula in Appendix A of the Rules of the 12<sup>th</sup> HPMCC."

#### Based on the above:

- a) 12 out of the 18 Teams:
  - i) 3 out of the **12** Teams qualified from Regional Round Ankara (corresponding to the overall number of Teams in that Regional Round being 14)
  - ii) 4 out of the 12 Teams qualified from Regional Round St. Gallen (corresponding to the overall number of Teams in that Regional Round being 17)
  - 5 out of the **12** Teams qualified from Regional Round Dublin (corresponding to the overall number of Teams in that Regional Round being 21)
- b) The remaining 6 Teams qualifying to the Final Oral Round came from:
  - i) Ankara (4 Teams)
  - ii) Dublin (2 Teams)





During our regional round in Dublin, we were impressed by the quality of the teams we went up against and would like to highlight how much our initial moots against them along with the judges' feedback shaped our future arguments. The act of attentively listening to the opposing team to see if we could implement their arguments into our future pleadings proved extremely valuable and aided us particularly later on. Luckily for us, we were able to qualify for the finals.

In Strasbourg, we had the privilege to moot in the preliminary rounds against two teams which would also qualify to the quarter finals. Both matches were tight, and we left the rooms feeling excited about the prospect of potentially qualifying further and what we would tweak in our arguments. In this light, over the course of the week as we progressed, we spent each night refining our arguments, tightening the case law used and most importantly, simplifying the arguments. Our team's strength was the simplicity of the arguments which allowed for them to be linear and therefore easy for the judges to understand. An argument which follows a framework can be more easily manipulated when answering interventions and is less likely to receive intense scrutiny as a result.

Having progressed through the rounds to the Grand Final, our only piece of advice to any teams in that situation in the future (and at any point during the competition) is to enjoy the moment. You have prepared and are in a position of privilege. It is best to try and enjoy it as it only happens once!

In conclusion, the HPMCC is an exercise in written and oral advocacy, ECHR knowledge, and a determination to win but it is first and foremost an excellent lesson in teamwork. No individual can excel in all facets, nor can they solely produce the work necessary to advance to the final. Our team's strength was our teamwork and ability to do what was needed, when it was needed, without individualism.

It is ultimately what led us to all plead during the Grand Final, and what made the process relatively stress free. We could count on eachother.

This final and most important element just mentioned, along with all of the other skills we learned and improved throughout this exercise was primarily due to our excellent coach Felix Torres. Our greatest thanks go to him and his commitment to making us a fun team!

# **RUNNER-UP'S PERSPECTIVE**

It was an honor for Team 10 to be able to take part in the 12<sup>th</sup> edition of the Helga Pedersen Moot Court competition and to participate in both the Ankara Regional Round and the Final Oral Round in Strasbourg. We, first of all, would like to thank ELSA International and ELSA Ankara for the amazing work they put into the final oral round and the regional round, respectively. Furthermore, we are extremely thankful to our coaches, Šejla Imamović and Valentina Golunova, for their constant honest and precise feedback as well as for their guidance, encouragement, and support throughout the competition.

Our preparation started back in October with the formation of our team, representing Maastricht University. We then embarked on the journey of writing two written submissions: one for Mister Borg and one for the State of Zemland. This year's case was focused on the freedom of expression and the right to be free from discrimination, two rights that interested the four members of our team. The four of us worked together with the support of our coaches throughout November and December to research as much as possible on the topic at hand and come up with arguments for both sides. All throughout the competition, but especially during the written submissions phase, teamwork was fundamental as we all still had exams a week after the deadline for the submissions.

During the month of January, the preparation for the Ankara Regional Round started. It was the first real exercise of oral pleading and despite the great challenge that this represented, preparing for the oral round made us learn a variety of different skills that are fundamental for a career in law. Testing and showing these skills in Ankara was both exciting and rewarding. Not only was this preparation personally rewarding, but it also led to us being awarded as the winning team.

After a small break, we started with our preparation for the final round in April. The preparation was characterized by intense work on style, as well as content. With exams and imminent thesis deadlines, this time was certainly challenging. Nevertheless, we worked hard to improve our pleadings each passing week. We are enormously grateful to the guest judges who gave valuable feedback during this stage of the competition. It was often the suggestions of our guest judges, who gave up their time so generously, that we were able to overcome major issues in our argumentation. After two months of additional preparation, we felt confident and excited for the Strasbourg rounds to finally start.

Our experience in Strasbourg is undoubtedly one we will never be able to forget. Over the course of a week, we were challenged by our opponents in various pleadings, from the preliminary rounds to the grand finale, which took place at the European Court of Human Rights. Although there were some challenging moments, and at times emotions ran high, after a fierce competition our team proudly received the runner-up prize.

The Strasbourg experience was educational on multiple fronts. Firstly, the new challenges we faced pushed us to give our best, significantly enhancing our oral skills. Additionally, we had the privilege of interacting with human rights experts and judges from the European Court of Human Rights, providing us with practical insights into our human rights knowledge.

Our journey in Strasbourg was marked by exciting challenges and valuable learning experiences, making it an immensely rewarding experience that enriched us both personally and professionally. We extend our deepest gratitude to everyone who made the Final Oral Round possible, from ELSA International to all who challenged us during the pleadings.

Having the opportunity to plead in the Grand Chamber of the European Court of Human Rights is a privilege that is not lost on us. To stand in front of some of the most esteemed pioneers of human rights law and plead our case is, without a doubt, an experience that will stay with us throughout our future careers. # **BEST ORATOR'S PERSPECTIVE**

Winning the prize for best orator was more of a confirmation of my team's teamworking abilities and overall argument rather than my abilities to speak. The reason? In order to win best orator, you have to score the highest in the combined four metrics which amount to 40 points. Only 10 relate to style, the remaining 30 relate to the identification of legal issues, the knowledge of the ECHR and its case law and the quality of legal analysis. These three elements are all directly impacted by the teamwork which the team exhibits.

In my case, I understood quickly that it was impossible to remember everything which the judges could intervene upon within my submission and therefore chose to rely on my colleagues. The best medium to transmit the knowledge was either cheat sheets or quickly written post-it notes. There is no shame in taking a couple extra seconds to read and fully understand the points made by your colleagues either during the moot! In that regard I thank my teammates Ranvir Raj and Rachel Lok for their extensive knowledge and continuous help.

My second tip is to make sure to rehearse as much as possible and get used to being interrupted during your rehearsals. This will strengthen your argument as you'll be able to understand the key points you want to transmit and will render you accustomed to being challenged and knowing when to concede and when to stick to your argument. Ultimately, during the final, I had 30 minutes to speak but was interrupted enough to find myself needing extra time and only with half of my actual full submission having been presented. Had our arguments not been simple, it would have been extremely difficult to mould my arguments to the amount of time I had.

Ultimately, it is an exercise which is facilitated by a strong, simple and malleable argument and such a presentation is much more easily created by a team and is presented better when the orator can rely on their teammates. In those difficult instances where multiple judges are asking questions and you know they know what they are talking about as numerous (in our case 4) are actual ECtHR judges, knowing that you are able to rely on your teammates alleviates stress.

Don't forget to speak slowly, loudly, articulate and make sure to signpost. Listing your arguments and points can also help, as does providing paragraph numbers for case law so as to demonstrate the depth of knowledge.
