INTERNATIONAL TRAINING MEETING

The beginning of September was marked by a new International Internal Meeting: the International Training Meeting. Here, I prepared the workshops and presentations, as well as answered any questions the National Groups would have regarding its structure and content. I would take this opportunity to thank all of those that attended the Meeting, hoping that it was fruitful and enjoyable.

THE NETWORK

Following the ITM, I started expanding the work with the Network throughout the month. Firstly, I launched the BEE Academies, for anyone interested in learning more about External Relations, Advocacy and Strategic Planning. I already started having the first meetings with the participants and developing plans for the term. If you haven't joined but would like to, there is always a spot for you! Secondly, we had our second BEE Open Call on the 22nd of September. This year I decided to change the purpose of these monthly meetings and so, we started doing exercises related to External Relations, where the BEE Officers could brainstorm on how to solve different issues that they may face during the term. EXTERNAL RELATIONS

If the month of August was all about preparation and strategising, the month of September was about taking the first steps. Thus, with the help of Federica, Marta, Eszter and Marianna, we started researching new potential partners - both general and for projects - and we initiated contacts with some of them. At this point, we are waiting for responses, as well as negotiating the way forward with those that showed interest in cooperating with us. On the other hand, I also continued meeting with our current partners, to evaluate the cooperation. With that in mind, I renewed the partnership with IE Law School and started preparing the terms of future renewals with other partners.

ADVOCACY

As we intend to restructure our advocacy initiatives, this month was still about planning. Starting with the Annual Human Rights Campaign, me, Ainoa, Valentin, Samira and Yagmur created a new structure for the Campaign, with a new purpose, timeline and tasks for the International Board and the National Groups. With this new plan, we intend to clarify the way forward for this Campaign, making sure that we are all on the same page regarding what is to be done. Furthermore, and even if the month was about finalising plans, there was also some implementation. With Daniel, we started contacting potential mentors for the Advocacy Mentoring Programme and with Federica we started contacting potential stakeholders for the Annual Human Rights Campaign. Lastly, I've started to explore with some of our partners the possibility of doing another advocacy campaign related to legal tech, with the aim of bringing this topic closer to law schools and law students. Nevertheless, this idea is still in an embryonic state, having to be developed in October.

LEGAL WRITING

1st of September marked the last day for submissions for the second issue of the ELSA Law Review on the topics of Human Rights and Digital Law. I am happy to share that from this Call, we have received 29 submissions and our super stars of the Publications Team; Bernadetta, Ekaterina, Parthabi and Roberta have been closely working on the reviewing process. On the other hand, together with Yulia and Andjela, we set goals for the purpose of encouraging and supporting the Network to conduct Legal Research Groups and these goals are already in the implementation stage. ENFORCING OUR COMMITMENT - HUMAN RIGHTS

After sharing the Outline of the Annual Human Rights Campaign 2021/2022 with the Network, Arga, Valentin, Ainoa and I have been working on the new structure of the Annual Human Rights Campaign to provide the Network with clear set of responsibilities and timeline for realising our aim raising awareness on Human Rights.

BEING THE CHANGE - BOARD REFORM IMPLEMENTATION

During September, I was focused on two directions to enforce the implementation of Board Reform: 1) developing social responsibility through the initiatives of Mental Health Project and ROLE Campaign; and 2) closely working with Mathieu on the Competitions, especially ENC European Final Round in order to ensure the future effectiveness of the transition period. Related to the social responsibility part, I can proudly say that preparations are in full swing and we are working on presenting new initiatives to be implemented in the Network. For the European Final Round,



ELSA Brno will have the honour of being the host of the first edition!

While talking about the implementation, it is important for us to provide you with feedback not only about the progress, but also the difficulties faced. From the overview we got from the ITM, Open and Coaching Calls, the interest of the Network regarding the ENC European Final Round is lower than expected which makes the preparations harder for us and for the Organising Group. Especially, the fact that most of the Groups are planning to organise ENC in their own official languages and late in the second semester. This puts the number of participants for the European Final Round at risk. We truly believe that the SotN will provide us with more exact answers which will be helpful to plan the European Final Round as well. We are very much looking forward to welcoming the teams from our National Groups in Brno in the second semester!
