

# Number of Local Groups




























On what date did your term in office start?




Did your Board receive Transition and, if yes, how long?







On a scale from 1 to 10 how would you evaluate the quality of the area transition for your national board?










How would you evaluate the International Boards communication with your National Group?












## Main Sources of Income



Which is the main source of income for your National Group?















4-6)	An increase of the amount of Local Groups by 16 and also adding ELSA Luxembourg to the list of National Groups without Local Groups
7-10)	The ELSA coverage of law faculties in the countries where ELSA is represented. Comparison 13th & 14th SotN: 314 – 323 – 346 Interesting is that the number of law faculties in the countries in which ELSA is present has during the past year gone from 1447 to 2830 to 929
11-13)	It seems we have not continued the steady rise in members going on for the past years as the total is 2248 members fewer than last years top of 38076.
14-15)	Even though there are fewer members we have a slight increase in the number of active members since the 14th SotN
18)	So when do we start the work for our year? Not at the same time is the answer. Only about half of the boards of the members and observers start their term in office on the 1st of August
19)	37 Members and Observers received transition before entering in to office. Of the five countries who has not received transition one is in progress of getting. The amount of spent on transition range from a few hours up to several months with more than half the Network in the span 1-4 days
20-23)	The quality evaluation of area transition is in the upper half of the scale with most areas landing around 7 while STEP and S&C moves up towards 8. Now is the question what to do to move up even higher.
25)	We are pleased to see that almost 98% percent of the evaluations of IB-NB communication is in the upper half of the range
28)	A strong majority of boards has a finished OYOP and the most common form is to write individual ones for every area.

- 29) Half of the National boards have meetings every week and more than 75% have meetings at least twice a month.
- 30) Half of the National boards have meetings every week and more than 75% have meetings at least twice a month.
- 31) There are a majority of groups who does not have a focus on expanding in numbers. While this is, a great number are focused on quality expansion
- 33) More than half of National Groups has or is planning to establish a reporting system. However the current status is that less than a third has an effective way of getting statistics from their Network.
- 34) Two thirds of National Groups has or is planning to create a human resources strategy. The NGs who has one only 7 groups are using it fully
- 40) The most useful mode of support would according to the NGs be for Travels and Accomodation for Statutory meetings. Interesting note though is that only one group applied for such support before ICM Opatija
- 44) 24 groups are or have been producing merchandise. There is room to use this fact for all NGs
- 48) Compared to the planning of last fall this years number is a significant increase.
- 54) Only ca. half of NGs are trying to establish teams for the EMC2
- 59) We see a welcome increase in ambition for STEP. Compared to final number (11) of IFP Traineeships of 2012/2013 the planned number of 122 for this year is an amazing raise.
