We ask you to read this report carefully to be fully prepared and to be at your best ability to work for the benefit of the Network.






Number of Local Groups In total 249 Local Groups + 6 National Groups without Local Groups




Number of Local Groups in your National Group?













How many Law faculties does your National Group and/or Local Groups cover in total?












Evaluation of communication from National Group to Local Groups






On a scale from 1-10 how would you evaluate the quality of communication with your Local Groups?






How would you evaluate the quality of communication between your National Board and the International Board?













On scale from 1 to 10 how would you evaluate the quality of communication with the officers of the International Board?

Local Officers' familiarity with international events and projects








On scale from 1 to 5 how familiar are your Local Officers' with international projects and events?








How much the daily participation fee should be raised to make it feasible for your country to organize S&C events or international internal meetings (ICM, IPM, SAM, KAM)?











NUMBER OF IFP AND HUMAN RIGHTS EVENTS









How many Study Visits and Institutional Study Visits (national and international) did your National and Local Groups organize until the end of term?









On scale from 1 to 10 how would you evaluate the quality of communication with the Assistant for STEP Regional Development of ELSA International?






