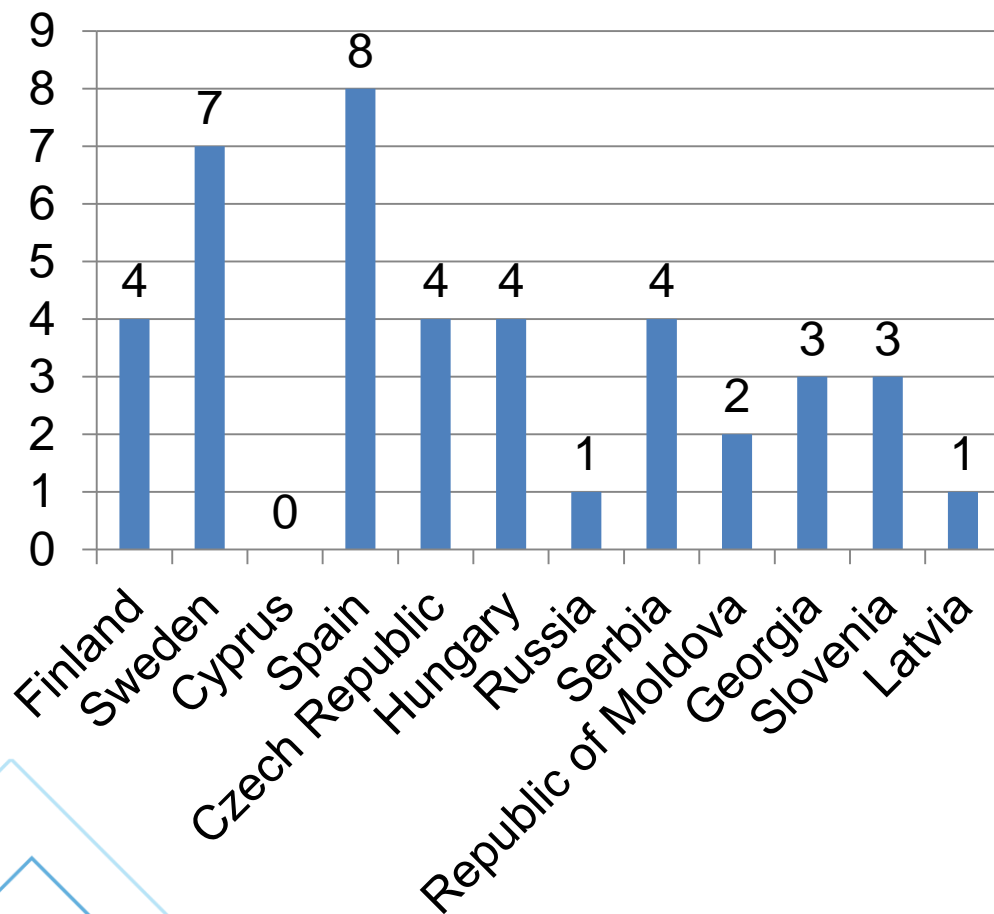
Local Groups per member





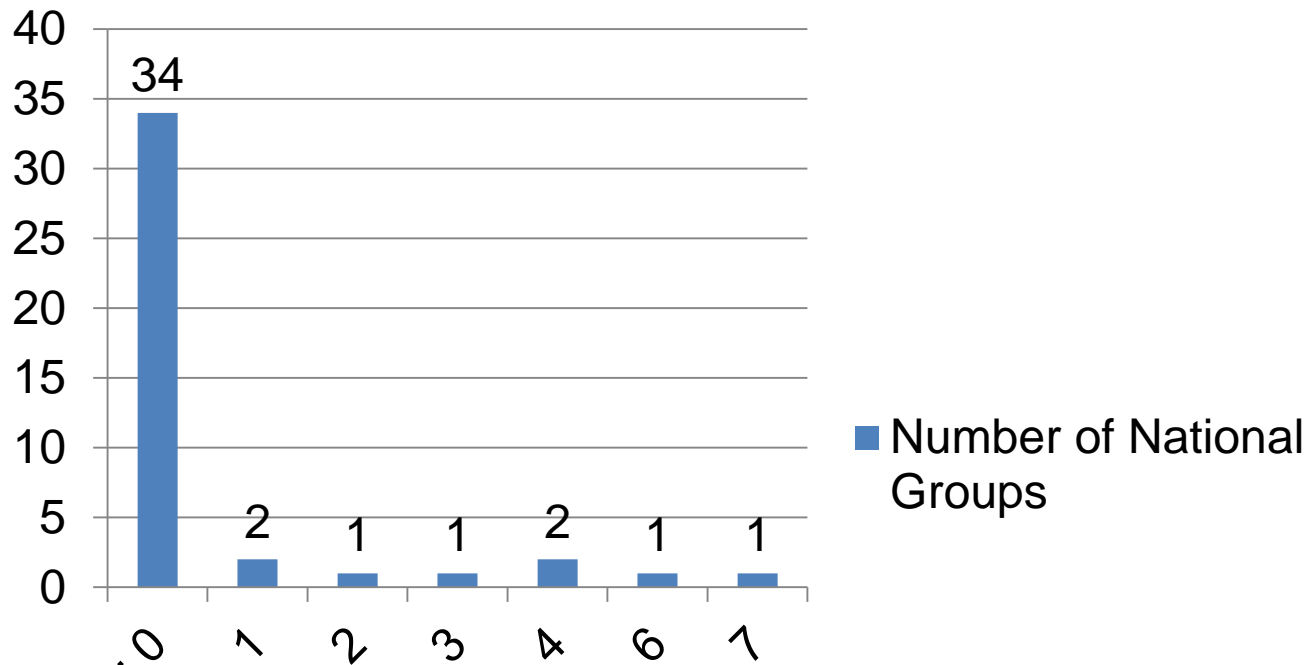

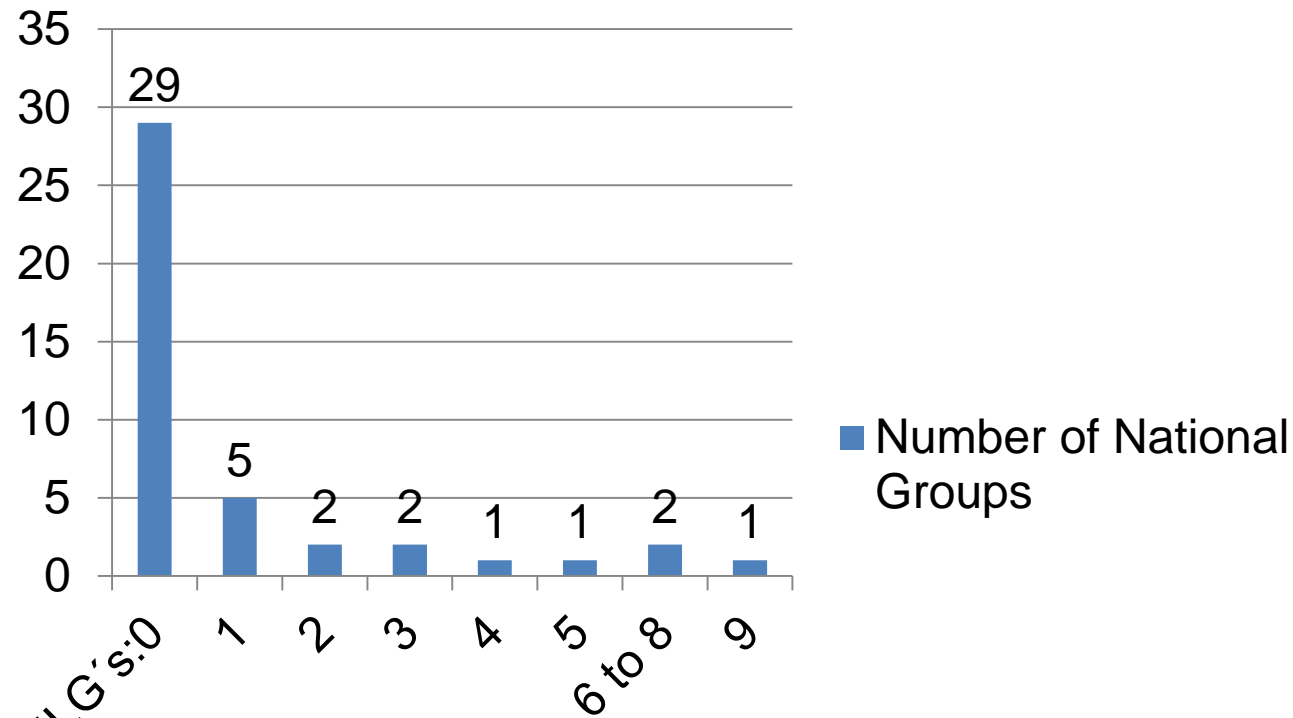

Observer Local Groups per member



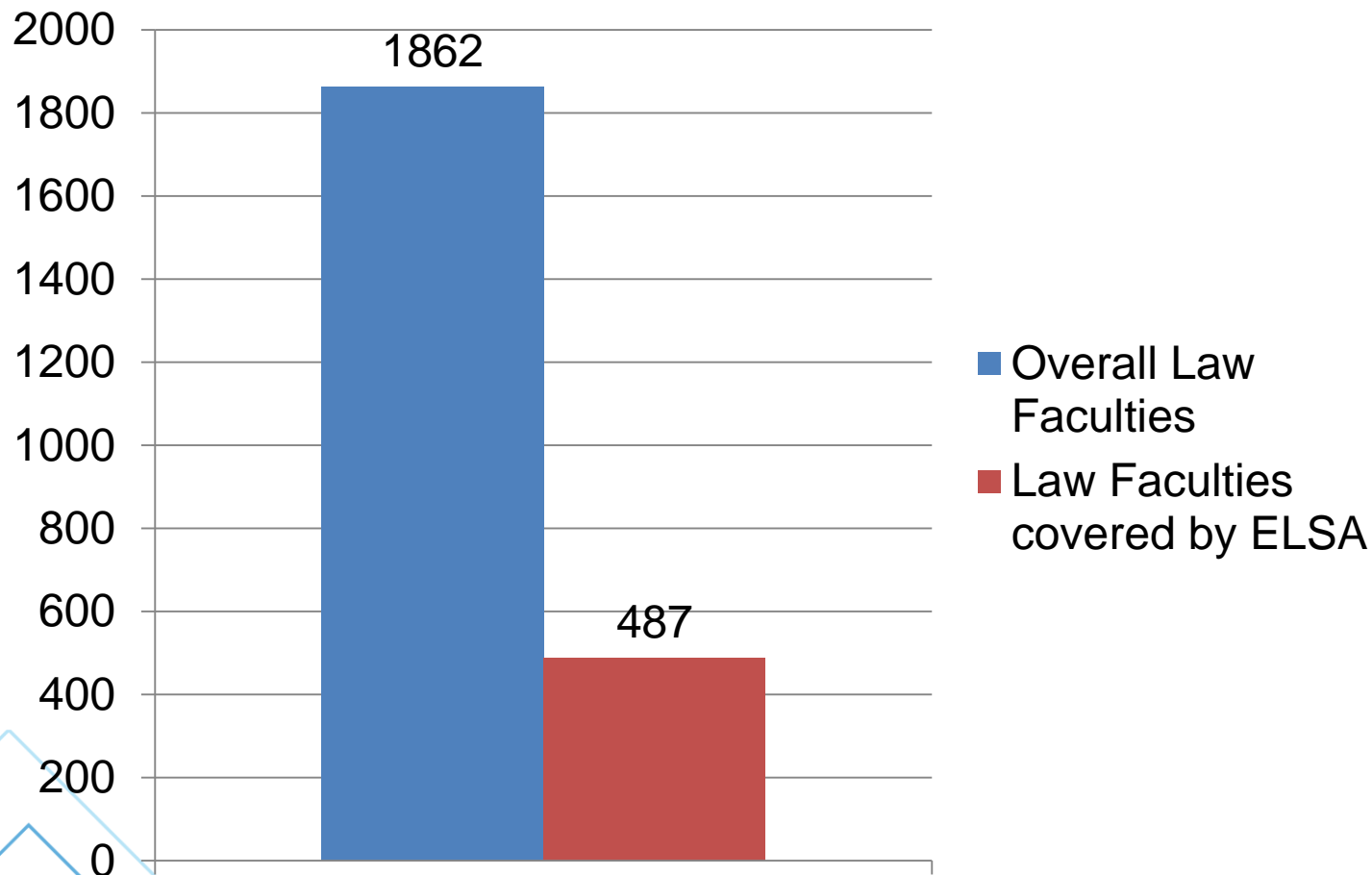

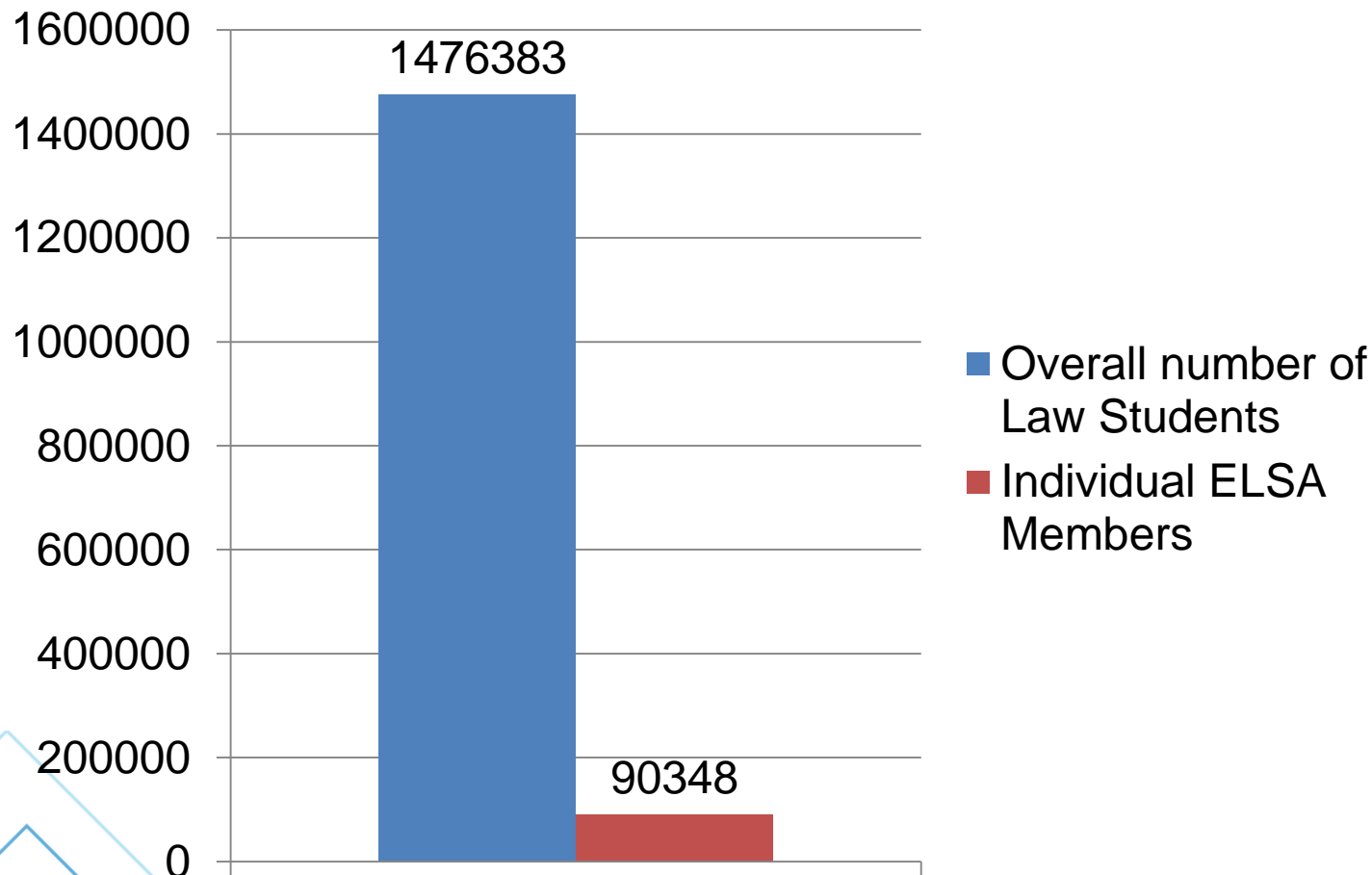

Overall Law Faculties in member countries/Law Faculties covered by ELSA Groups



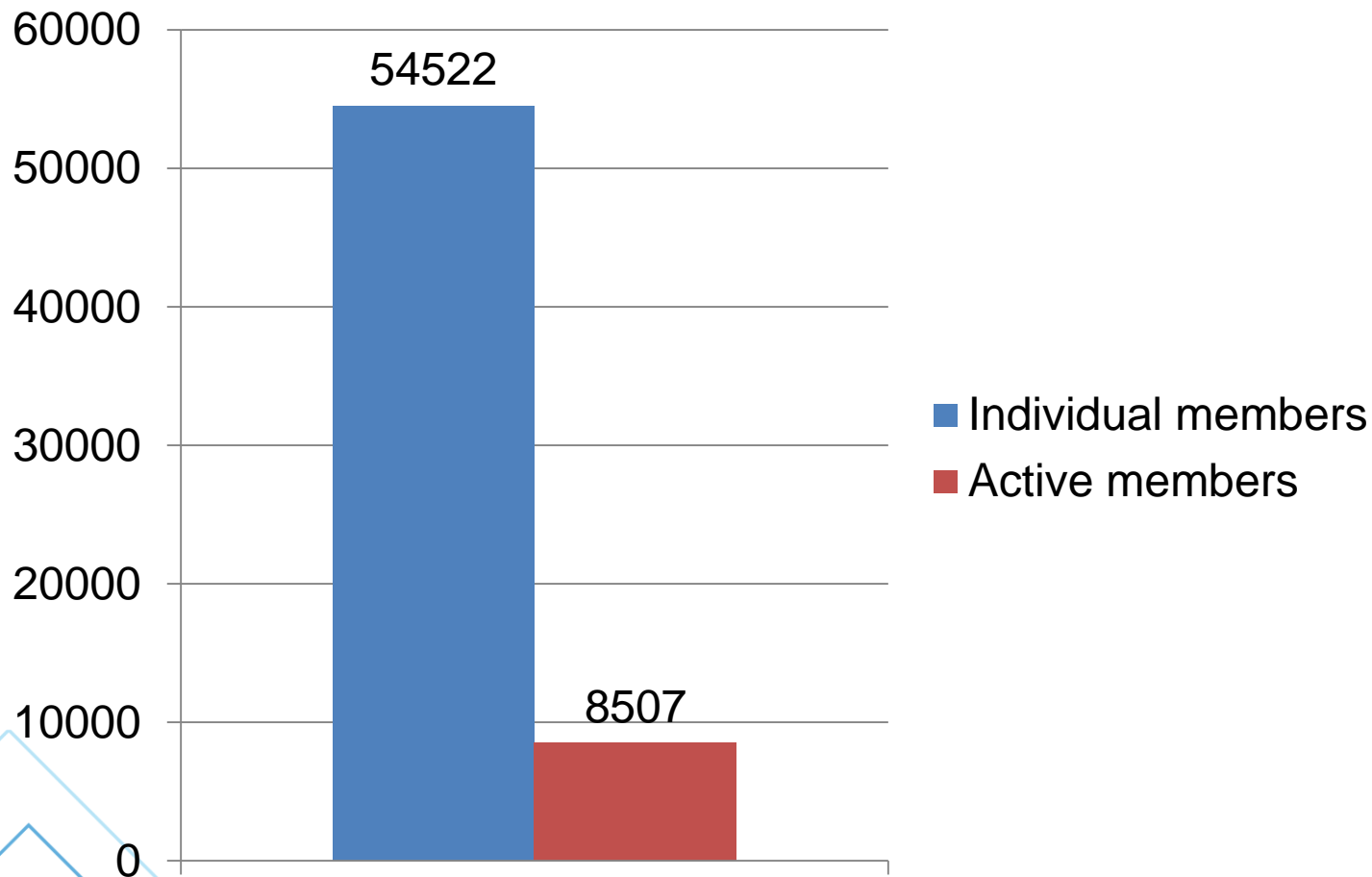
Overall number of law students in member countries/individual ELSA members



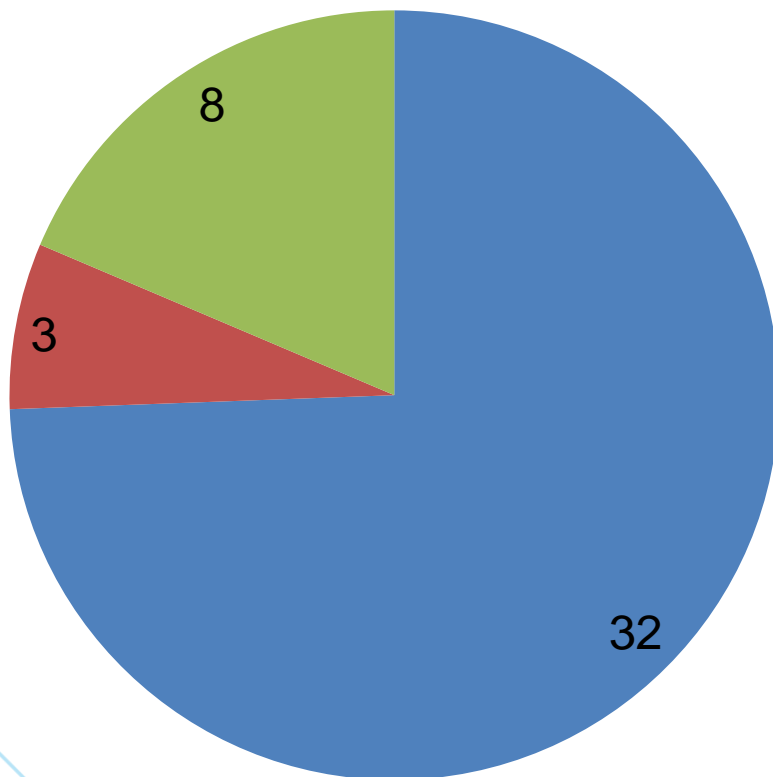

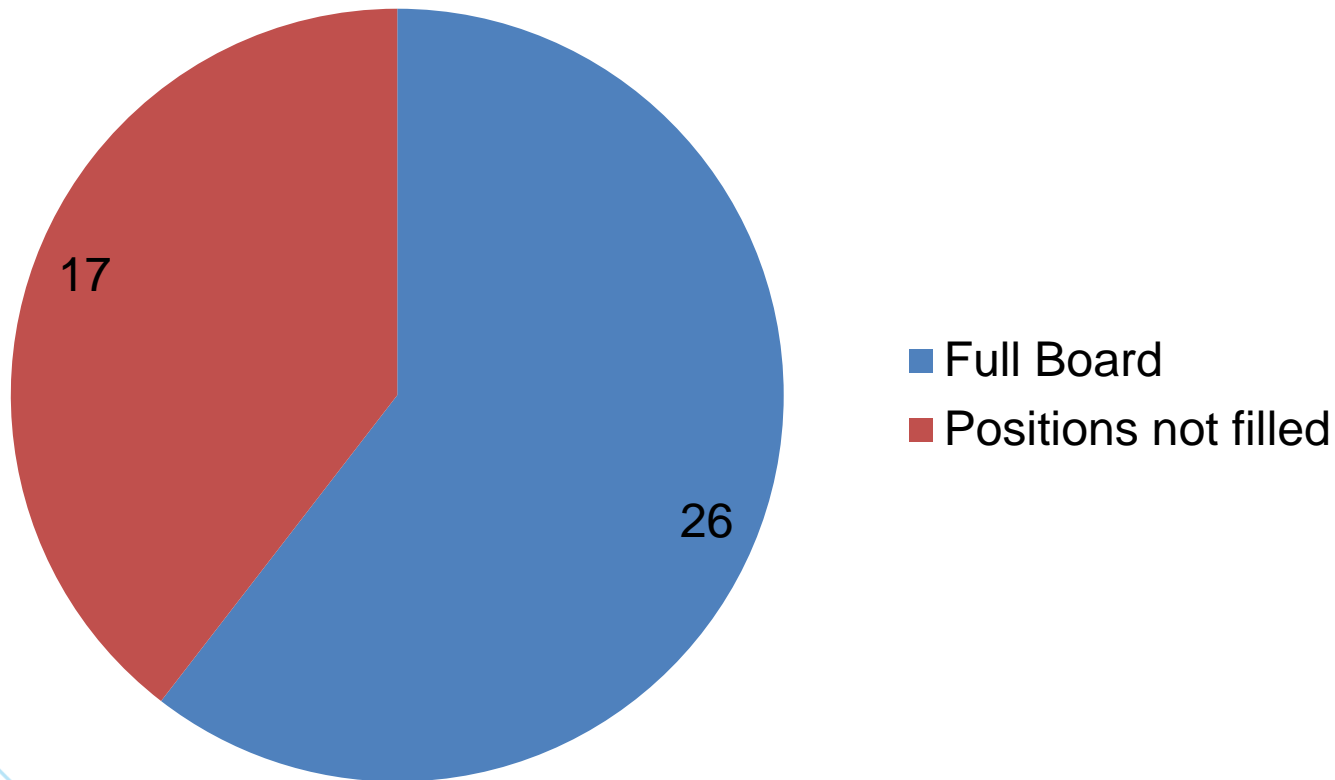

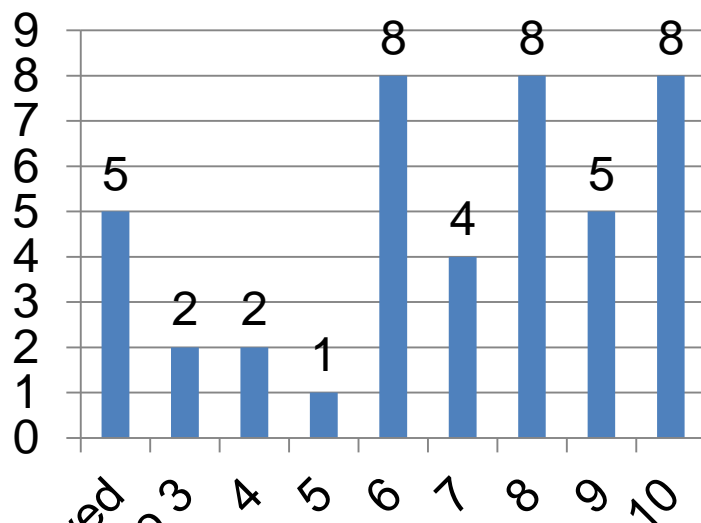

Quality of received transition from former NB

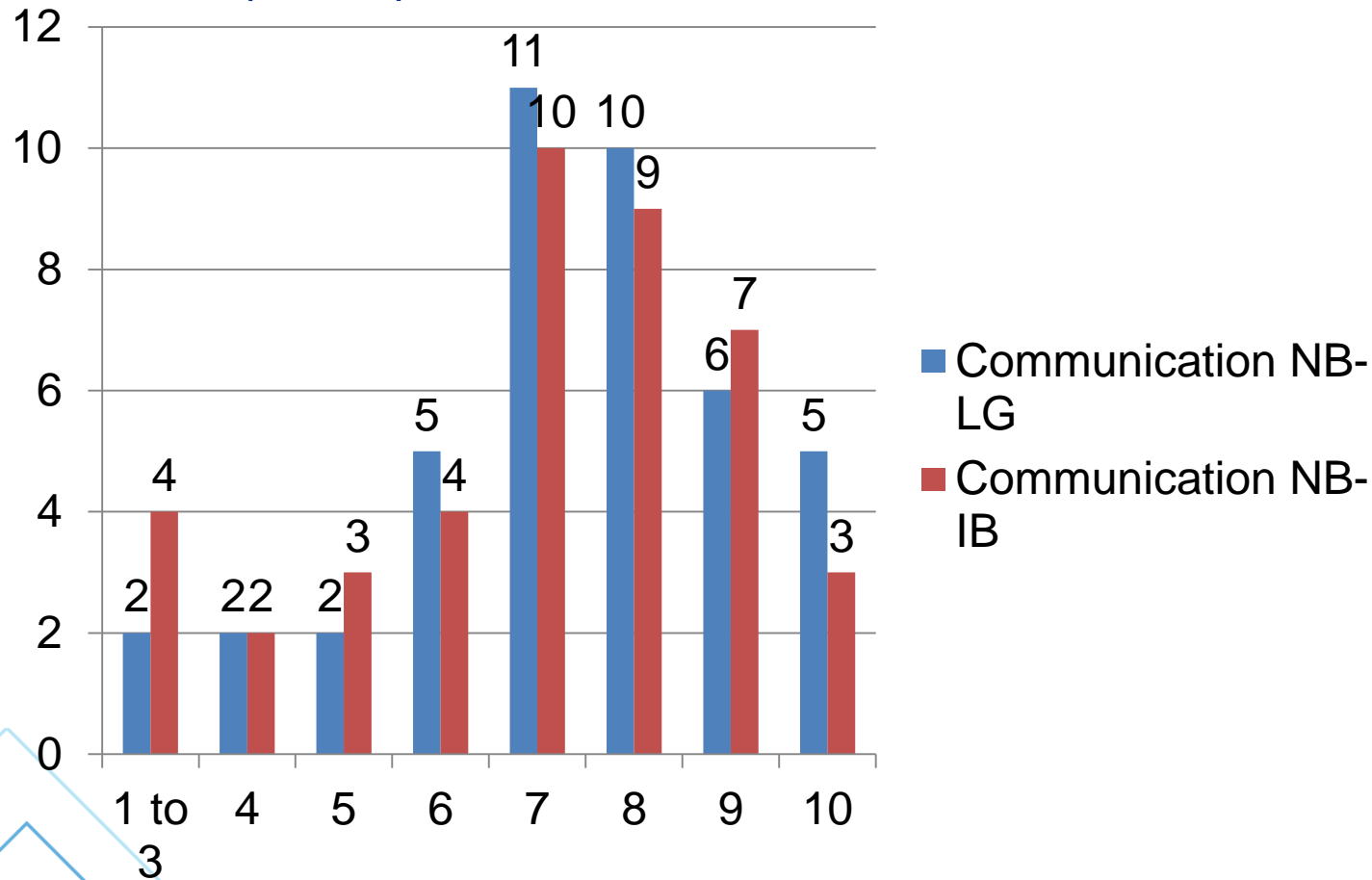

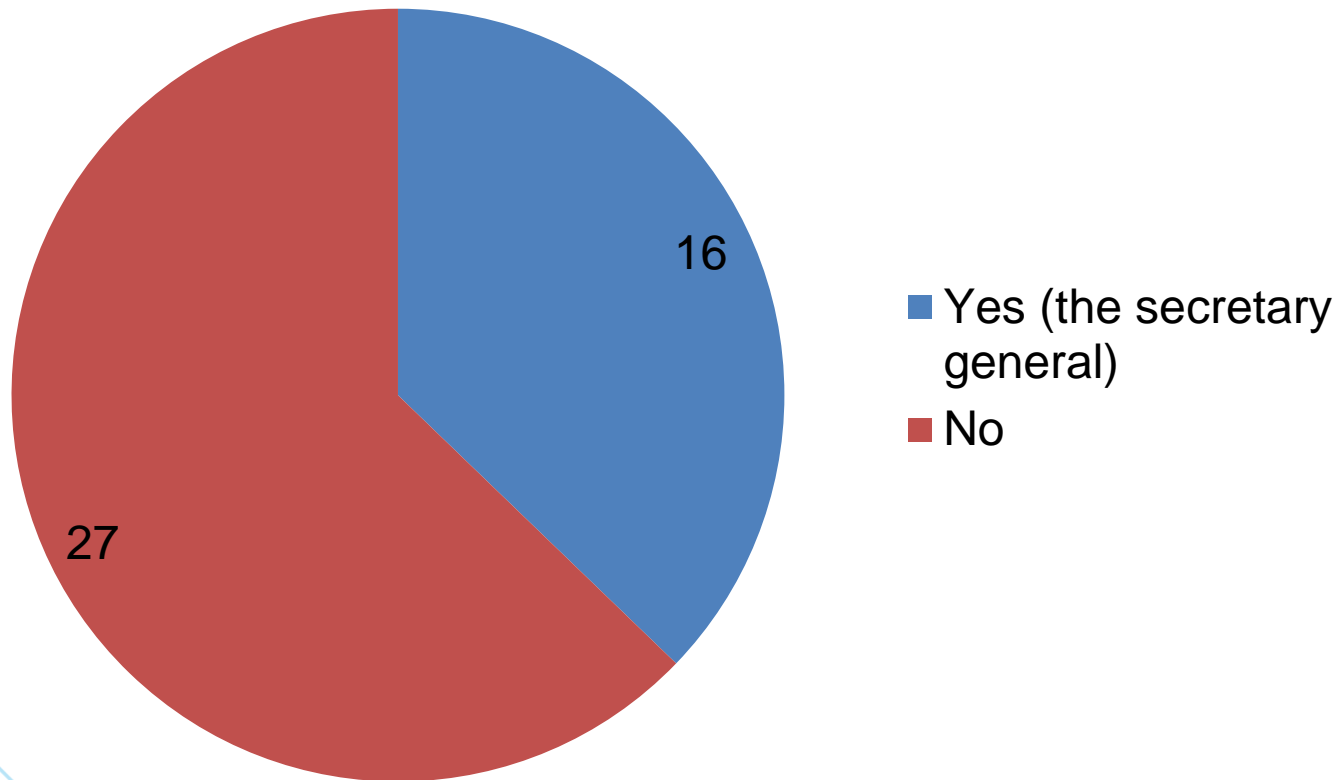

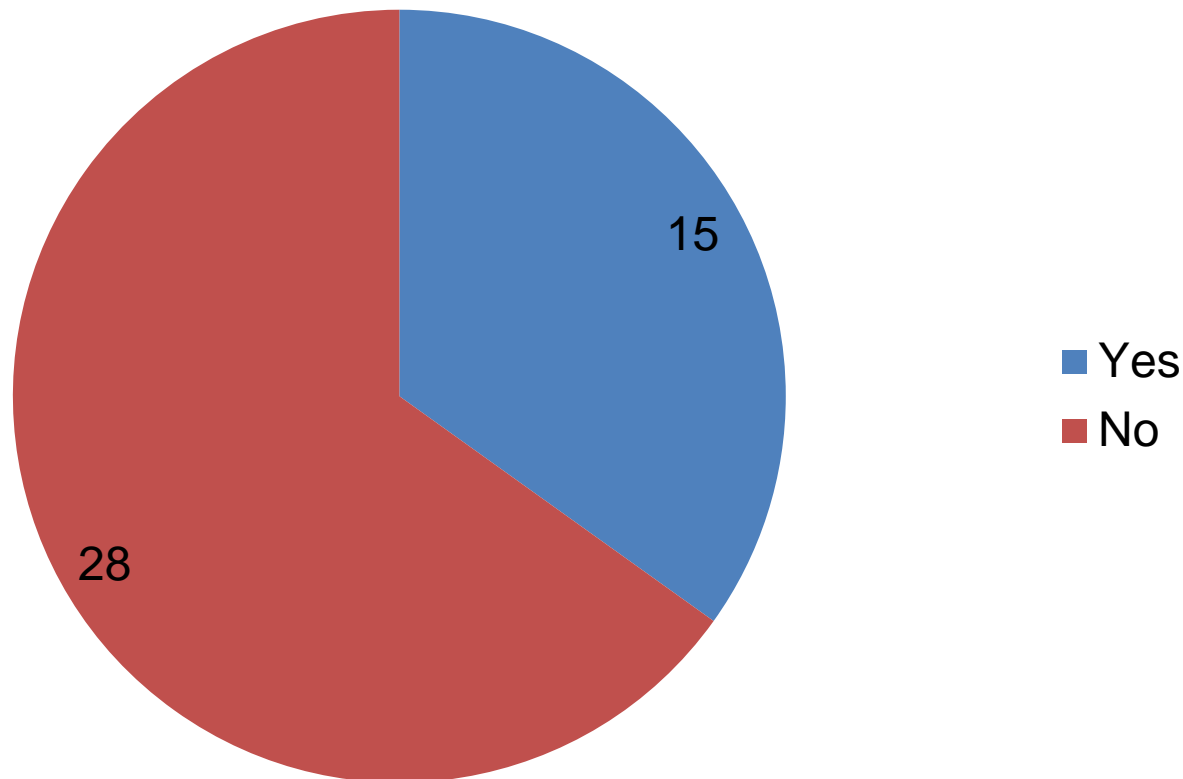
Quality of Communication between NB and Local Groups/Communication between NB and IB (1-10)



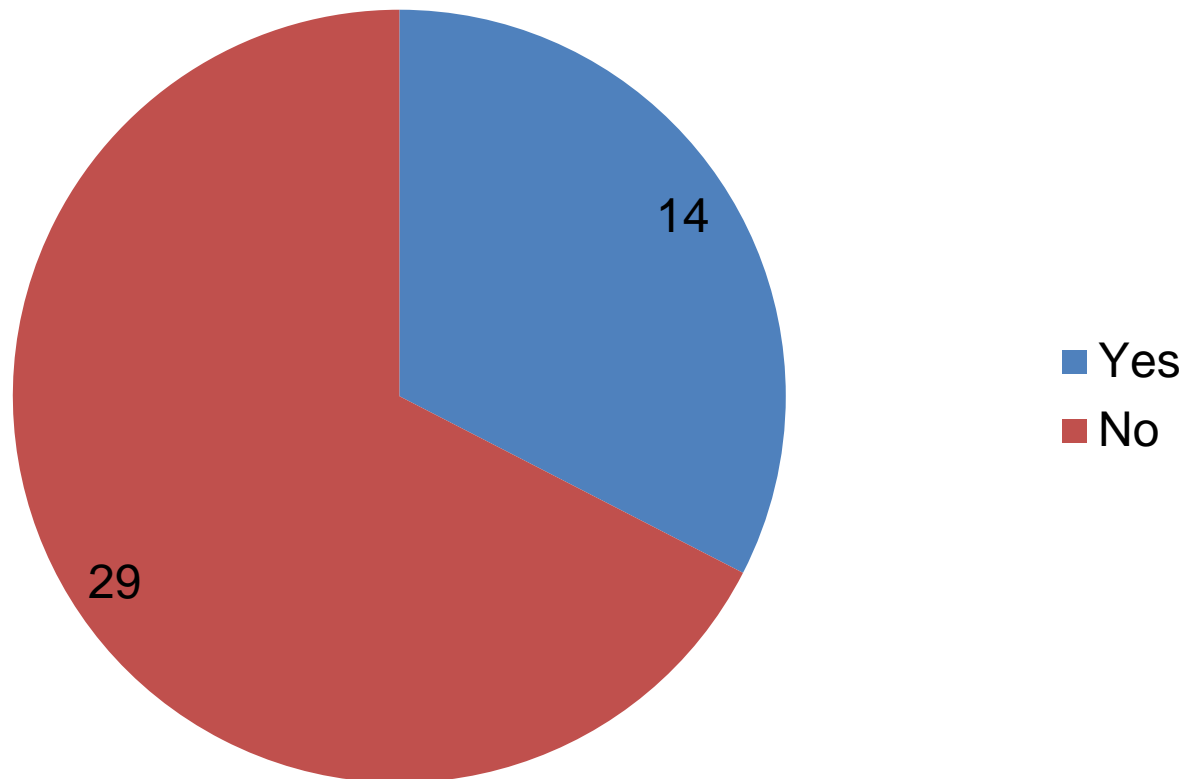

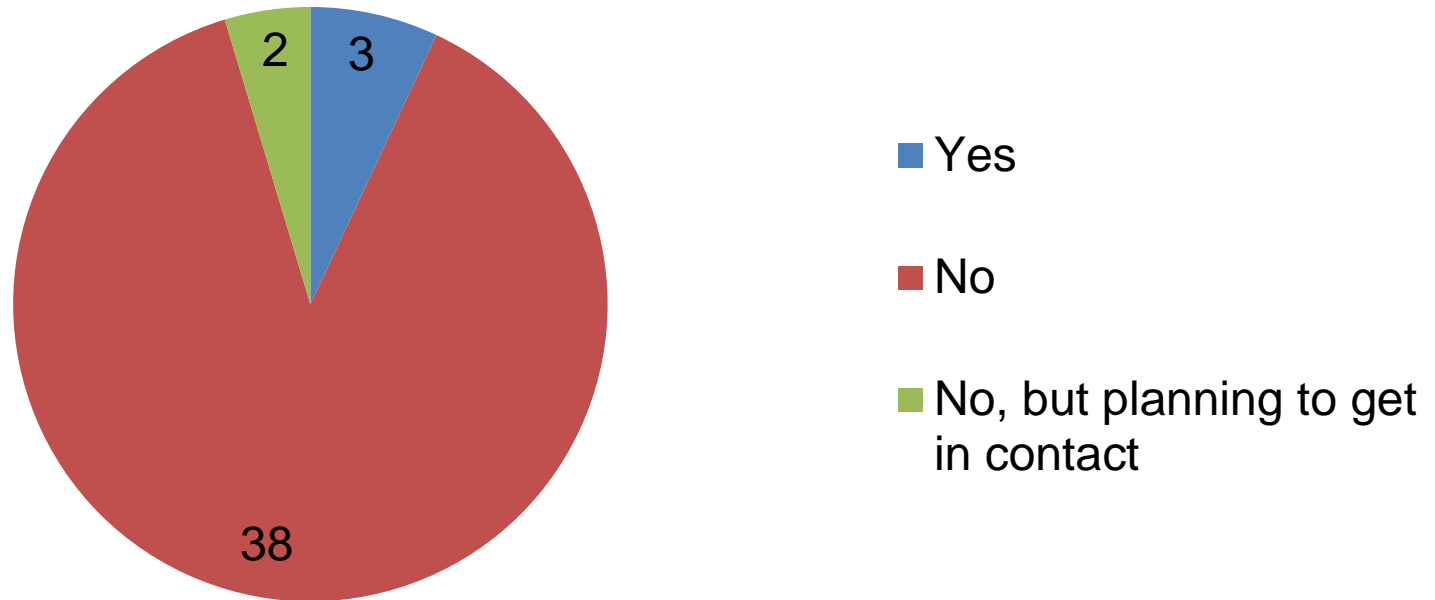
How often do you have board meetings?



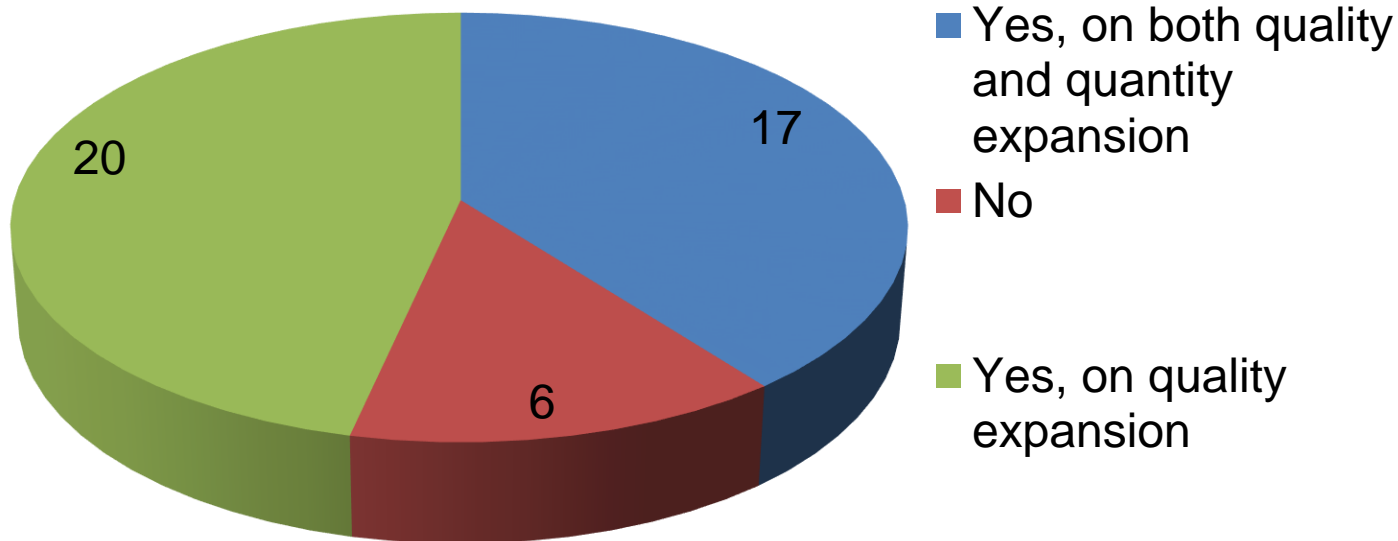
How good is the cooperation within your board? (scale 1-10)

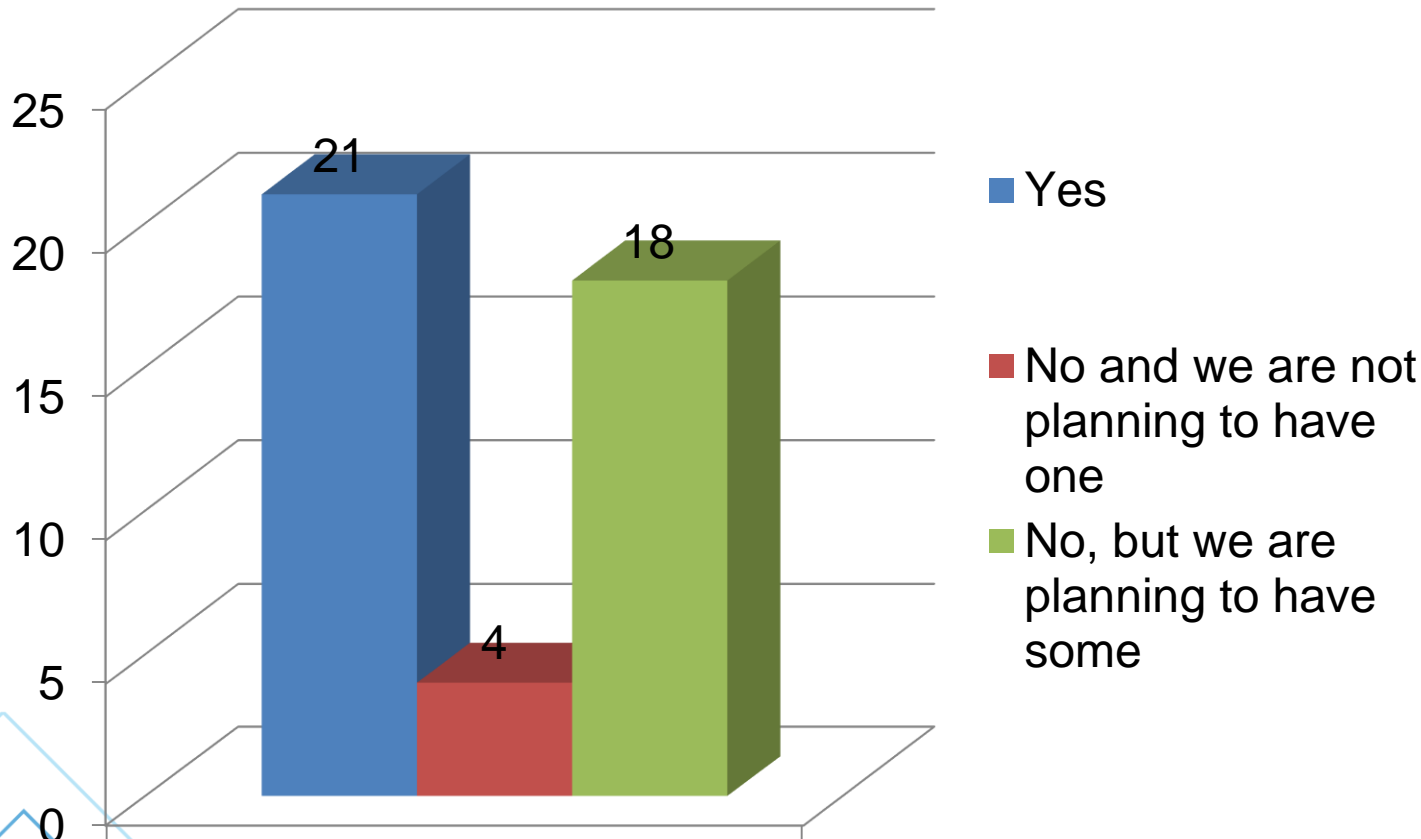
Do you think the HR Strategy is a useful IM tool?



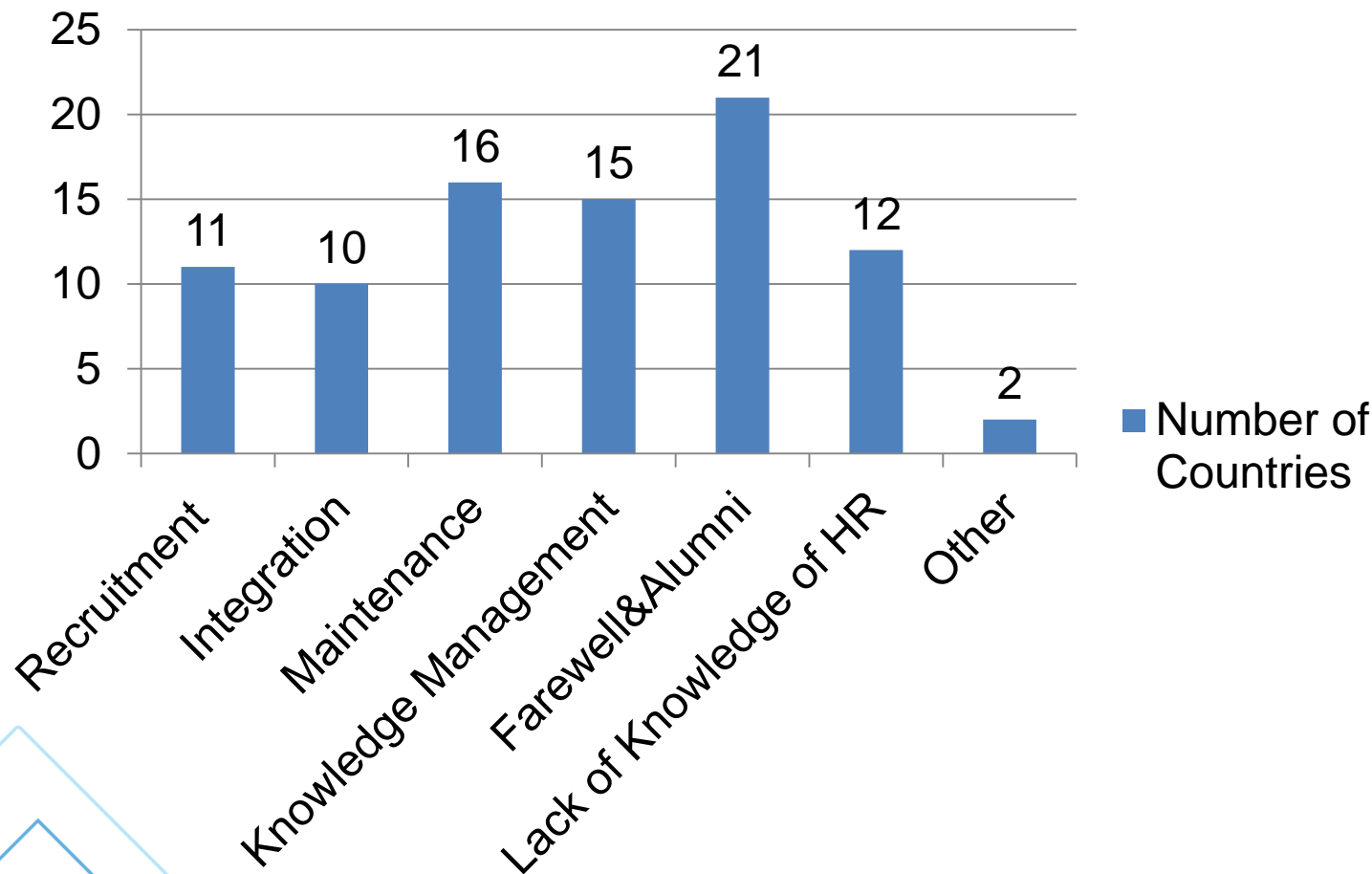

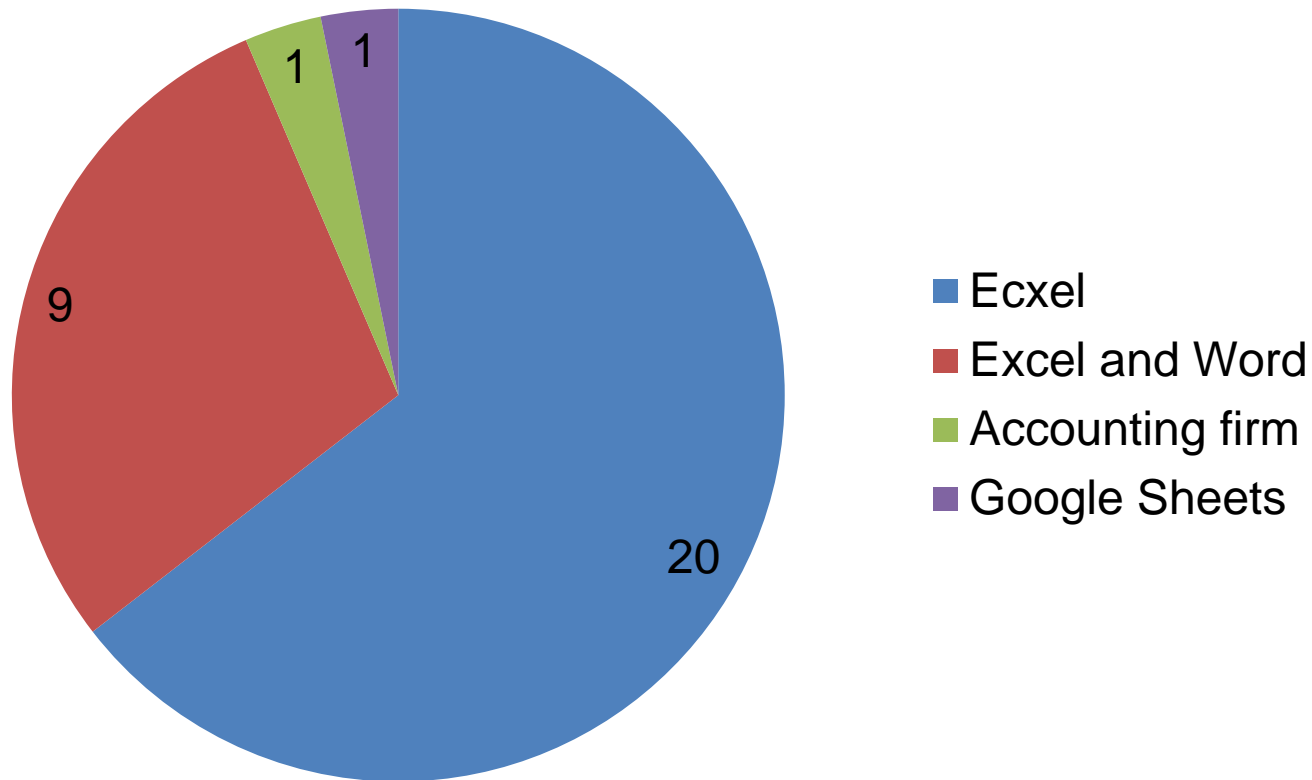
What is your NG's main source of Income? (multiple answers possible)



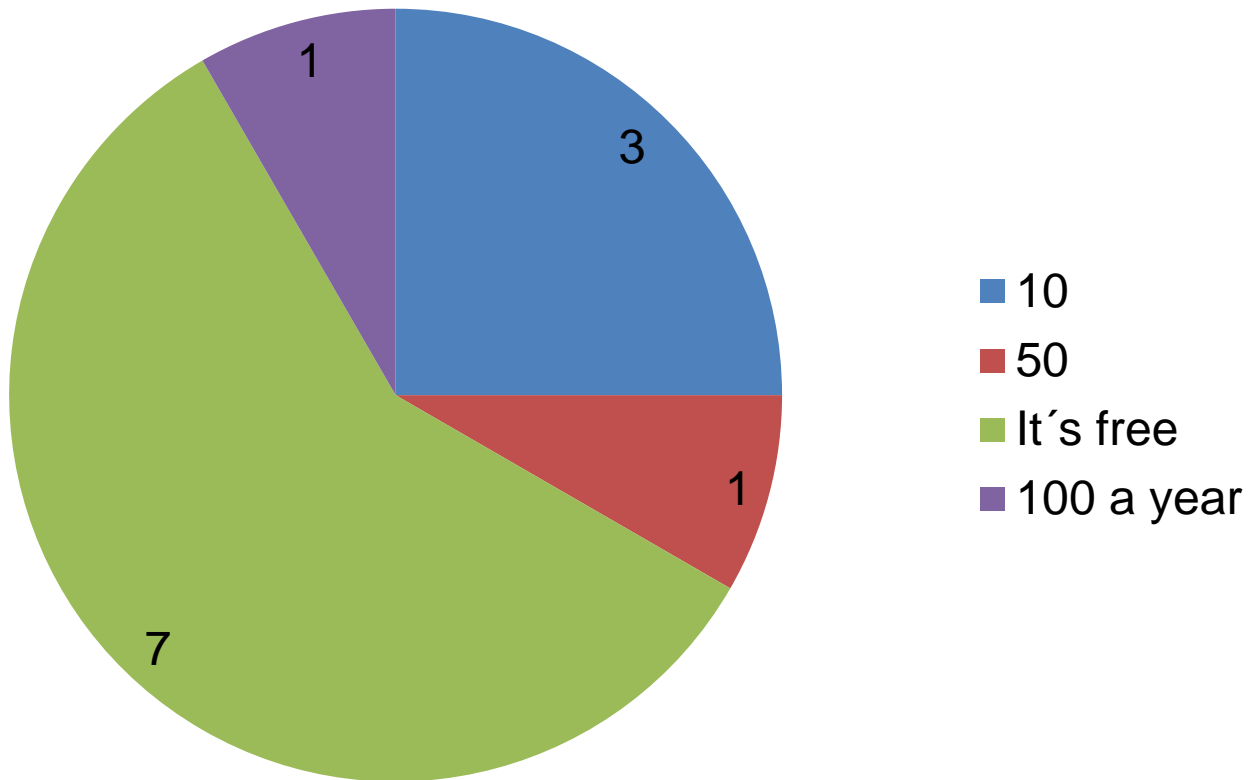

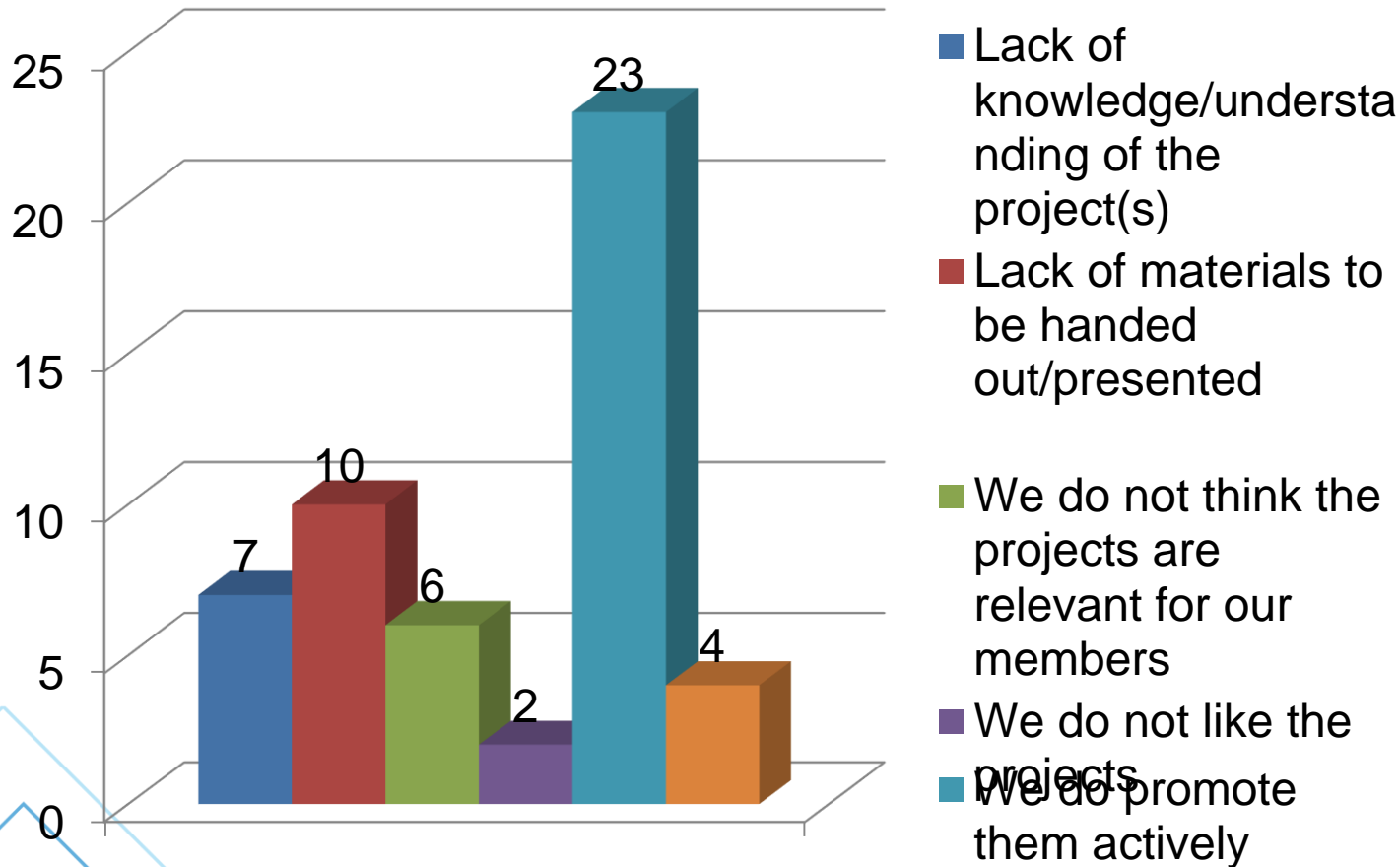
Which of the following international projects does your NG actively promote?



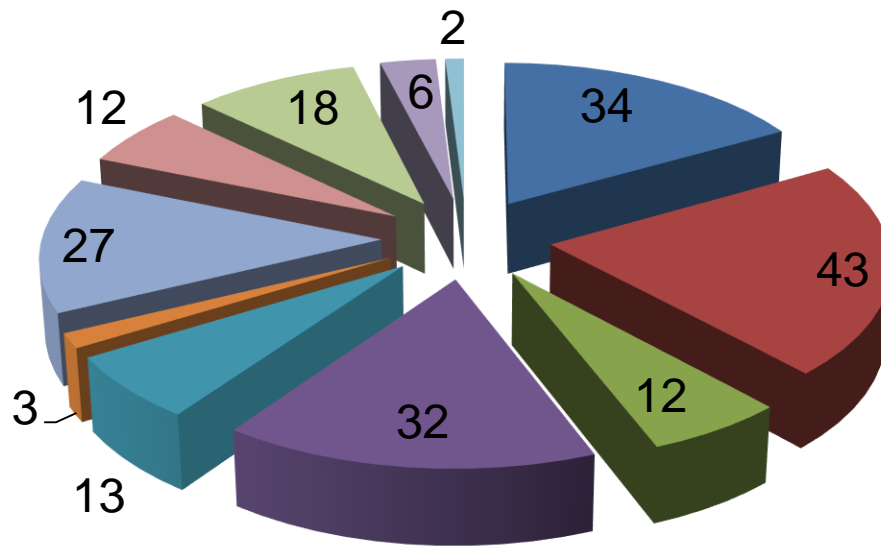
Which of the following flagship projects does your NG find most appealing?

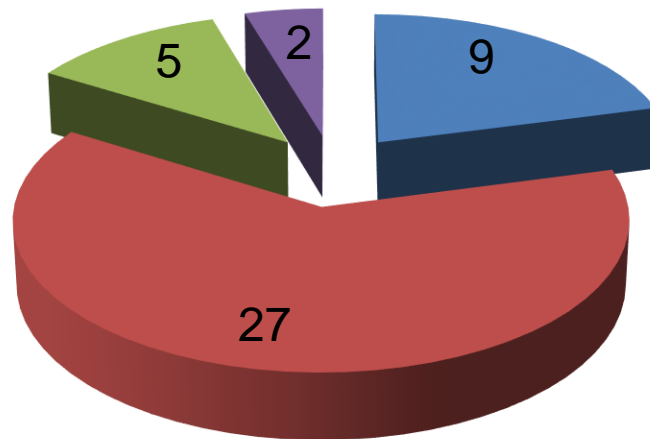

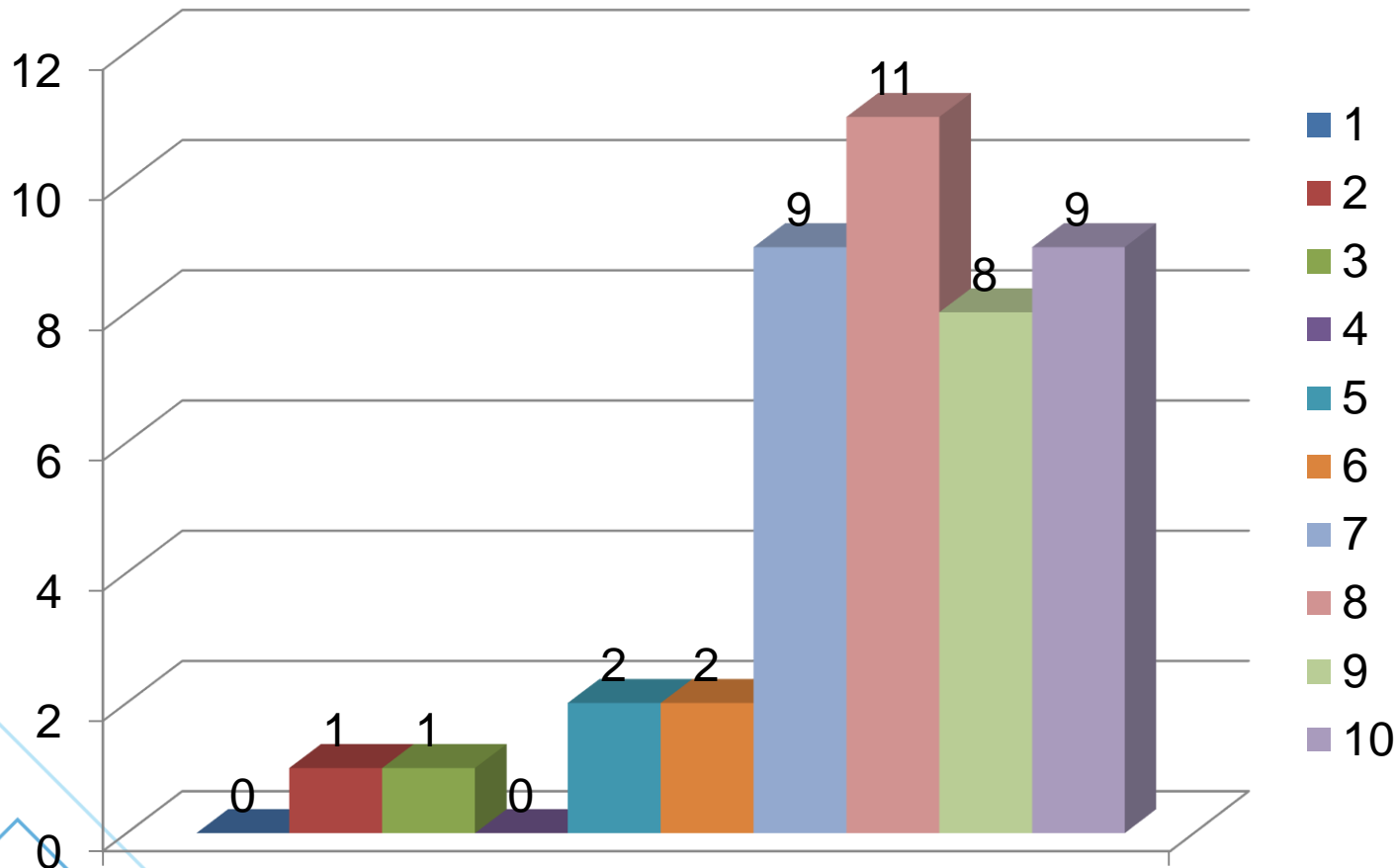

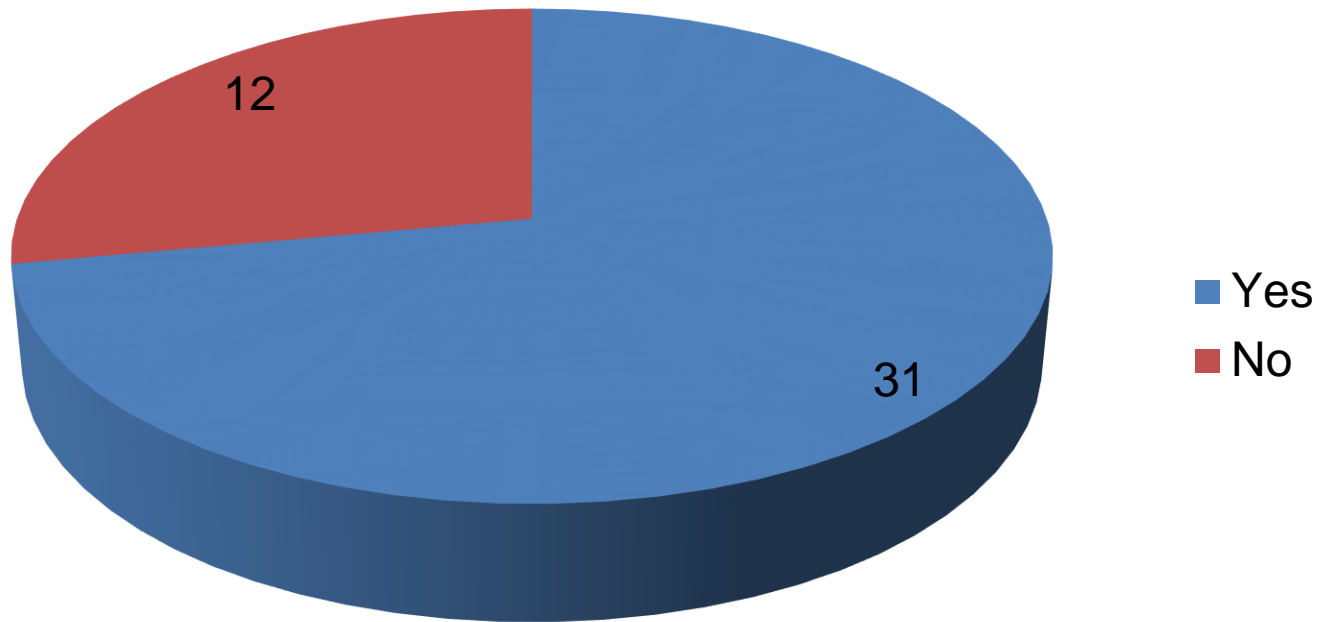
Are you satisfied with Student Hunting during the 1st cycle?



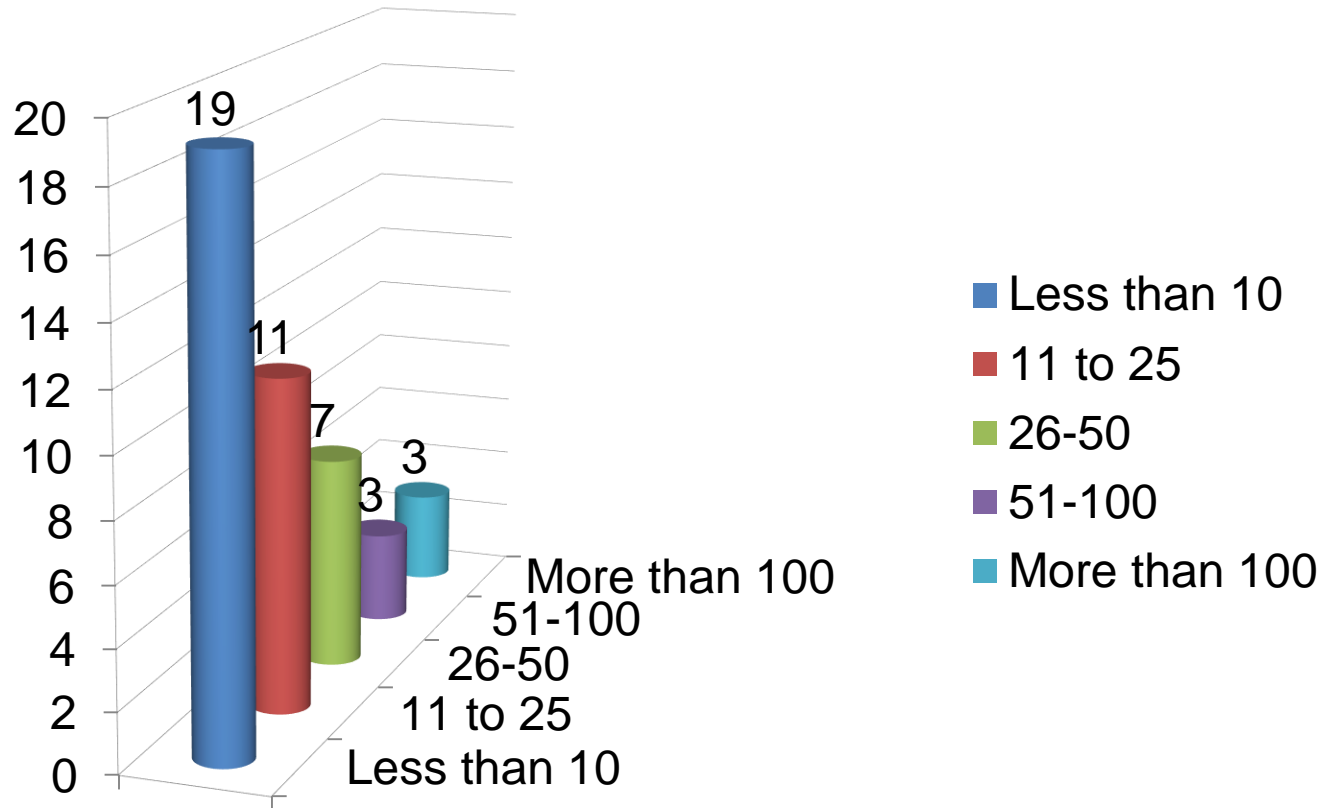
Evaluation of Contact with your STEP Coach (scale 1-10)
