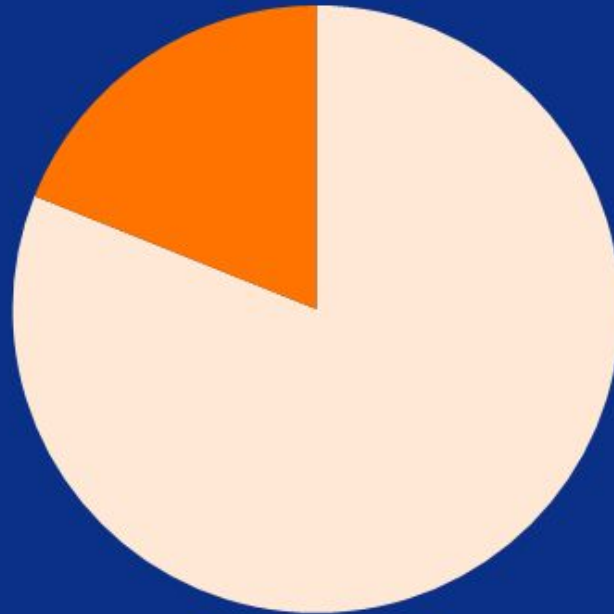

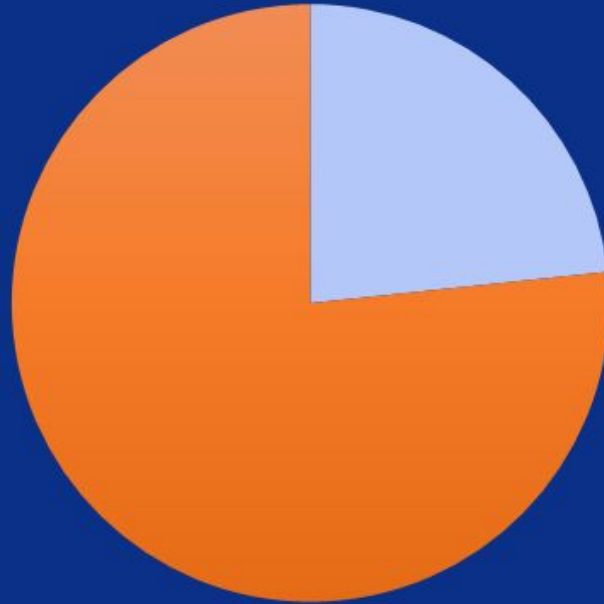

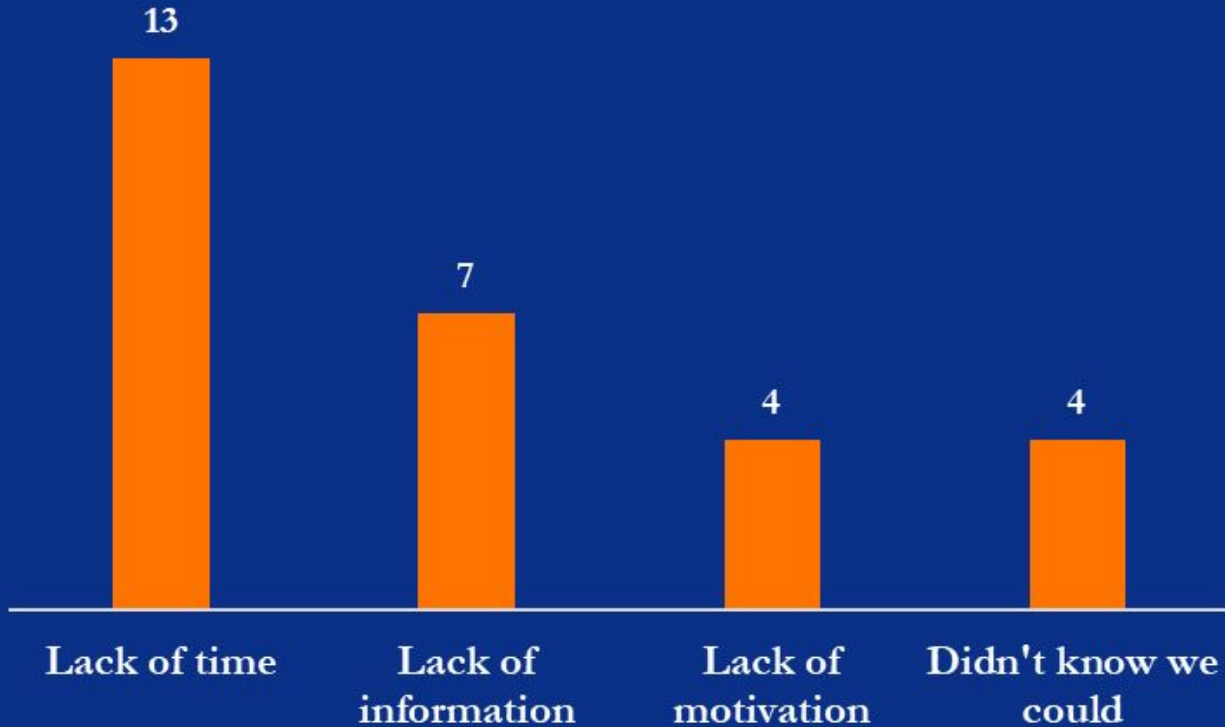

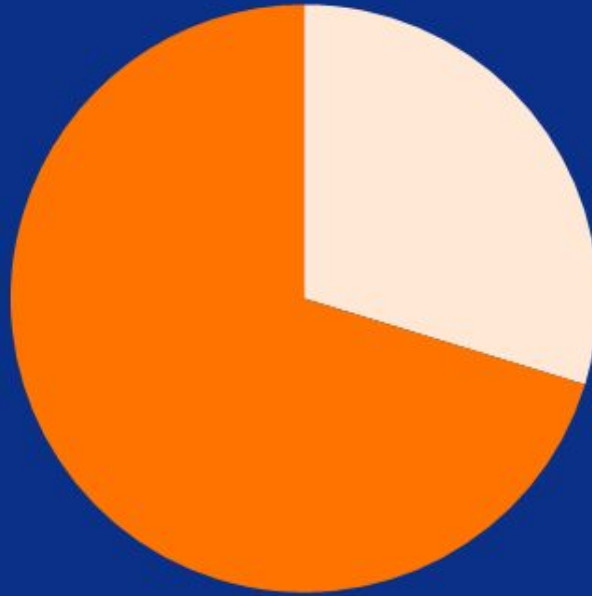

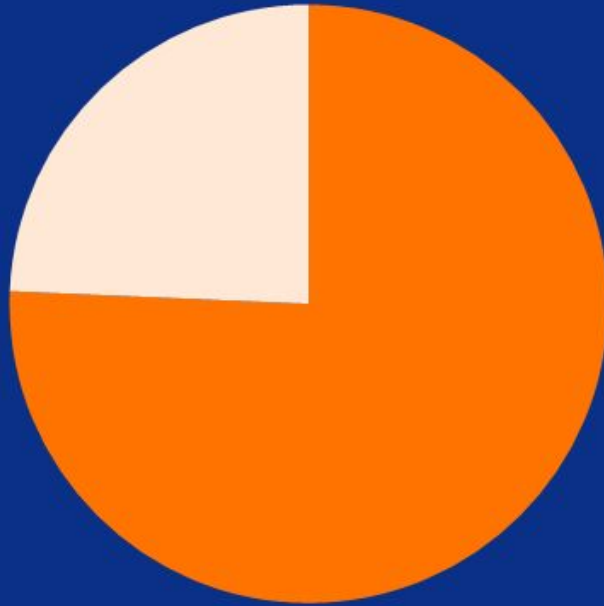

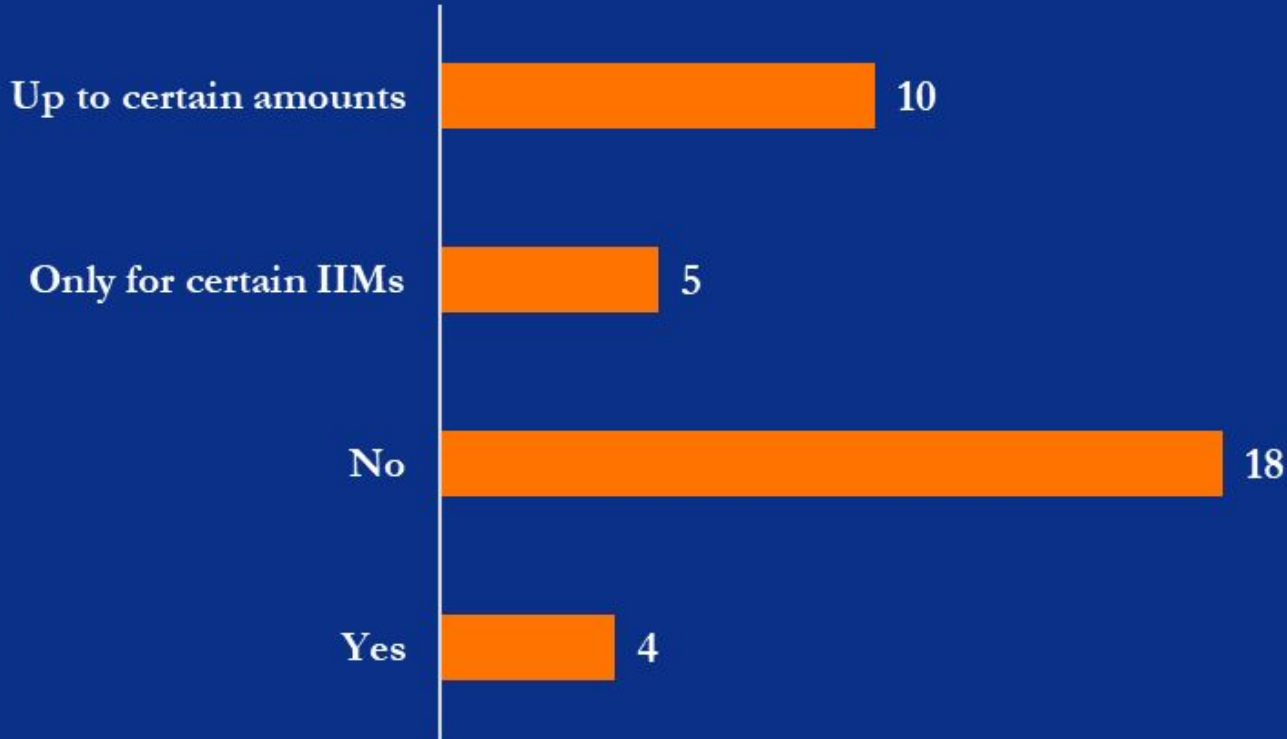
## 6. How much is the “Annual General Income” of your National Group gathered in the immediate previous financial year expressed in EURO?

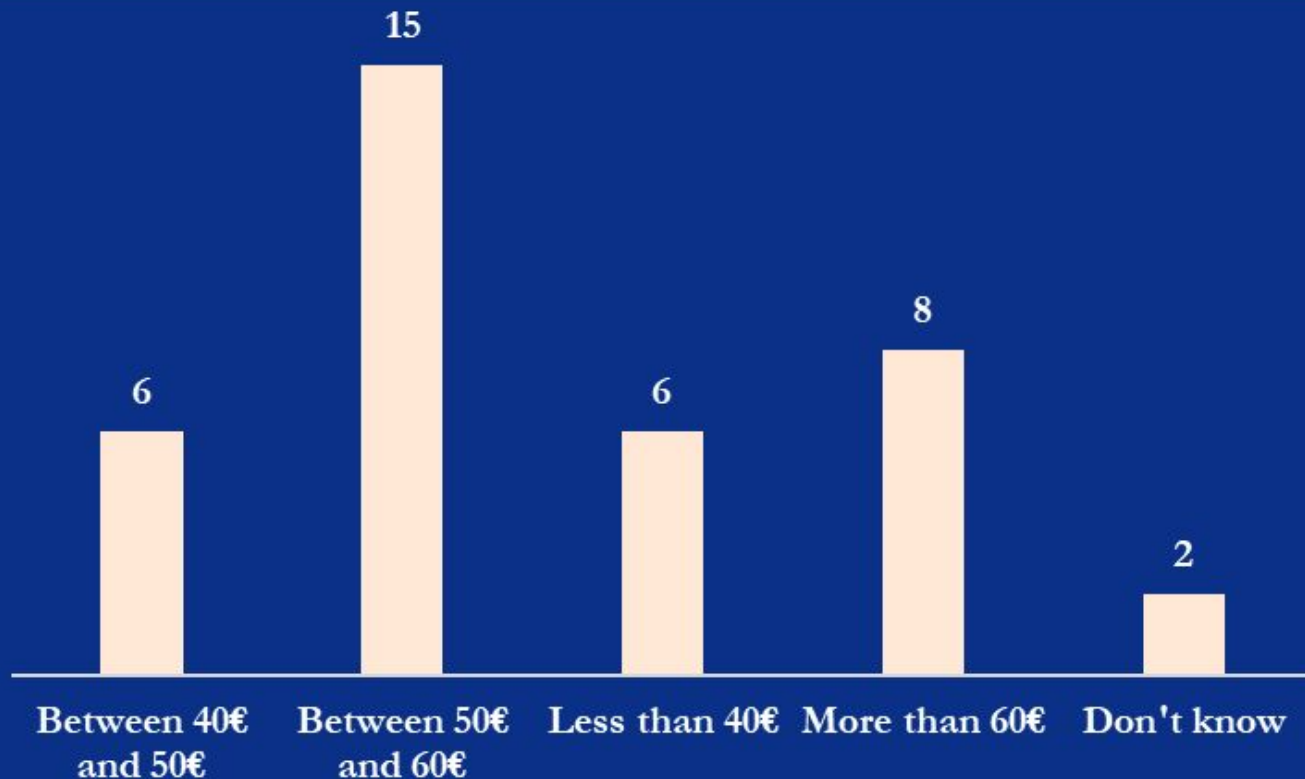




## 7. Does your National Board cover the expenses of the delegates for International Internal Meetings?



## 8. How much would you need to charge per participant per night to be able to organise an IIM? (participant fee includes accommodation and meals)

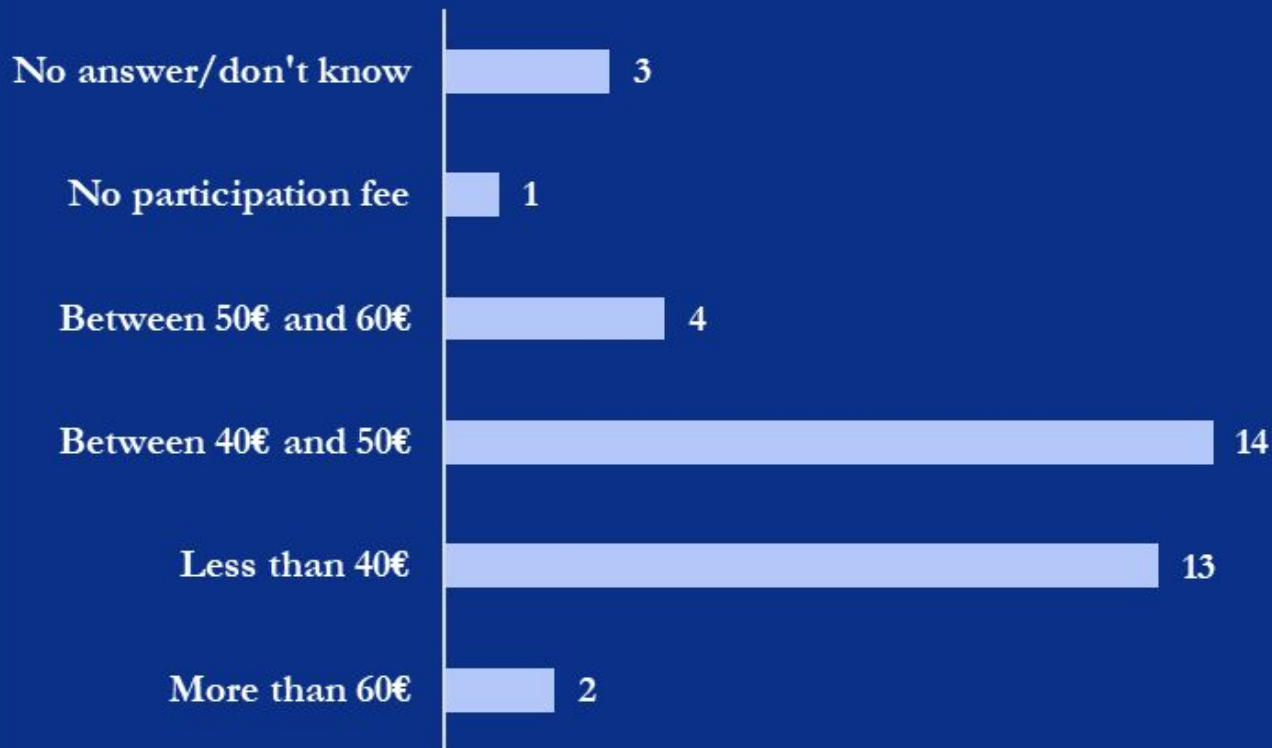


## 9. How much is the participation fee for your National Council Meetings? (per night including meals)

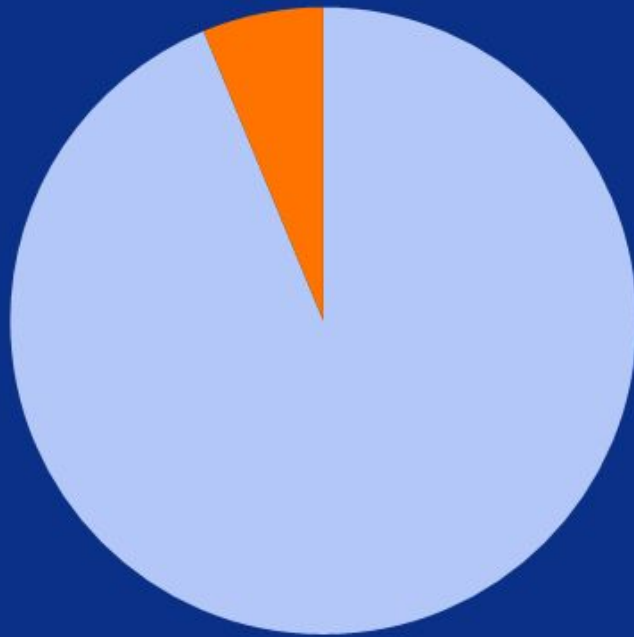

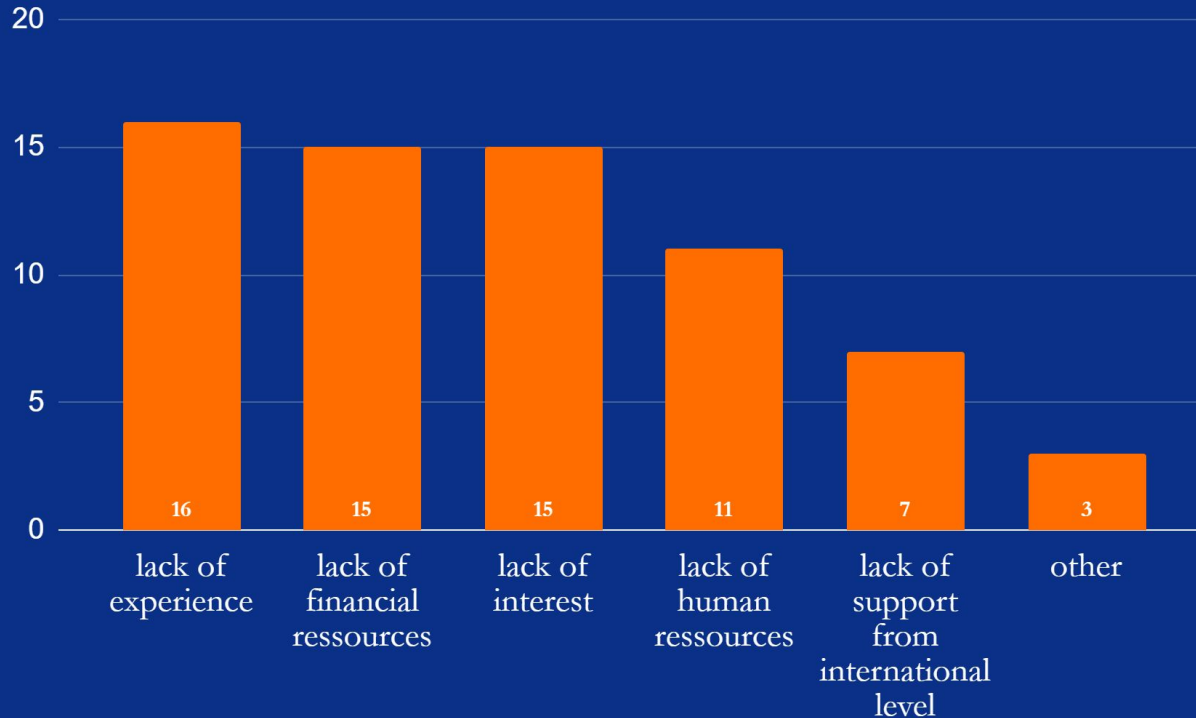

# 15. Which difficulties do you face related to your social responsibility projects?





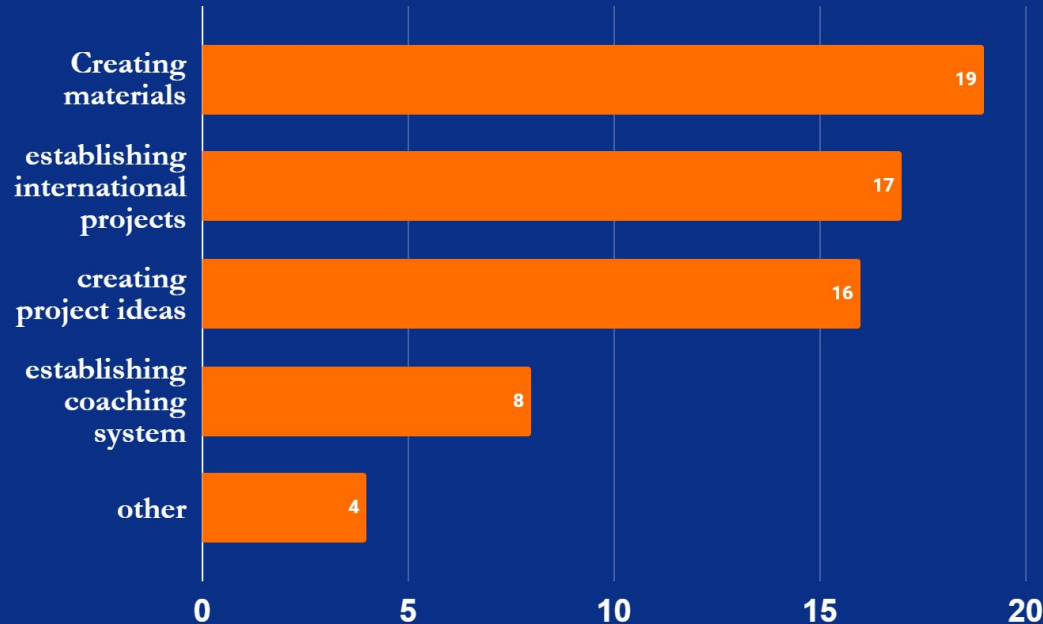

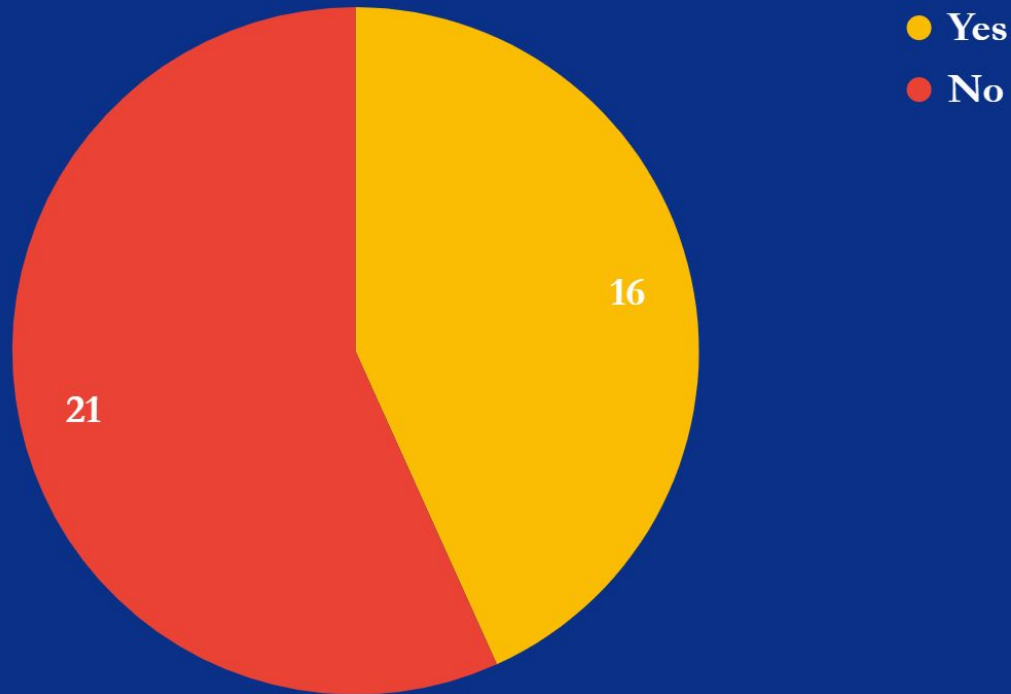
# 17. Are you familiar with the concept of the Vice President in charge of Competitions that will take effect from the term 2022-2023?



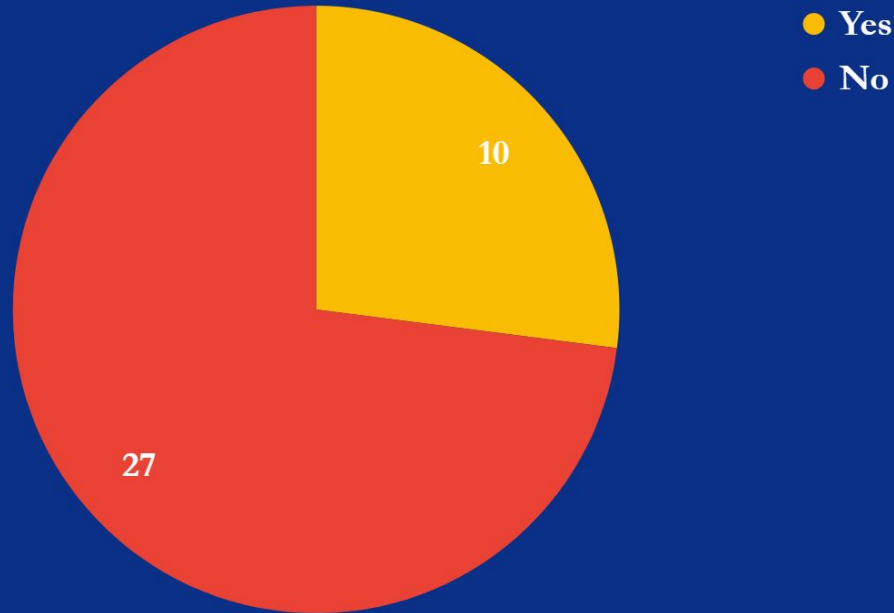
## 18. Does your National Group have a Vice President in charge of Moot Court Competitions?

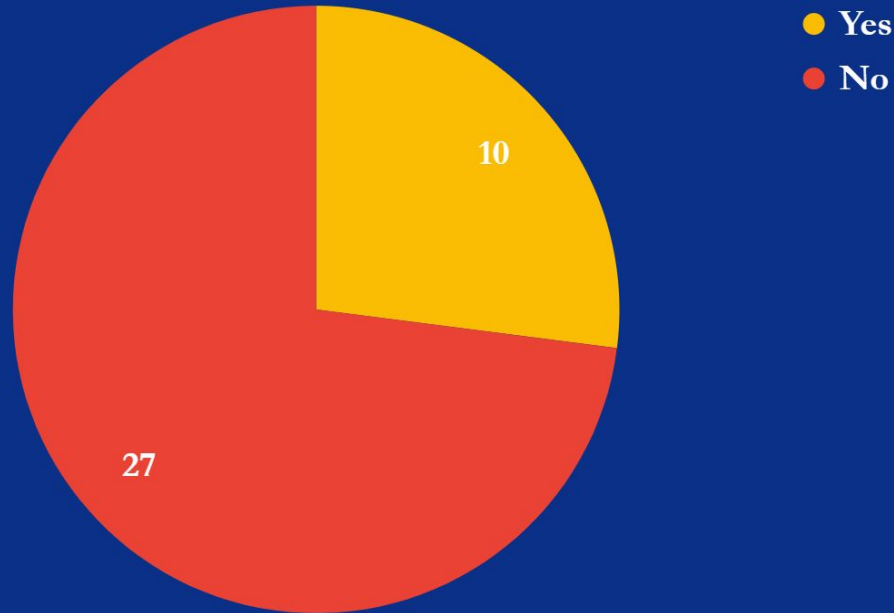


## 20. Would you need assistance from ELSA International in the transition to Vice President in charge of Competitions?

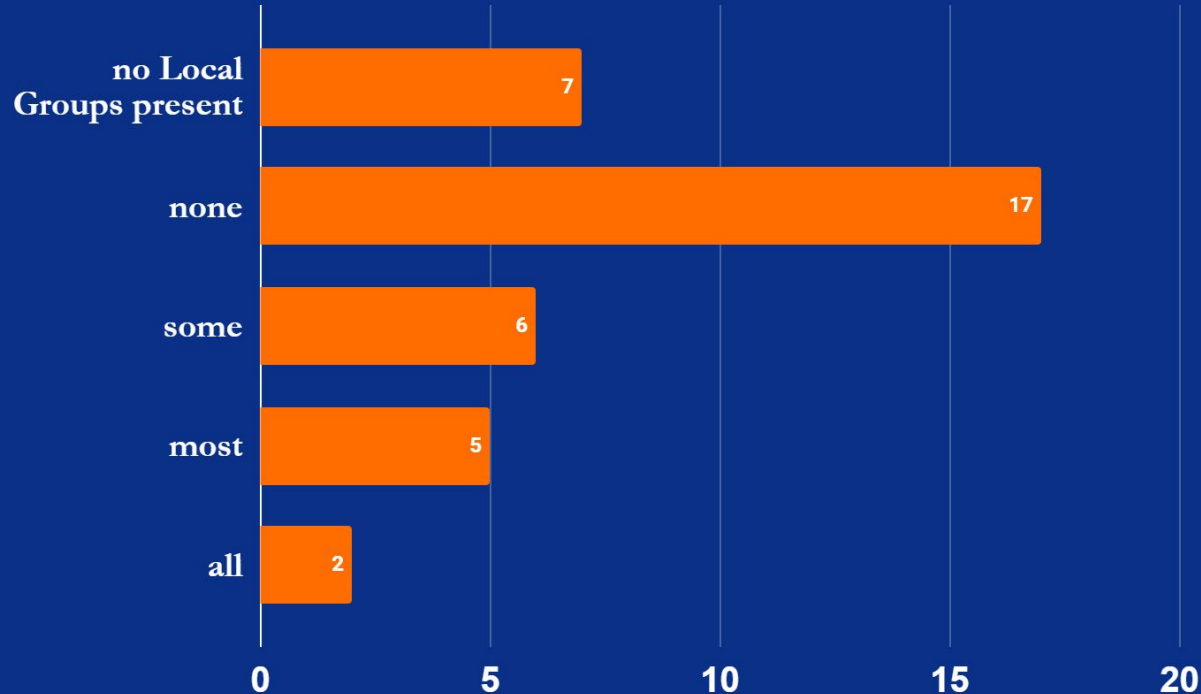

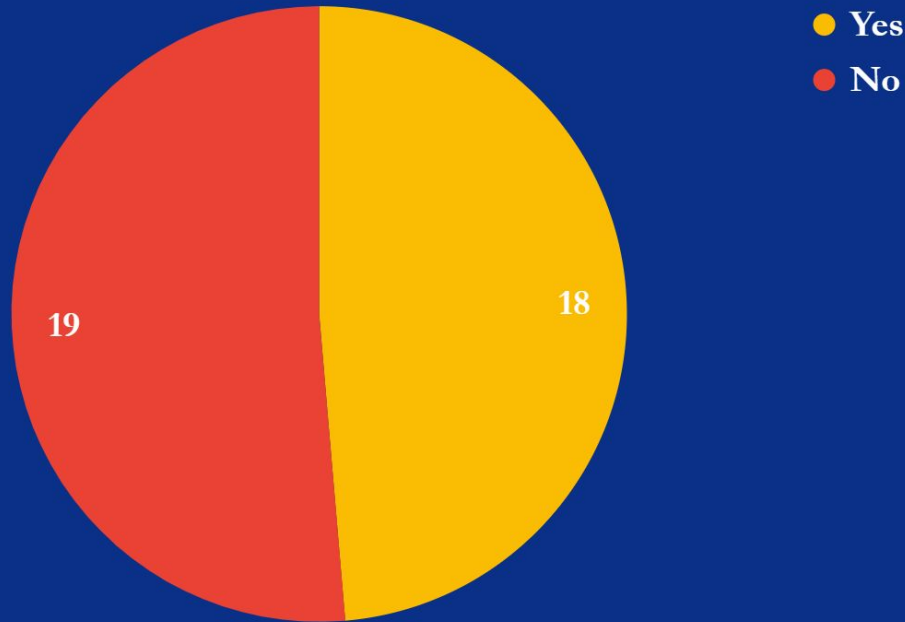
22. In your opinion, after the first year of implementation, are the responsibilities and tasks of the Professional Development area well defined?



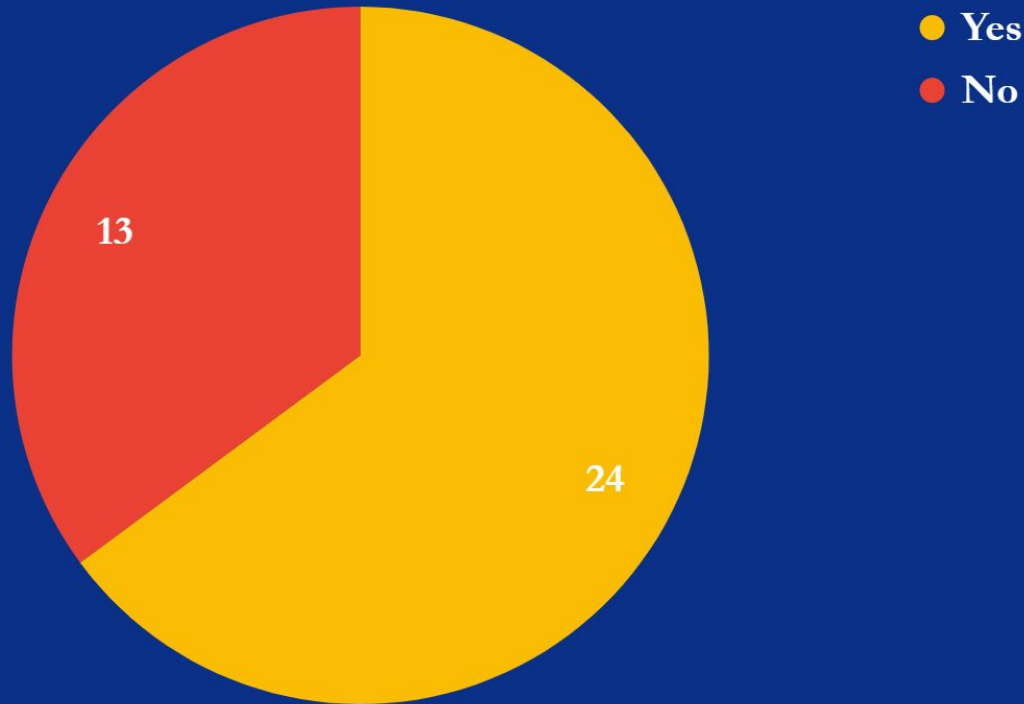
## 23. Did your National Group complete the transition from STEP to Professional Development position during this term?



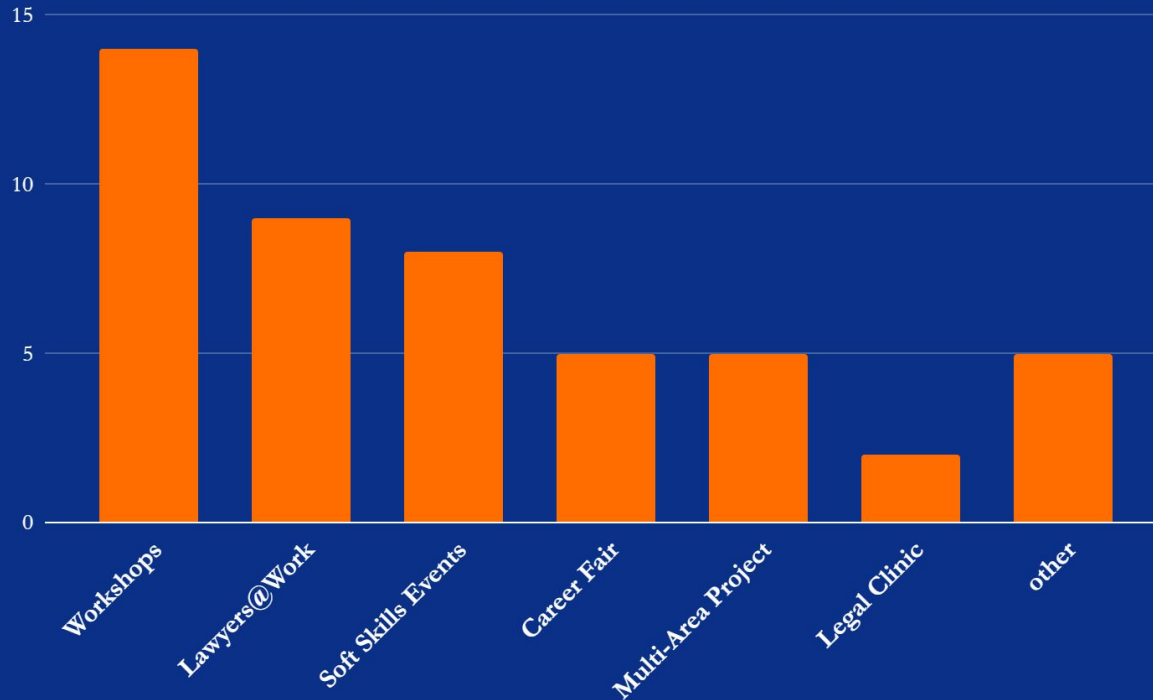

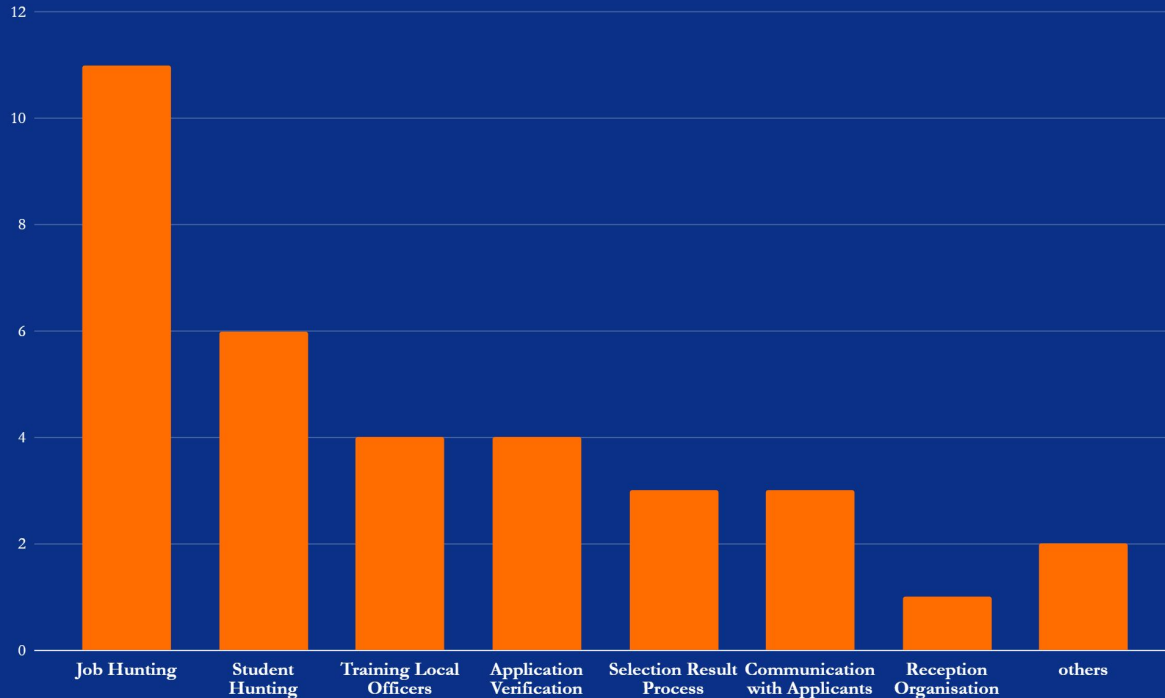

## 27. Did you face difficulties in the activities related to ELSA Traineeships?



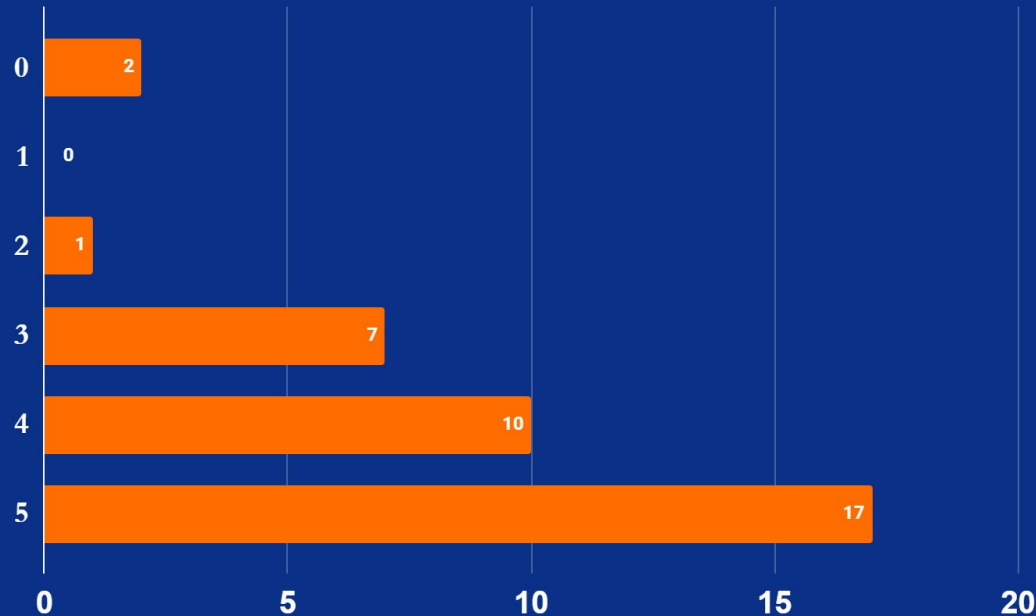

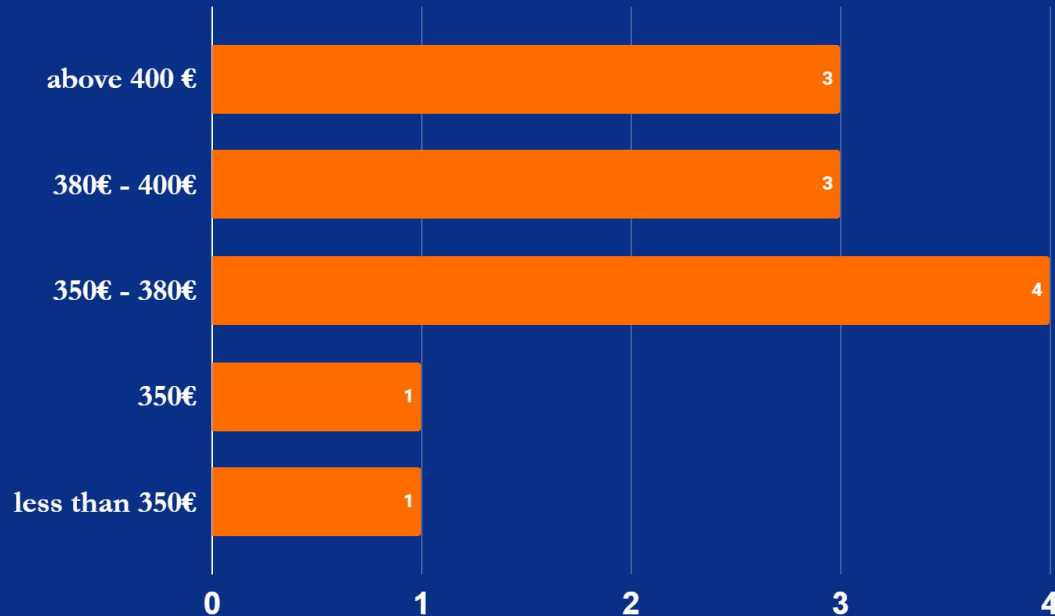
## 29. Do you believe that the maximum participation fee for ELSA Law Schools reflects the costs of organising it?

## 30-B. What would be the ideal maximum participation fees for an ELSA Law School in your opinion?



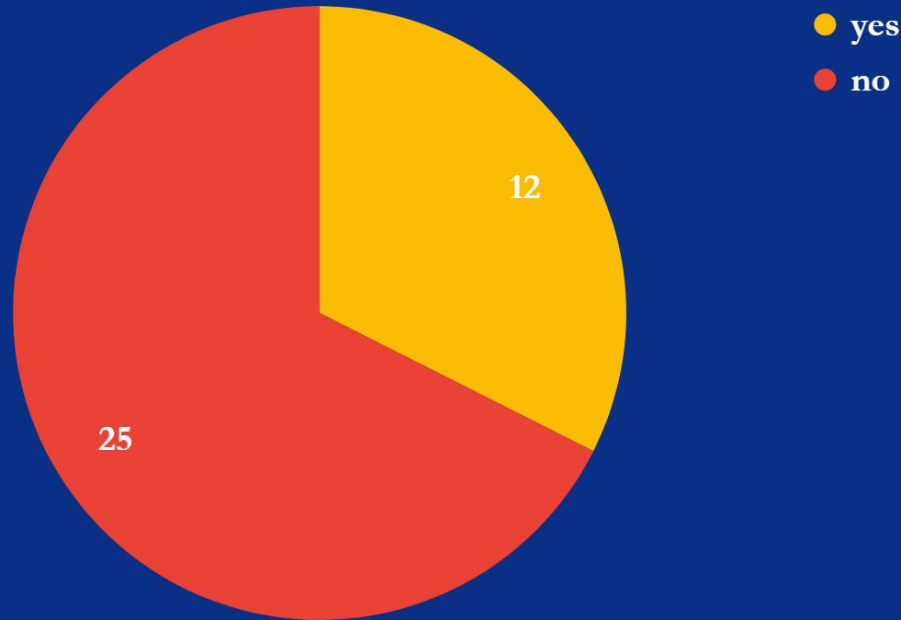

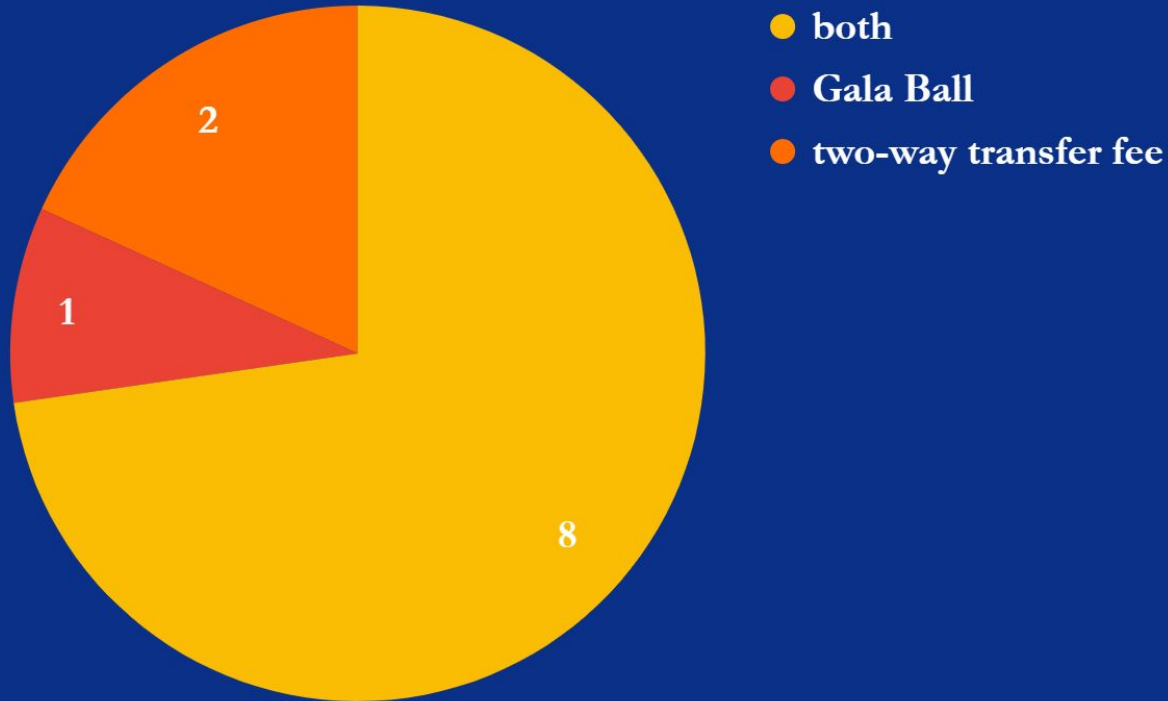

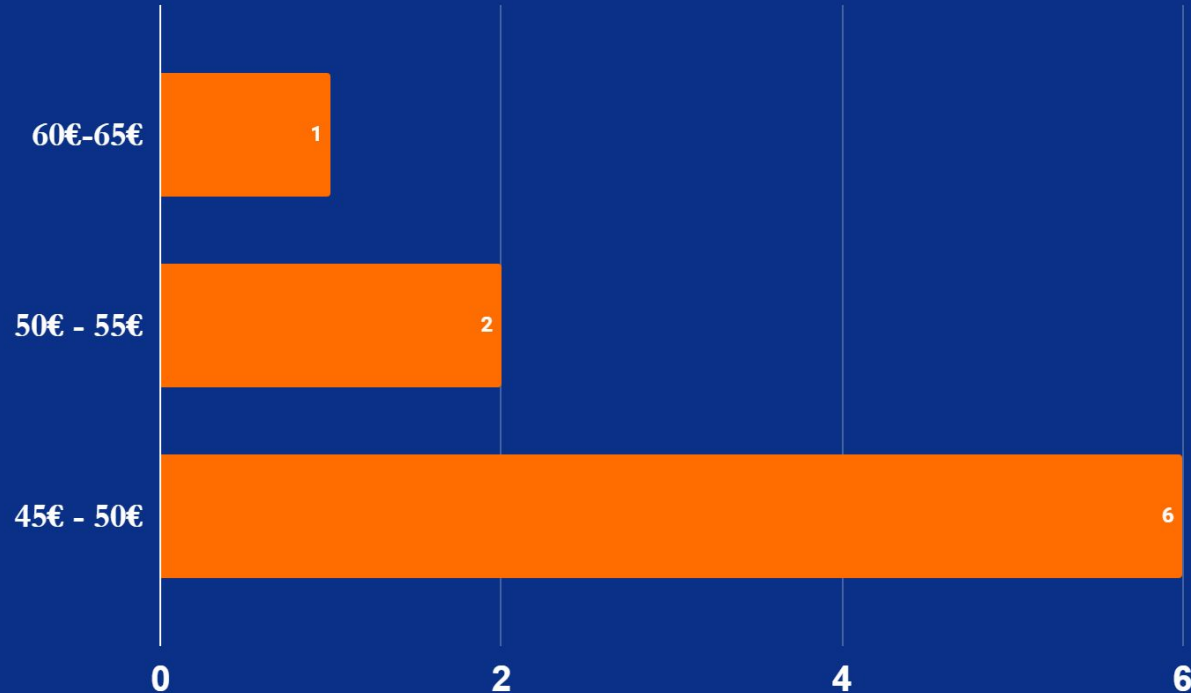
# 31. Do you believe that the maximum extra fees (Gala Ball and Two-way airport transfer fee) should be changed?
