18 September 2023	Competition Launch via Website ELSA International officially launches the Competition, by publishing relevant documents on the Website of the John H. Jackson Moot Court Competition.	
20 September 2023	Release of the Registration form and the Case ELSA International releases the Case for the 22nd edition and opens the registration for the Competition.	
10 November 2023	 Team Registration Deadline To be eligible for participating in the competition, teams must register by the online Team Registration Form on the Website and pay the Registration Fee. The deadline for submission of the electronic Team Registration Forms is 23:59 Central European Time. ELSA will provide each registered team with a team number by email which must be used for all further communication. Late registration is only possible upon request to ELSA International.
