Deadline	Activity
16 September 2024	<p>Competition Launch via Website ELSA International officially launches the Competition, by publishing relevant documents on the Website of the John H. Jackson Moot Court Competition.</p>
	<p>Release of the Registration form and the Case ELSA International releases the Case for the 23rd edition and opens the registration for the Competition.</p>
27 October 2024	<p>Team Registration Deadline</p> <ol style="list-style-type: none"> 1. To be eligible for participating in the competition, teams must register by the online Team Registration Form on the Website and pay the Registration Fee. 2. The deadline for submission of the electronic Team Registration Forms is 23:59 Central European Time. 3. ELSA will provide each registered team with a team number by email which must be used for all further communication. 4. Late registration is only possible upon request to ELSA International.
	<p>Deadline for Requests for Financial Aid Teams may ask for a partial or complete waiver of the Registration Fee, they need to submit a letter of motivation, a letter of recommendation and a curriculum vitae to director.jhjmcc@elsa.org.</p>
4 November 2024	<p>Clarification Question Deadline Final date for each Team to send a maximum of 5 clarification questions to the John H. Jackson Moot Court Competition case, which must be sent to ELSA International via the Clarification Questions form on the Website of the John H. Jackson Moot Court Competition.</p>
21 November 2024	<p>Team Registration Fee Deadline</p> <ol style="list-style-type: none"> 1. Teams are required to pay the competition Registration Fee directly to ELSA. 2. Late payment of the Team Registration Fee is at the discretion of ELSA International. 3. ELSA will send an invoice for Team Registration Fee to the nominated Team Contact Person on the Team Registration Form. 4. In any case, late payment is only possible upon request to ELSA International.
28 November 2024	<p>Regional Rounds Allocation List ELSA will publish an “Allocation List” detailing the Teams (by Team Number) participating in each Regional Round.</p>

9 January 2025	Written Submission Deadline 1. Deadline for registered Teams to dispatch electronic copies of the Written Submissions via the Written Submissions Form . 2. The deadline for dispatch shall be 23:59 Central European Time and sent via the relevant form on the Website.	
28 February - 3 March 2025	East Asia & Oceania Regional Round, Phnom Penh, Cambodia	Regional Rounds Each Team participates in one Regional Round. The official dates will be published on the website of the Competition.
7 - 10 March 2025	West & South Asia Regional Round, Jodhpur, India	
(18 - 21 March 2025)	All-American Regional Round, dates and location to be confirmed	
15 - 18 April 2025	1st European Regional Round, Istanbul, Türkiye	
23 - 26 April 2025	African Regional Round, Nairobi, Kenya	
29 April - 2 May 2025	2nd European Regional Round, Amsterdam, the Netherlands	
May 2025	Announcement of finalists The official announcement of the 24 Teams that have been selected to plead in the Final Oral Round.	
10 - 14 June 2025	Final Oral Round, Geneva Lasting 5 days, consisting of Preliminary Rounds, Quarter Finals and Semi Finals and the Grand Final. The Quarter Finals, Semi Finals and the Grand Final of the Competition will happen at the WTO headquarters in Geneva, Switzerland.
