FOREWORD

Dear colleagues and friends,

It is with a tinge of sadness that we close this 20th edition of the John H. Jackson Moot Court Competition on WTO Law. Being case author was a great adventure, challenging us to think in new ways, work with new colleagues and learn new skills.

Our goal when drafting the case was to write a case with enough depth so that students, coaches and panellists could have fun exploring it further at each stage of the competition, while still keeping it to no more than three claims in total. We also wanted to set the case in a broader political and economic context so that students understand that international economic law is not only about applying the rules to the facts but also reflecting as to why the rules are or should be in a certain way. Furthermore, we hoped to give students both legal and factual questions to play with and explore, as being a lawyer is not only about legal interpretation but also about figuring out what to do with the facts at hand. In this regard, we liked the idea of a shorter narrative part supplemented with several annexes.

From a factual point of view, the case was inspired by recent developments regarding the increased cross-border movement of both firms and subsidies between countries, which has caught the attention of governments in developed countries. The case also focused on measures adopted by developing countries to foster their downstream and value added industries in order to avoid the exportation of raw materials. Finally, the case addressed the shift towards the production of more environmentally friendly goods, which is often tied up with the preceding two developments. From a legal perspective, we drew inspiration from trade defence investigations initiated by the European Commission regarding cross-border subsidies and from WTO disputes on unwritten measures and export restrictions such as Russia - Railway Equipment and China – Raw Materials.

Thank you for participating in this year's competition as students, coaches, panelists, members of ELSA or members of the academic board. We remain immensely grateful to everyone who made this year's moot a success. We hope you had as much fun pleading and discovering the case as we had writing it and take with you many fond memories.

We look forward to meeting you again in the course of the next editions of the competition!

I. ABOUT THE COMPETITION

The John H. Jackson Moot Court Competition was founded in 2002 by European Law Students' Association with the help of the World Trade Organization. Previously called the ELSA Moot Court Competition, this competition focuses on the simulated hearing of the World Trade Organization dispute settlement system. After 20 years, what started as a European students' initiative, had now become a broadly international and critical element in training future trade lawyers. The John H. Jackson Moot Court Competition developed from being a European Competition for ELSA Members to a global challenge that gathers students from all around the world every year, with 6 Regional Rounds organised across the globe.

The John H. Jackson Moot Court Competition consists of three phases. First, the teams must deliver Written Submissions on the issued Case for both parties of the dispute – Complainant and Respondent. Secondly, the teams have to participate in one of the Regional Rounds and plead as a Complainant and Respondent in front of the Panel, full of experts and professionals in the area. Lastly, the 4 best teams from all the Regional Rounds qualify for the Final Oral Round, held in Geneva, Switzerland.

In the Academic Year 2021/2022, ELSA organised the 20th edition of the Jackson Moot. The Competition was launched on 15 September 2021 with the publication of the Case written by Mr Victor Crochet, associate at Van Bael & Bellis (the platinum sponsor) and Mr Marcus Gustafsson, member of the Legal Service of the European Commission.

One team per university or faculty could register 2-4 members until the first of December 2021. In total, 81 teams registered until that deadline and were asked to send their Written Submissions. From these 81 teams, a final number of 73 teams participated.

From February on, we were forced to organise all Regional Rounds in an online format due to the COVID-19 pandemic. These rounds were all organised on the platform Coderblock. A 3D-online simulation platform, where participants could come closer to all the people involved via a fully virtual environment. Due to the still ongoing international conflict between Ukraine and Russia, where the Russian Federation committed acts of aggression against Ukraine, we were forced to postpone two of the online Regional Rounds to the end of April to assess the situation and see in which ways we could aid the Ukrainian participants in the competition.

Finally, between the 28th of June and the 2nd of July, after more than two years online, we hosted the Final Oral Round of the Jackson Moot again physically in Geneva. Here we invited 24 teams from all over the world. At ELSA, we were very glad to extend Financial Support to both teams from Ukraine and all African participants. All teams had to participate in the Preliminary Rounds (hosted this year at the University of Geneva) and the best 8 teams continued to the Elimination Rounds (hosted by the WTO) to conclude with the Grand Final between the University of Zurich (Switzerland) and the Catholic University of Leuven (KULeuven - Belgium) in Room W at the WTO. I want to again extend my congratulations to the University of Zurich for winning the 20th edition of the Jackson Moot.

III. WRITTEN SUBMISSIONS

Written Submissions are the first stage of the Competition. The teams need to draft two Written submissions each, one on behalf of the Complainant and one on behalf of the Respondent. Two independent trade law experts assess the quality of submissions. The Written Submissions were scored on the following criteria:

ANALYSIS OF LEGAL ISSUES

- On the application of the SPS Agreement (3 points);
- On the claims under the SPS Agreement (15 points);
- On the claims under GATT 1994 (12 points).

ARGUMENTATION AND WRITING STYLE

- Structure, organisation, and weighting of arguments (5 points);
- Creativity of argumentation (5 points);
- Clarity and tone of written expression (5 points);
- Correct use of legal terminology, grammar, spelling, and citation (5 points).

Each team could receive a maximum of 50 points for each Written Submission. After receiving the scores of both Written Submissions, these were averaged and used in the Preliminary Rounds of each Regional Round and the Final Oral Round.

IV. REGIONAL ROUNDS

The Regional Rounds are the second stage of the Competition. In this edition, there were six Regional Rounds organised virtually on the platform Coderblock. The Regional Rounds consisted of two Preliminary days, the Semi-Finals on the third day and Grand Final on the last day. The teams were scored on the following criteria, the panellists having important freedom regarding their appreciation of the scores. The teams' scores are the average scoring of the panellists present during that round.
