# ELSA LAW SCHOOLS SELECTION GUIDELINES

## **Foreword**

Winter and Summer ELSA Law Schools are among the Flagship Projects of ELSA, and their preparation necessitates both extensive logistical work, and a meticulously executed selection process for participants. To assist in this selection, the ELSA Law Schools Team developed a ranking system designed to aid Organising Committees make informed decisions regarding the selection of their Participants. This ranking system is **non-binding** and aims to serve solely as a **guideline**.

Based on this system, Applicants are graded on a scale from 1 to 7 in three distinct categories, each with a different value. The three categories are as follows and they should represent the following percentages of the final score:

- The Curriculum Vitae (CV) 30%;
- The Motivation Letter 35%;
- Appreciation of the Organising Committee 35%.

After grading the Applicants, the ELSA Law Schools Team recommends ranking them. The Organising Committee is then advised to consider diversity goals for the respective ELSA Law School. The Organising Committee should consider putting high-ranked but not accepted Applicants on the waiting list.

# **Additional Factors to consider**

## **Diversity of Participants**

After grading the Applicants, the ELSA Law Schools Team recommends ranking them. The Organising Committee is then advised to consider diversity goals for the respective ELSA Law School. It is recommended to strive for diversity in gender, nationality/country of residence, age, and membership status when finalising the rankings. The Organising Committee should consider putting high-ranked but not accepted Applicants on the waiting list.

# Complexity of the academic programme of the ELSA Law School

When evaluating the Applicants' CV, the complexity of the academic programme should be regarded. If the ELSA Law School has an Introductory complexity of the academic programme, less previous knowledge of the relevant topic is required than if the ELSA Law School has an Advanced complexity of the academic programme. The complexity of the academic programme is to be considered when determining whether the Applicant has the necessary professional and/or academic background to actively participate in the academic programme of the ELSA Law School.

## Use of Al

If the Organising Committee identifies that the Motivation Letter is mostly written by AI, they may deduct 2-3 points from the score assigned in the "Motivation Letter" category.



# **Example of an Applicant Evaluation**

Applicant A has attached a High Level CV, which contains a relevant educational and professional background for the respective ELSA Law School (e.g. Maritime Law - and the Applicant is taking a master's programme in this topic), with various extracurricular activities (more than two) linked to the topic of the ELSA Law School (e.g. two seminars on Maritime Law as well as a Webinar). Attached a Motivation Letter with an "Insufficient Level of Motivation", which, while expressing the Applicant's interest in the ELSA Law School, provides a vague interest of the Applicant in the topic, academic, or social programme: "I am looking forward to your ELSA Law School ELSA Land on Maritime Law. I am excited for the social and academic programme.", without providing further details that demonstrate a genuine understanding or excitement for the programme. The Applicant wrote both the CV and the Motivation Letter in proficient English, has attended multiple ELSA events related to the topic of the ELSA Law School (Maritime Law), organised an ELSA Law School, and was an ELSA Officer.

## Applicant A score:

0.30\*6 (High Level CV) + 0.35\*3 (Insufficient Level of Motivation) + 0.35\*7 (Outstanding Level of Appreciation of Organising Committee) = 1.8 + 1.05 + 2.45
