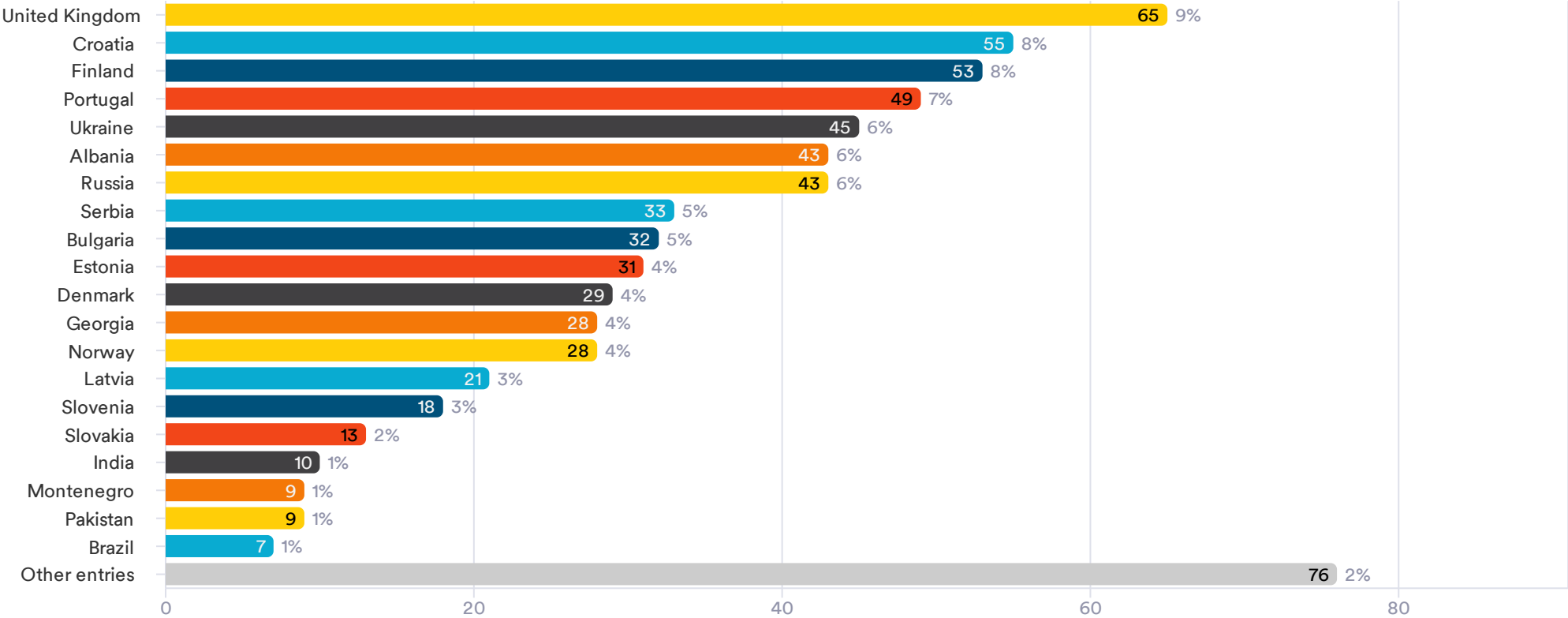

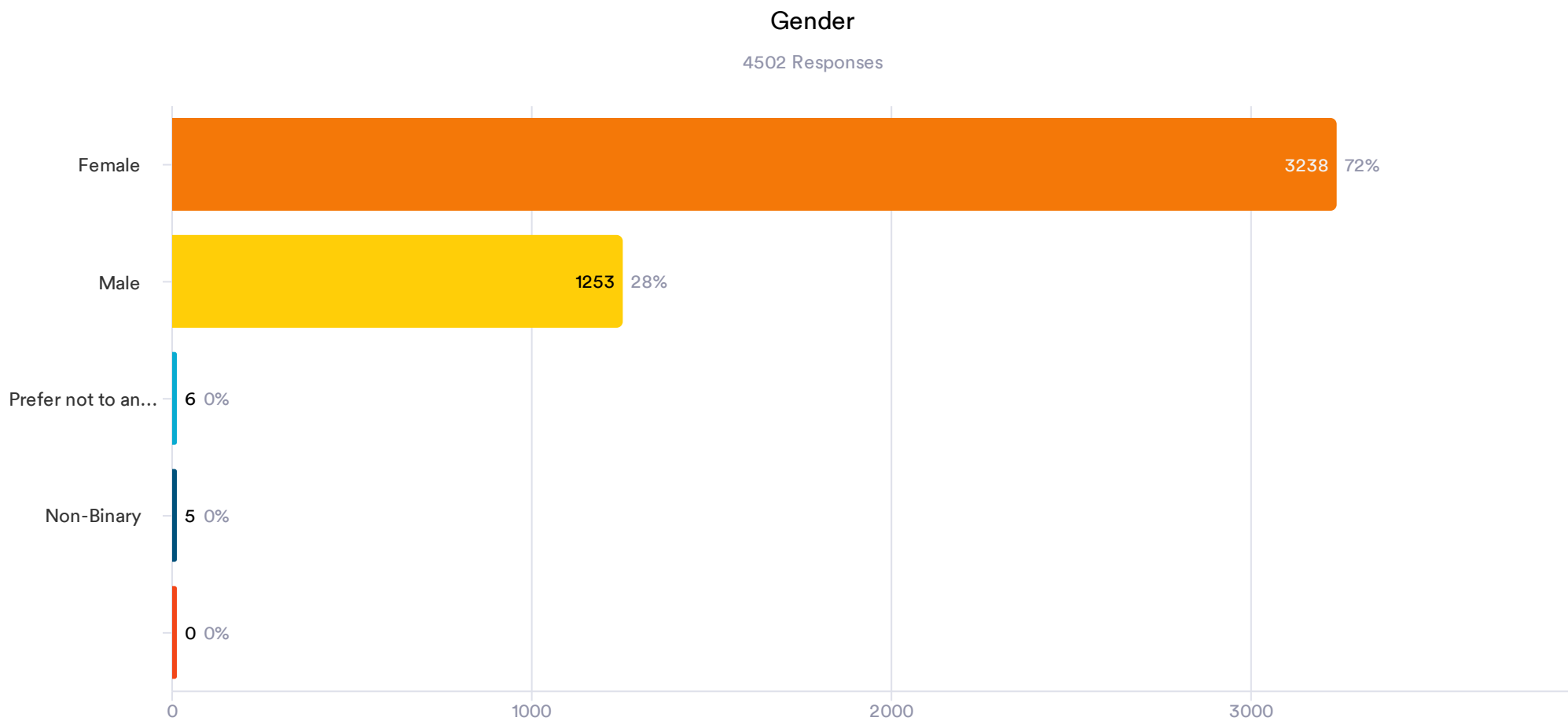

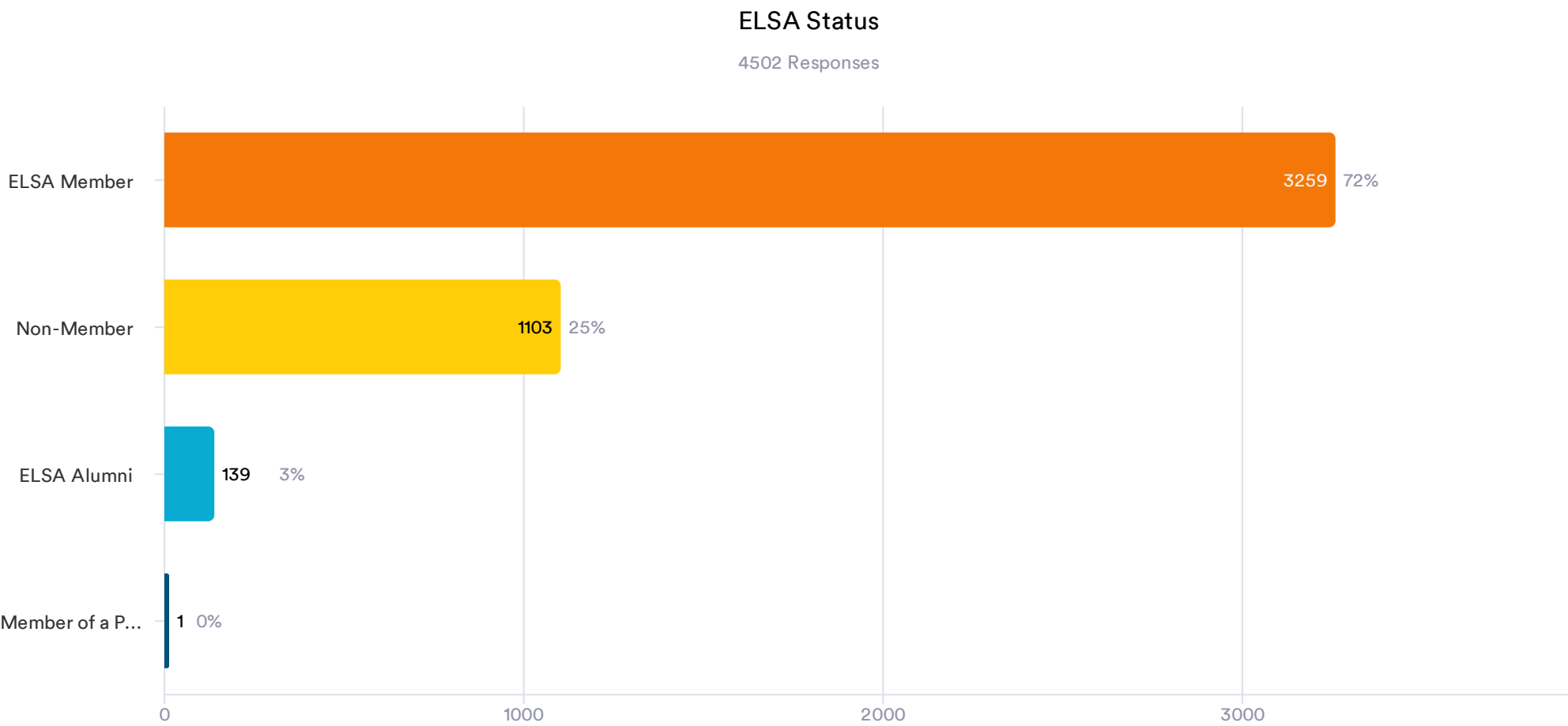

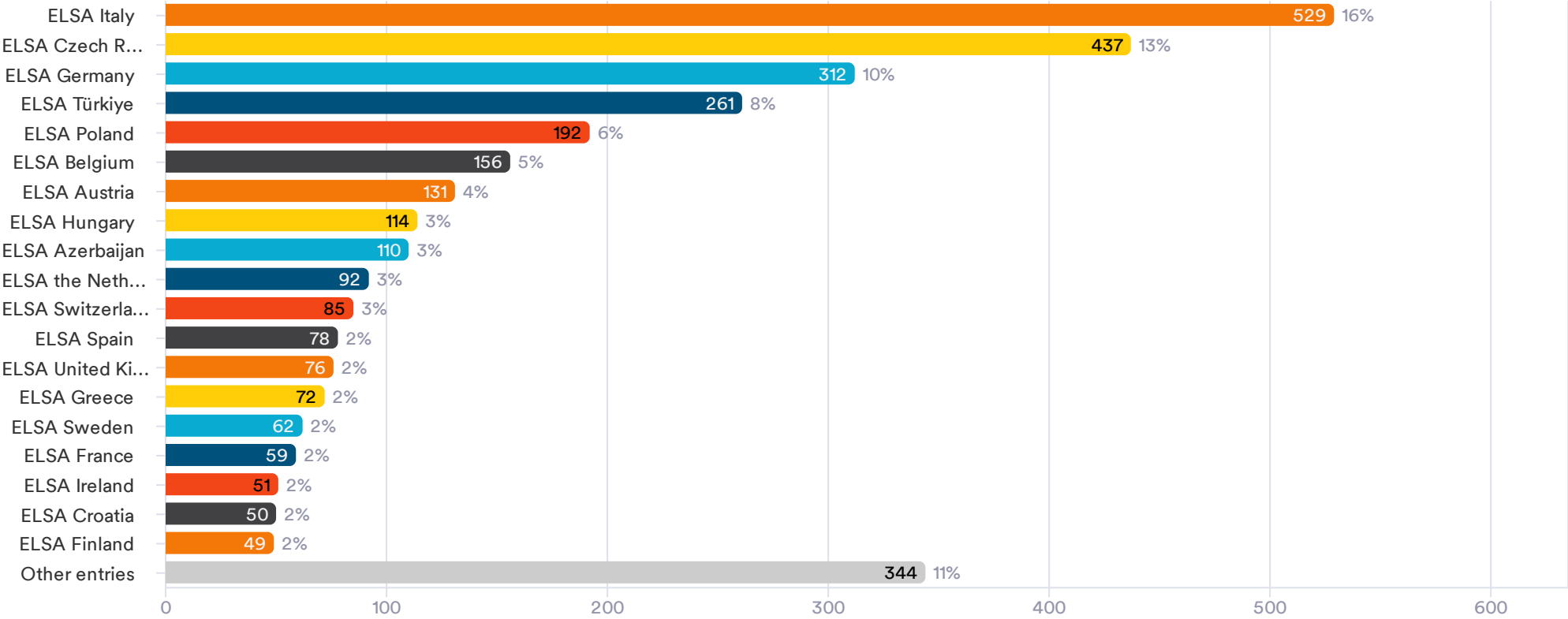

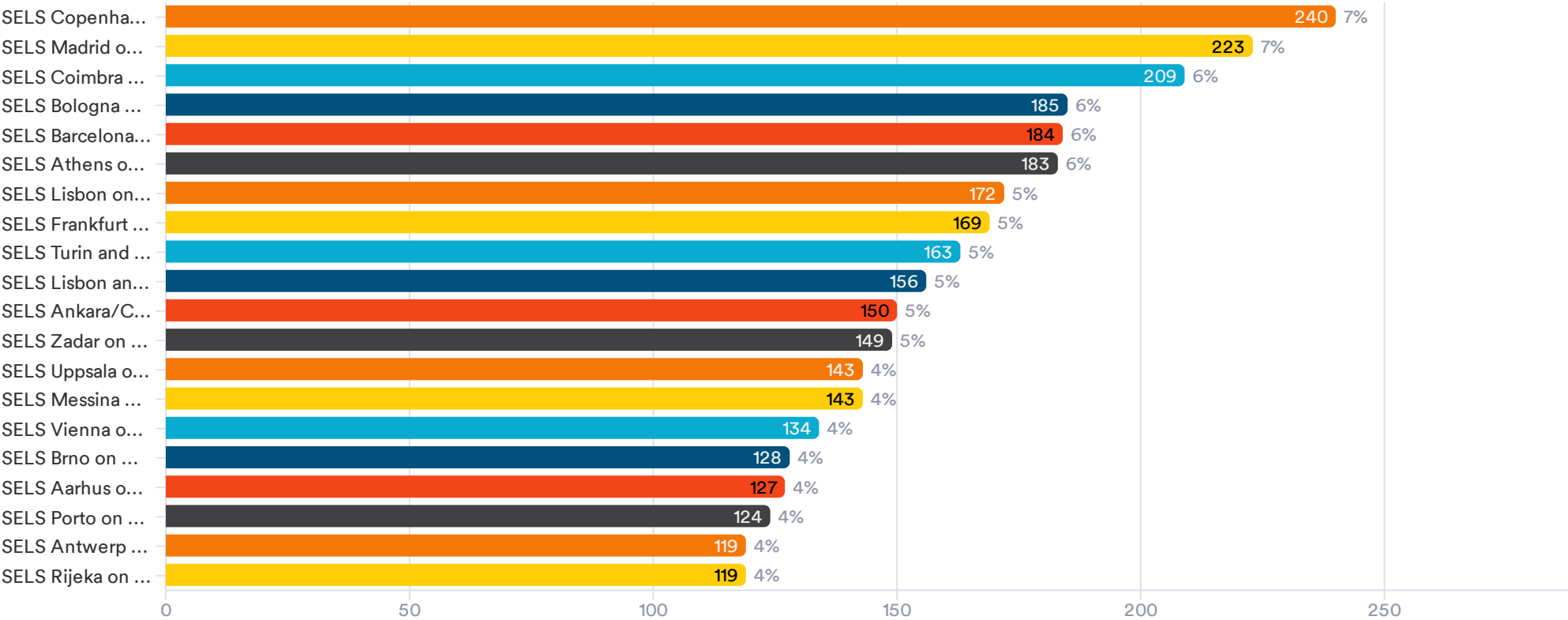

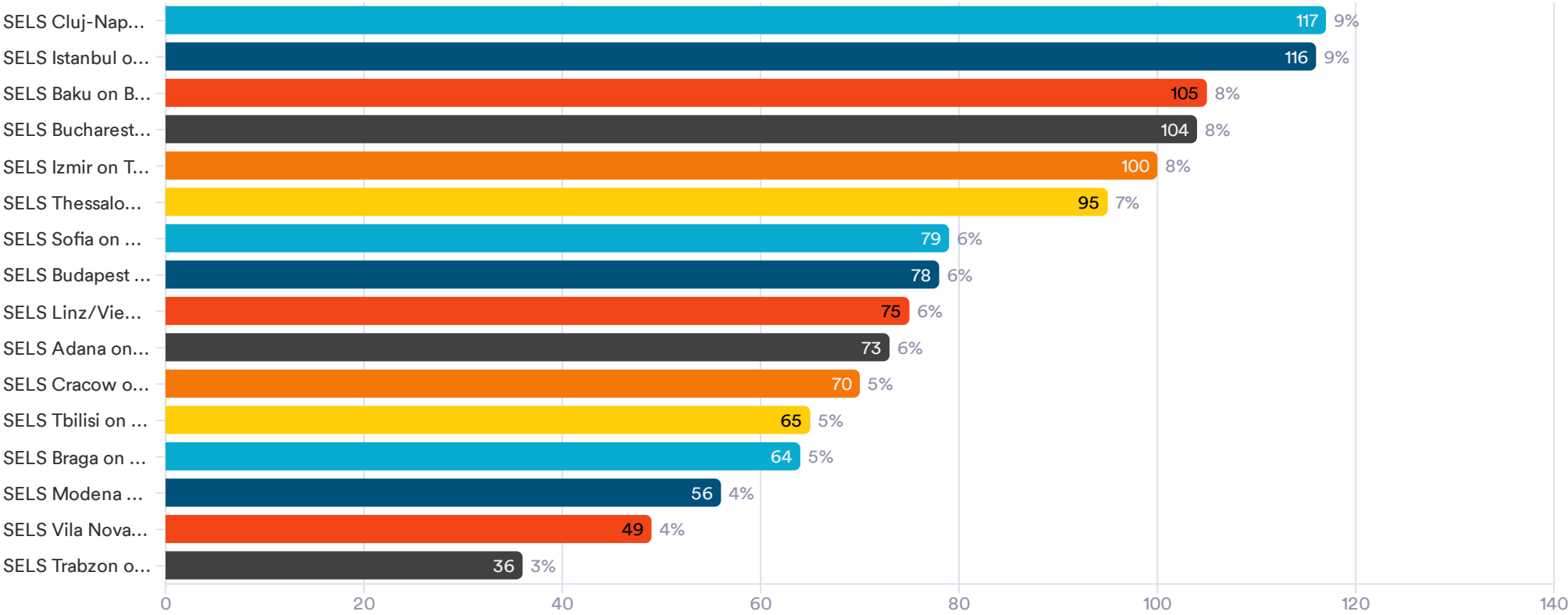
Choose the ELSA Law School you are applying to

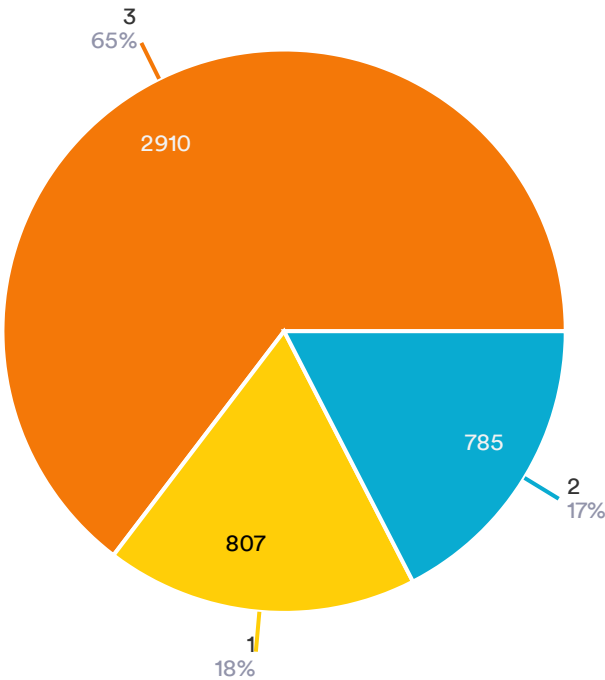

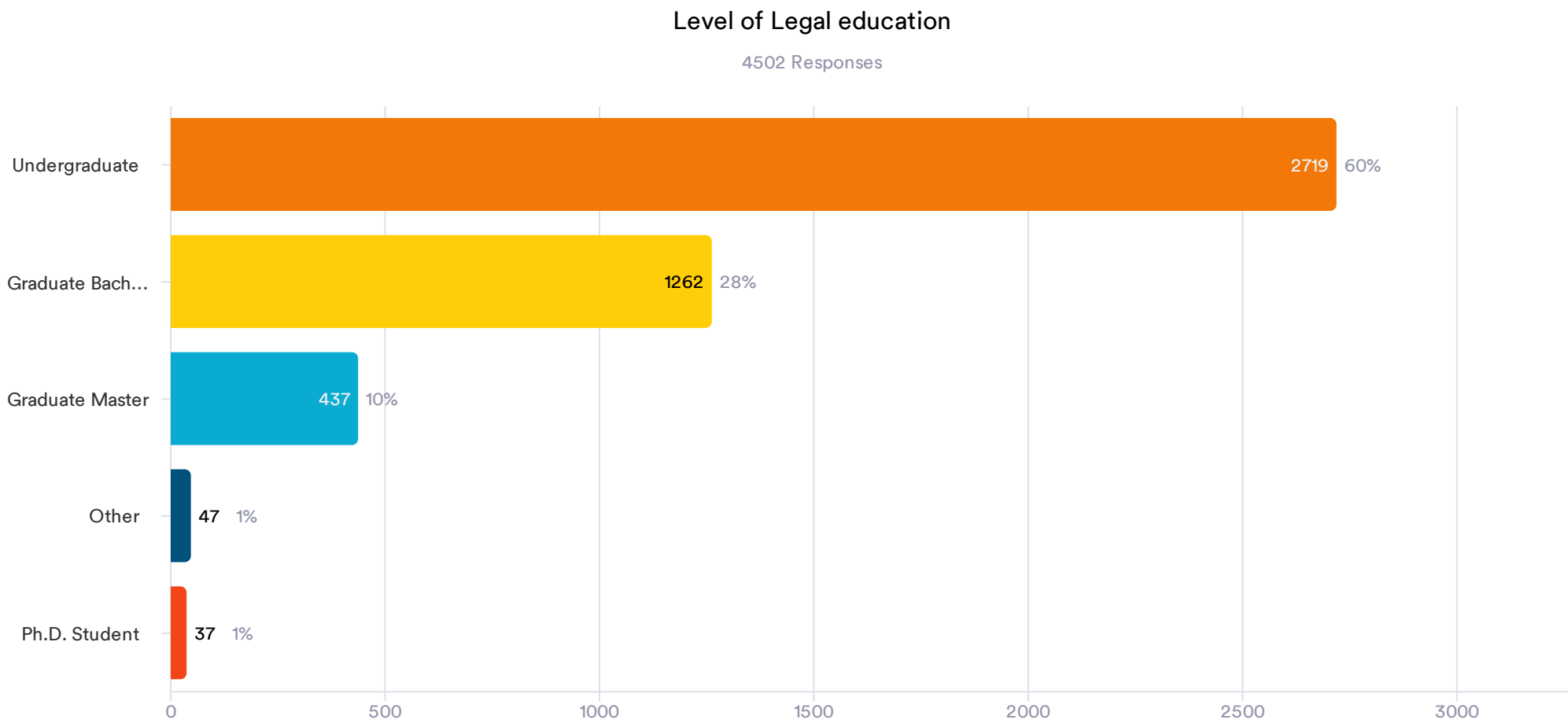

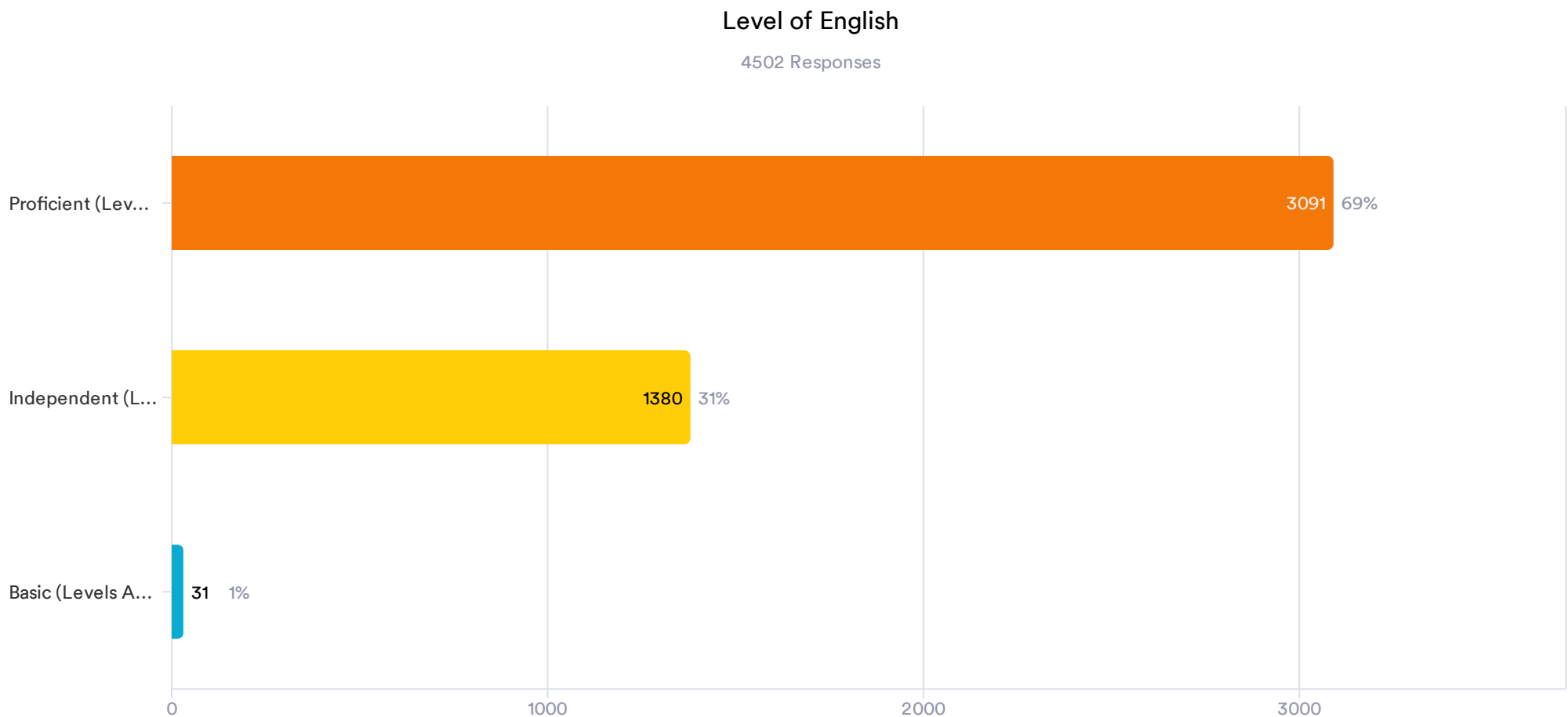


For how many ELSA Law Schools are you applying during this application period?

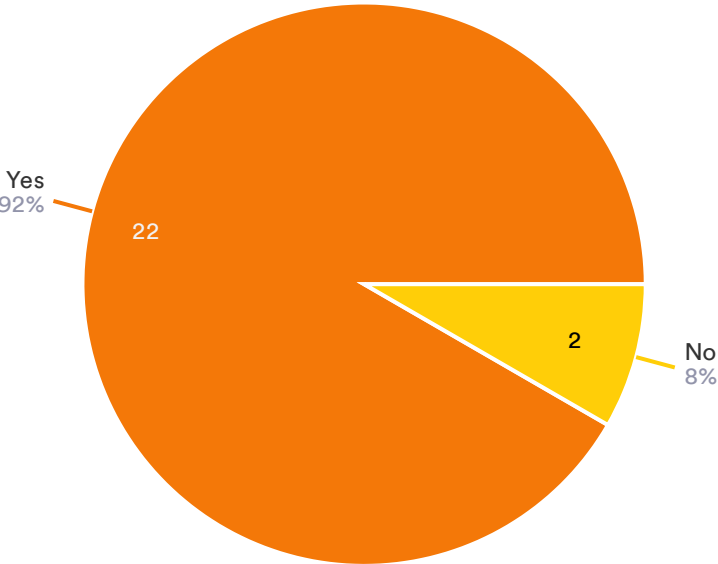

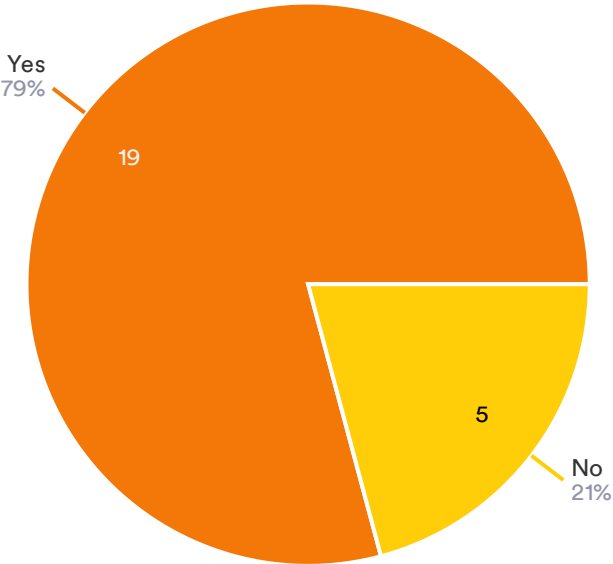
Do you plan to organise an ELSA Law School next year?

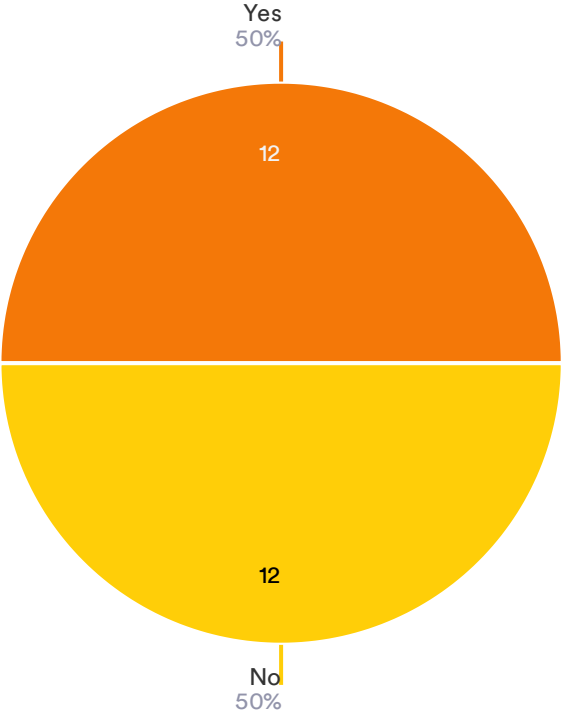
Do you plan to keep the same subject for the ELSA Law School?

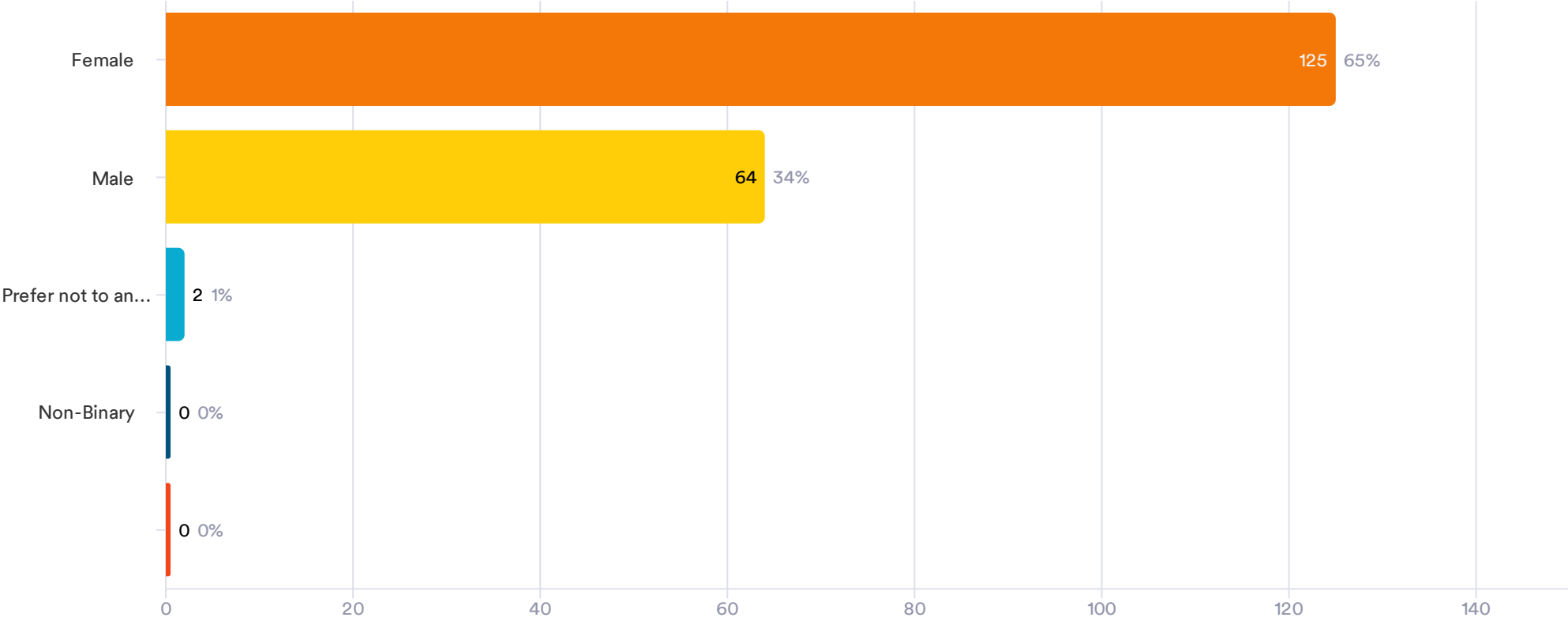

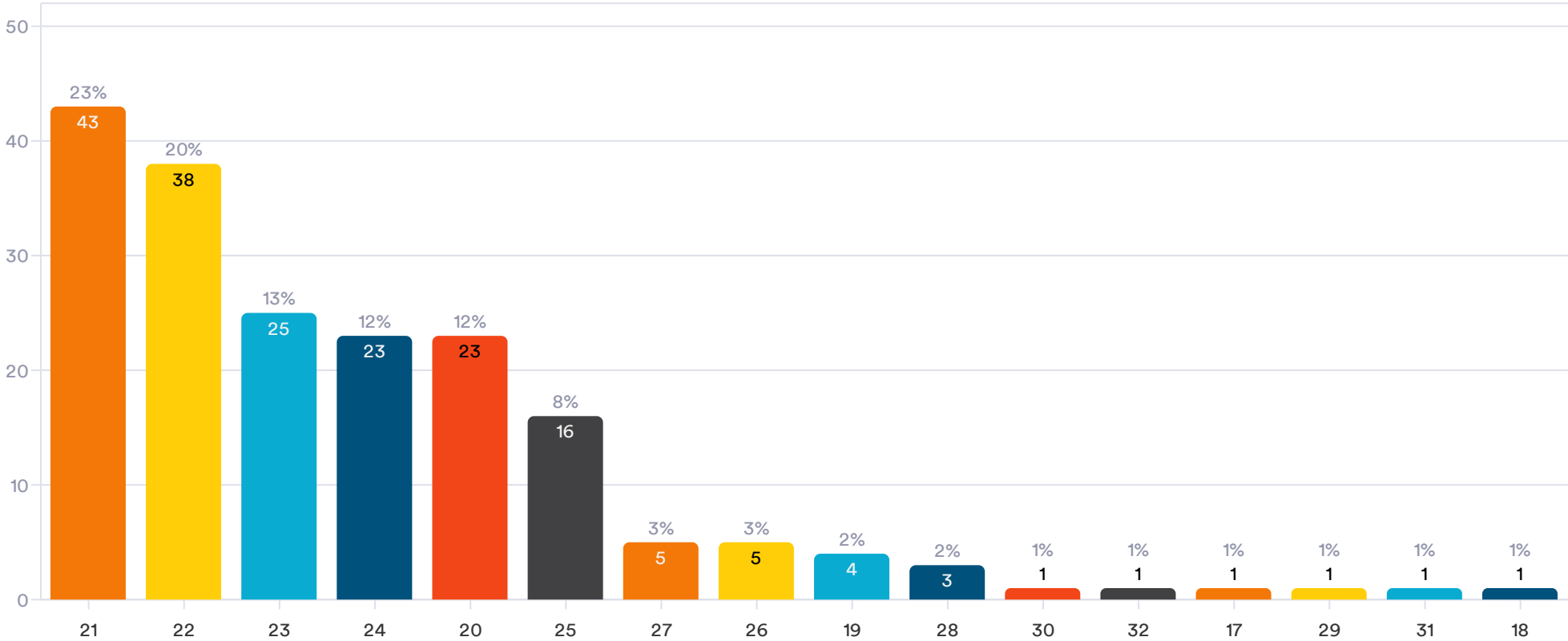

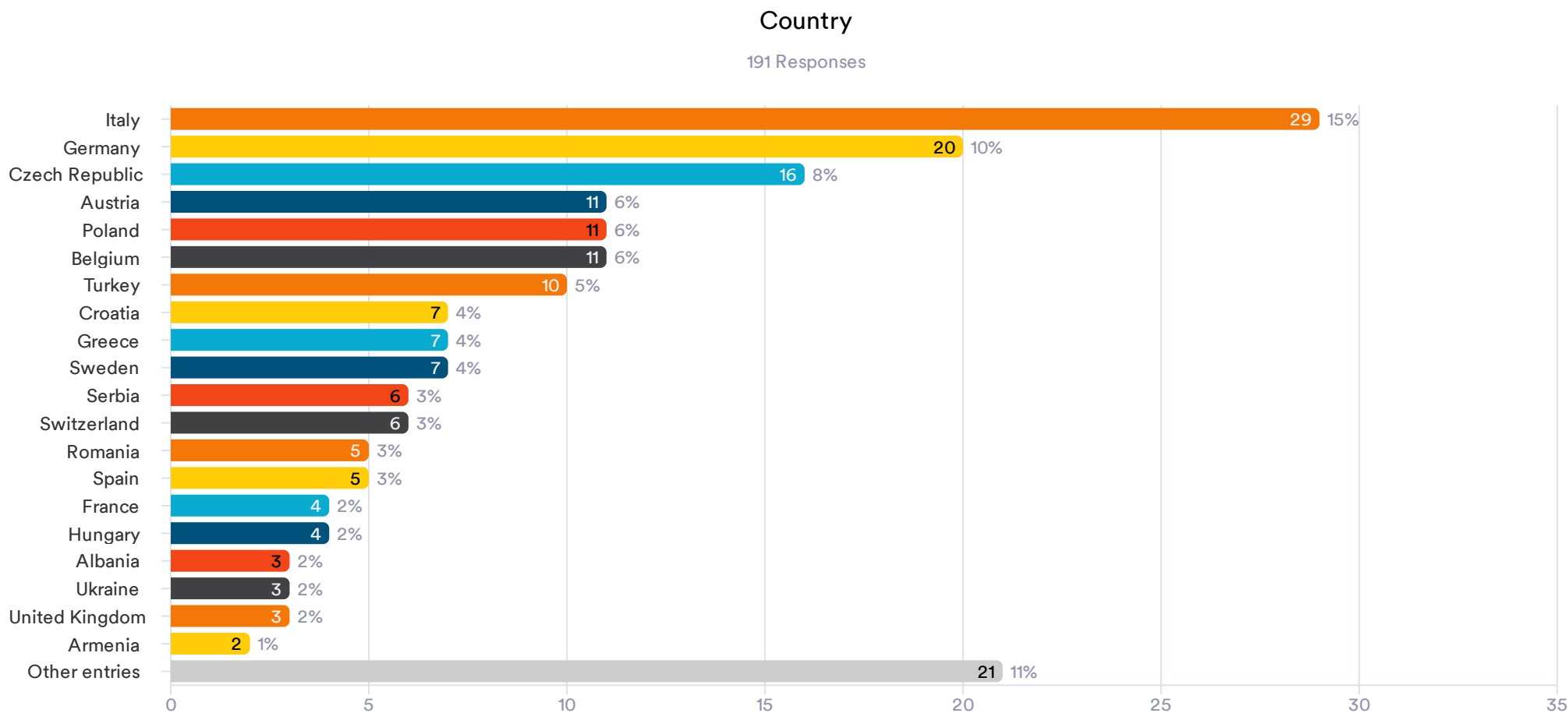

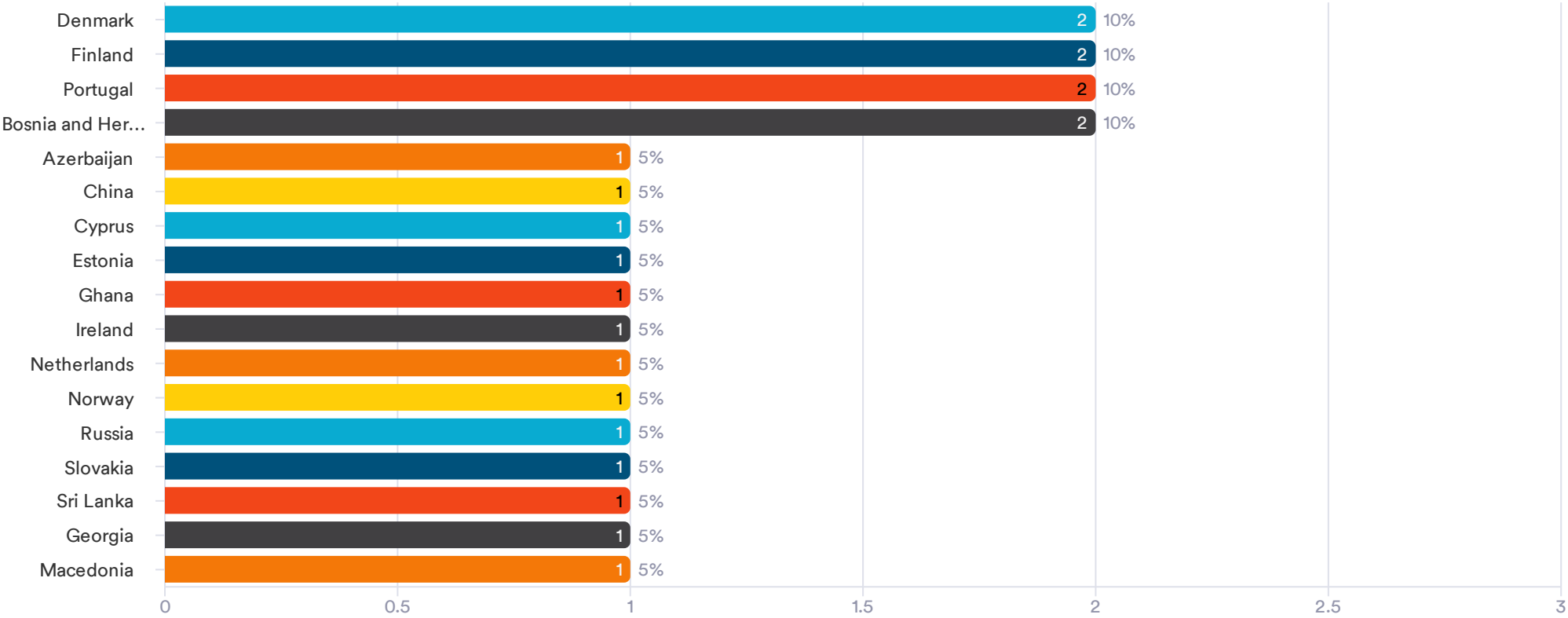

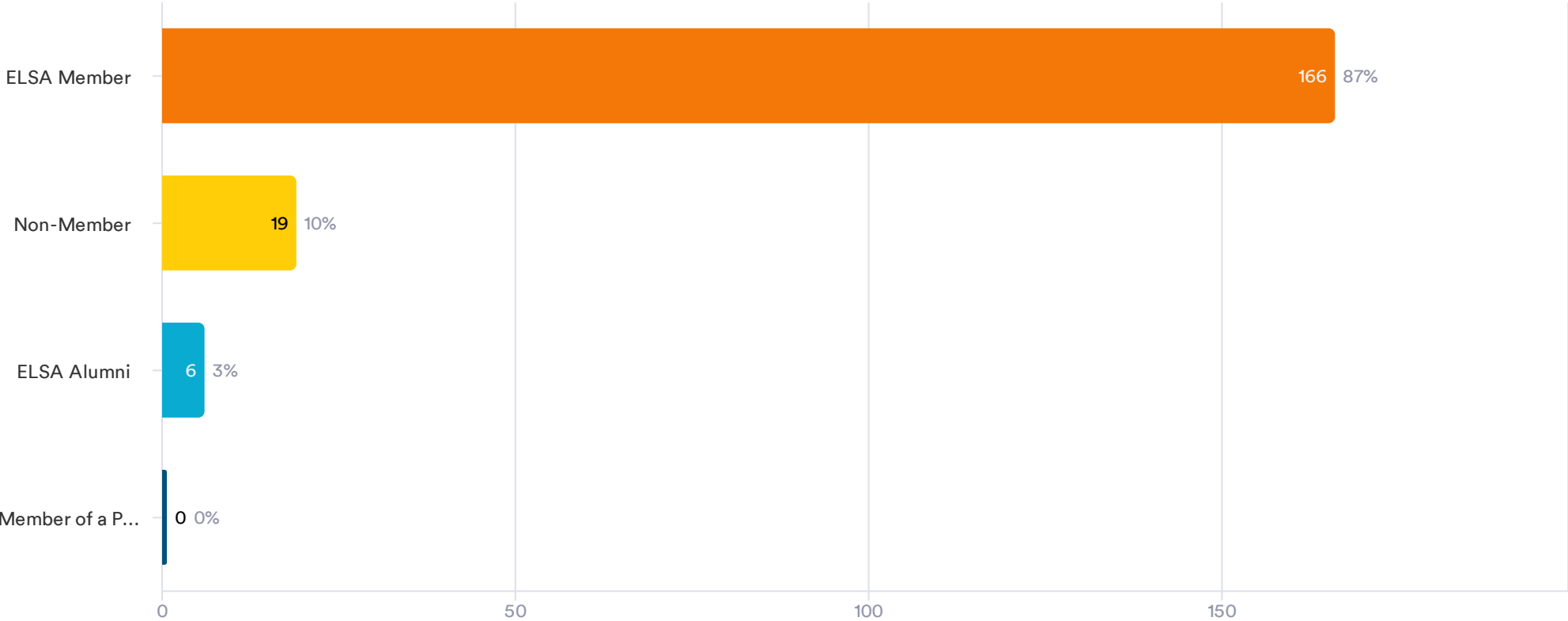

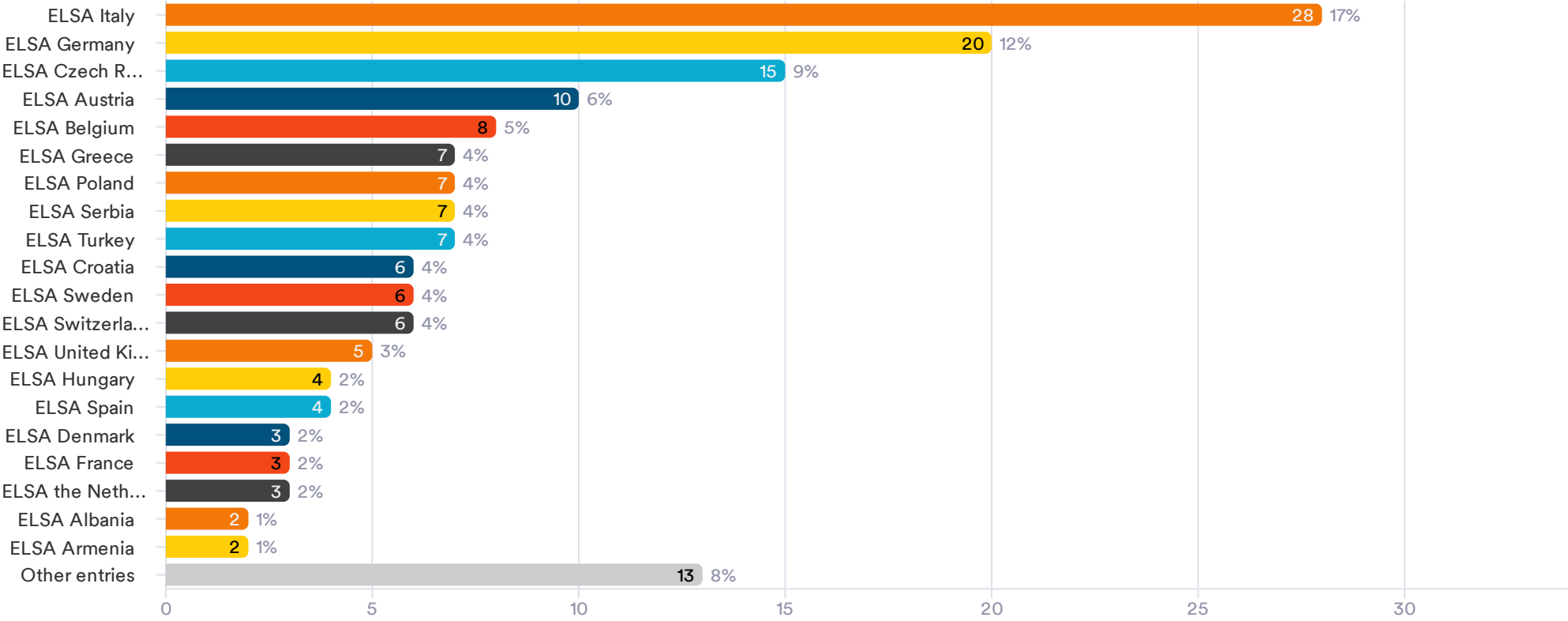

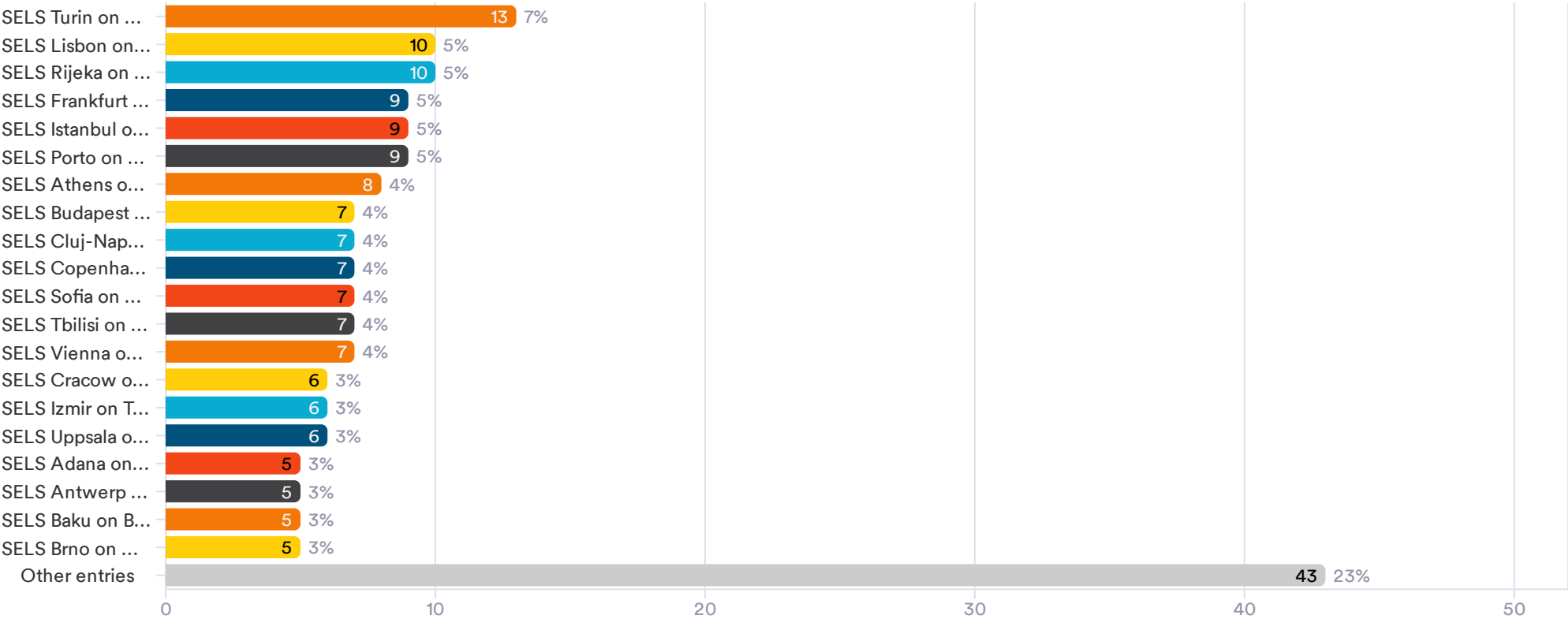

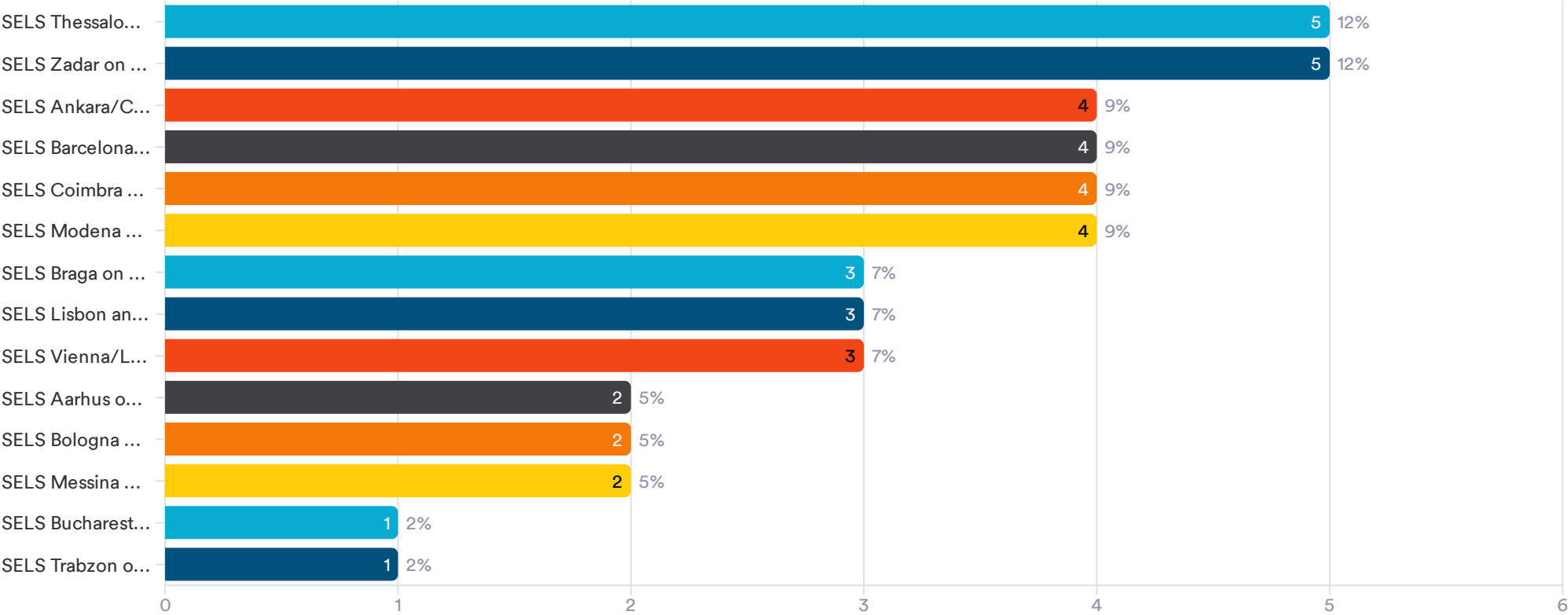

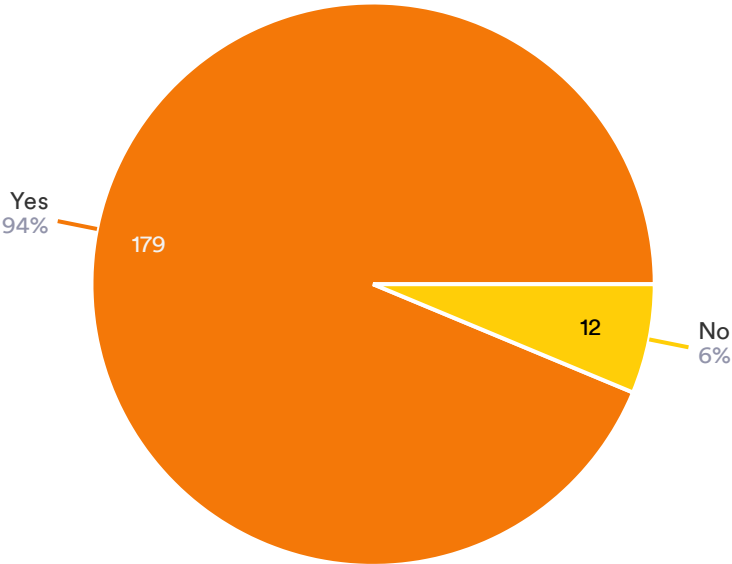

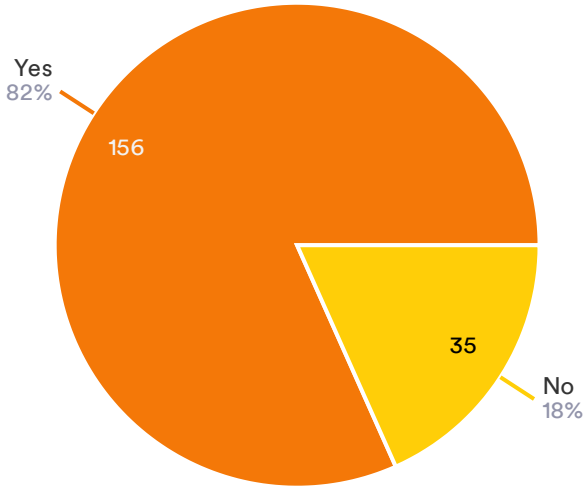
Would you recommend the ELSA Law School to your friends?

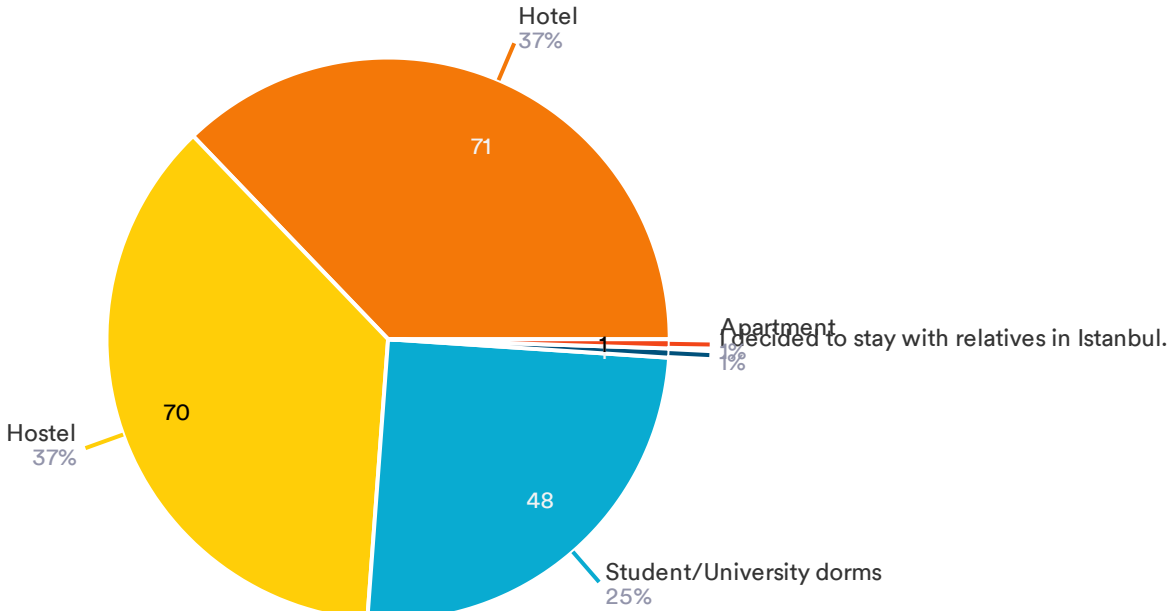

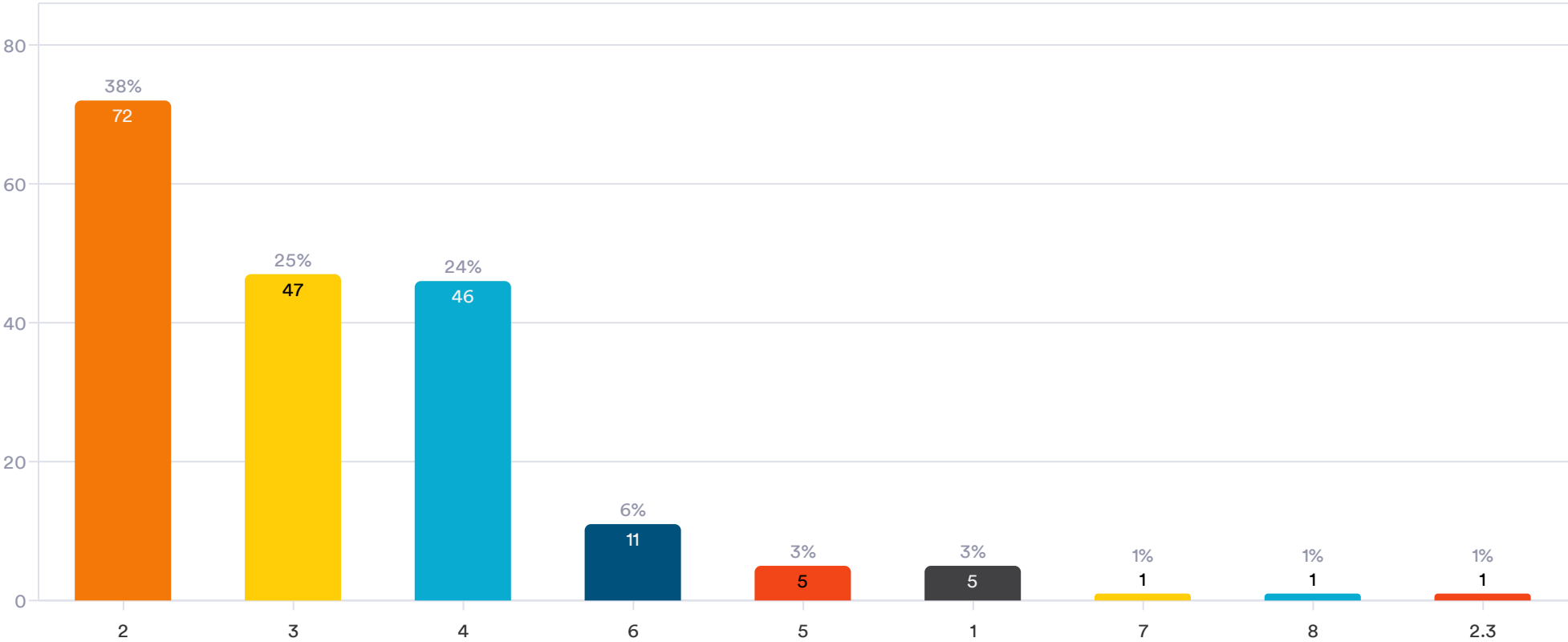
What type of accommodation did you stay in?

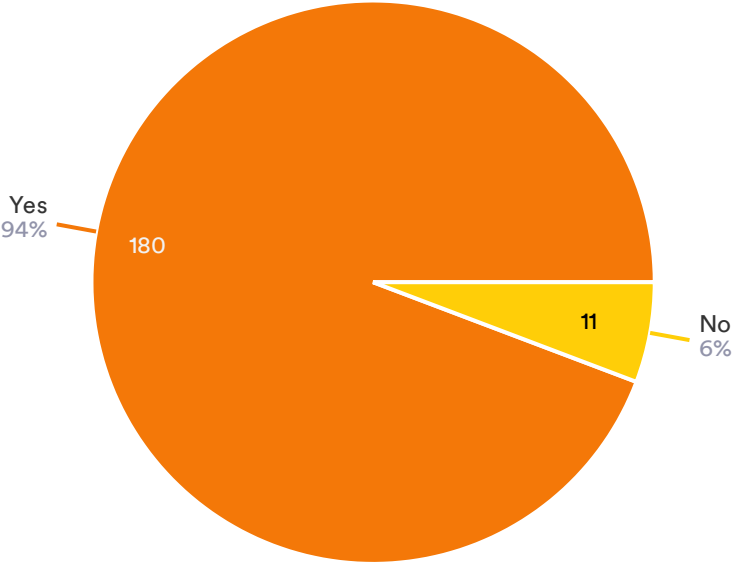

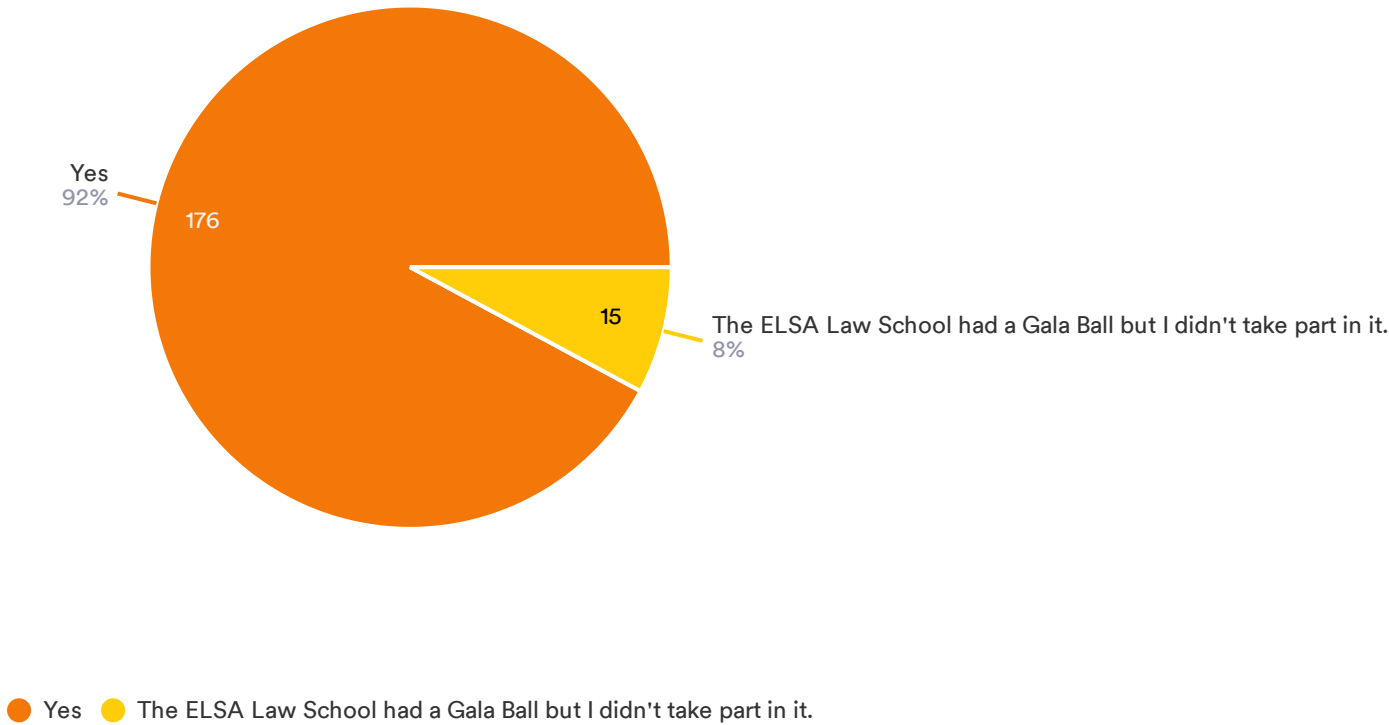

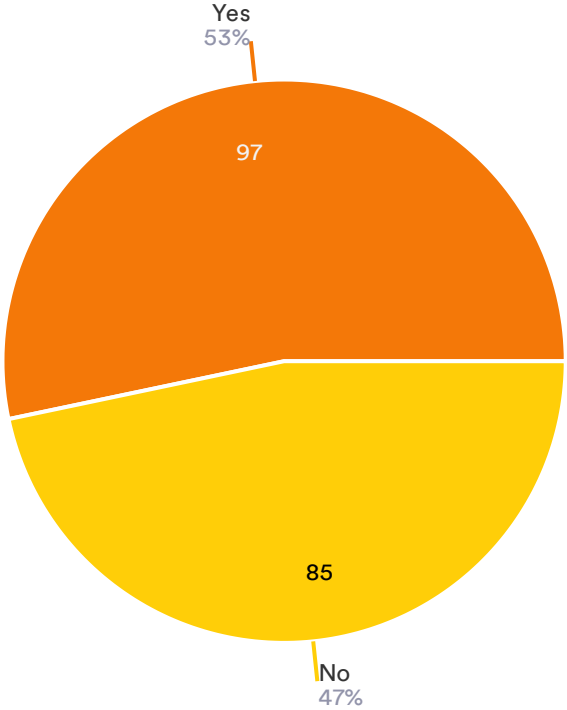

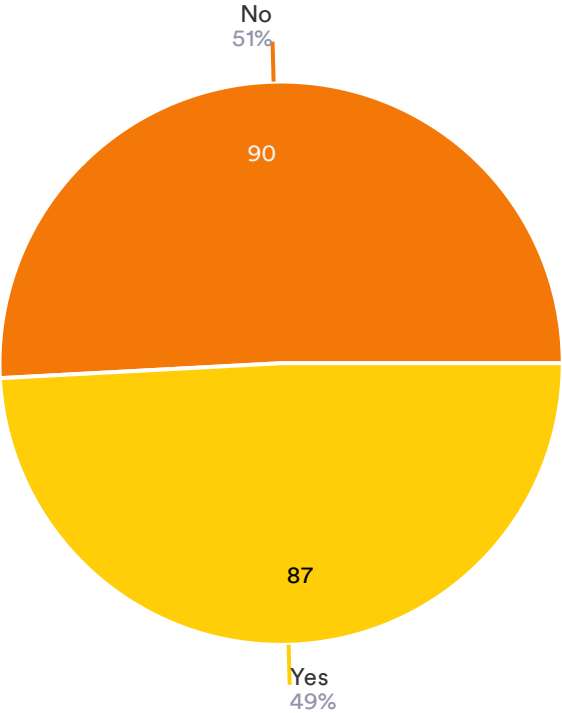
Was the Code of Conduct of ELSA Presented at the beginning of the ELSA Law School?

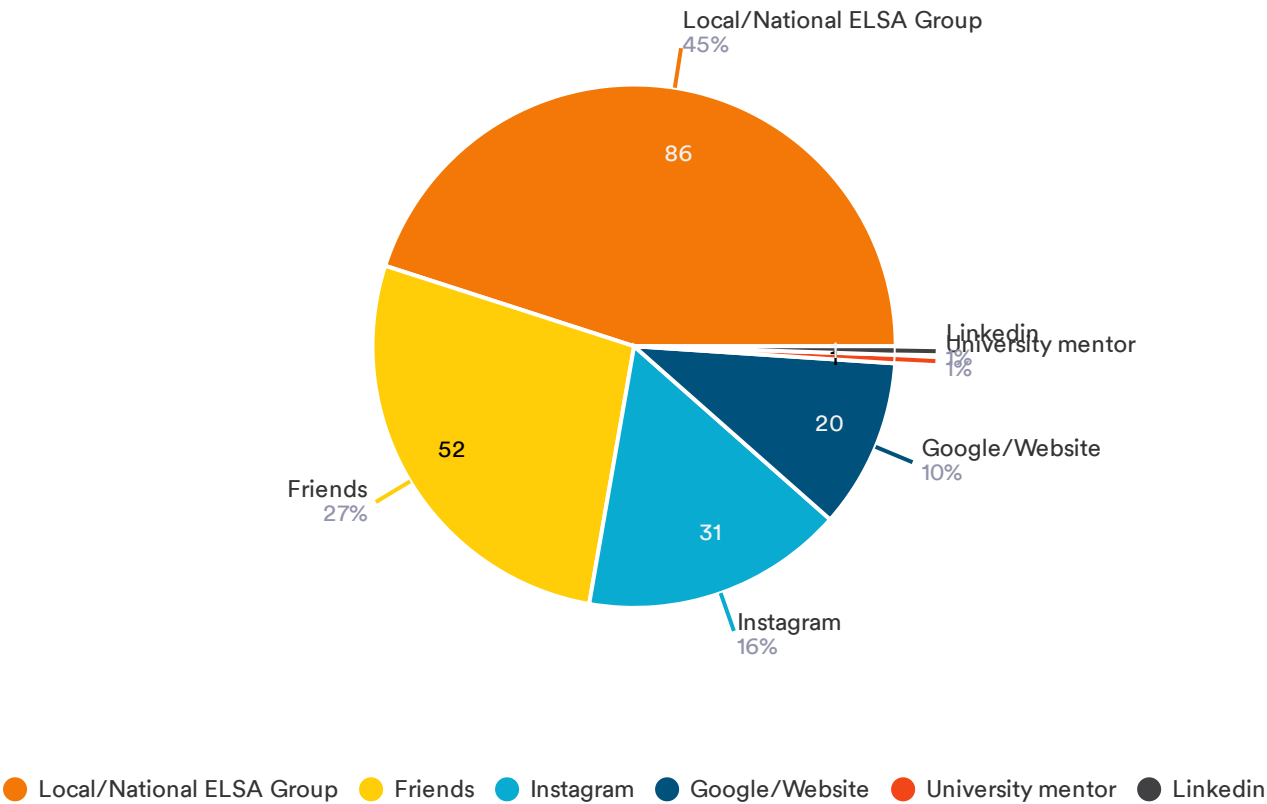
Was the specific Welfare Officer introduced to Participants during the ELSA Law School?

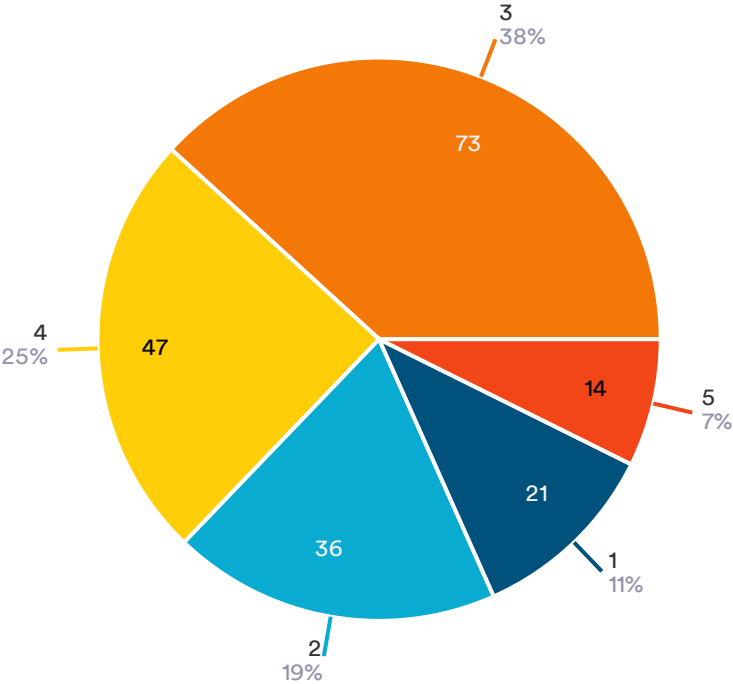
How did you find out about ELSA Law Schools?

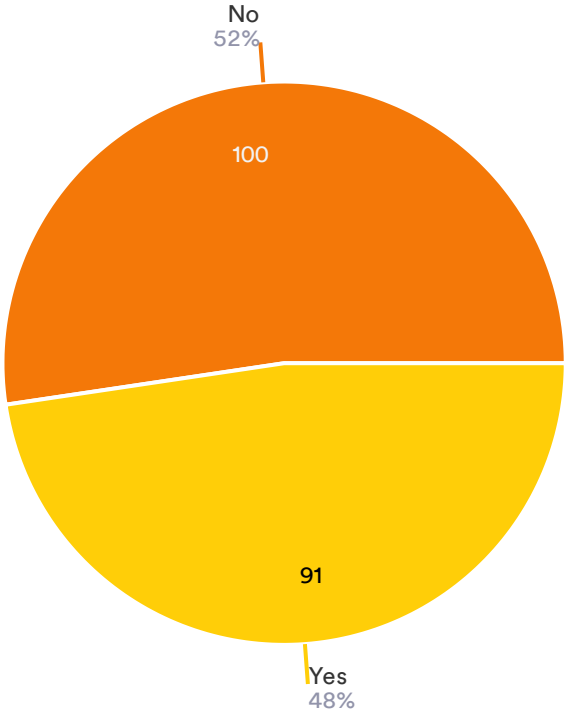
How decisive was the price of the Participation Fee as a factor in your decision to apply for ELSA Law Schools? (from 1 - 5)

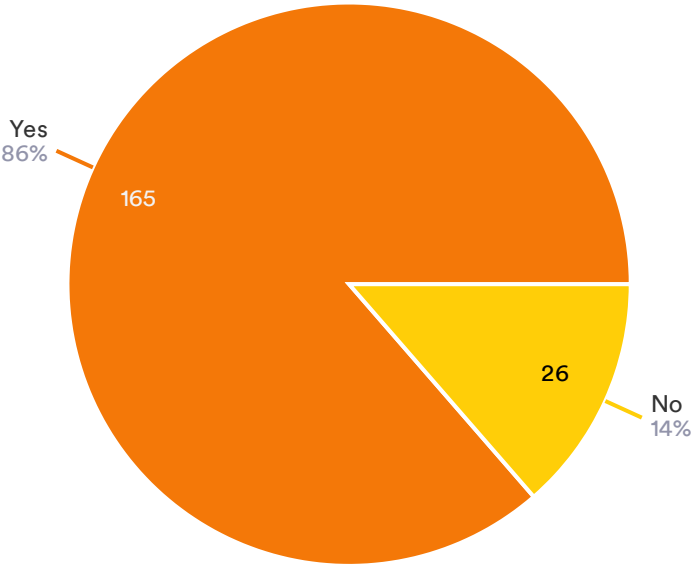
Would you have applied if the price would have been higher?
