




#### Summary of

The International Council voted in favour of removing Responsibilities of the OCs, and Quality Standards from the ELSA Law Schools chapter in the Decision Book. ### Annual Human Rights Campaign


The 9th ELSA Day on the 25th of November marked the beginning of the Annual Human Rights Campaign on Artificial Intelligence and Human Rights.
