

# Privacy Policy

Last updated: 14th of October 2022

## 1. Definitions

For the purposes of this Privacy Policy, the following terms shall have the following meaning:

**“ELSA”** refers to the European Law Students’ Association, Boulevard Général Jacques 239, Brussels B-1050, Belgium, and its members bound by the joint controllership agreement.

**“You”** refers to the individual accessing or using the Service and the Website, or the company, or other legal entity on behalf of which such individual is accessing or using the Service and the Website, as applicable.

**“Website Operator”** (referred to as either "Website Operator", “ELSA”, "We", "Us" or "Our" in this Agreement) refers to ELSA, who acts as the administrator, who can change, reconfigure or restrict the content of the Website.

**“Website”** refers to [webinars.elsa.org](https://webinars.elsa.org)

**“Service”** refers to paid and unpaid access to the products available on the Website, as well as any related services and marketing activities.

**“Personal Data”** is any information that relates to an identified or identifiable individual.

## 2. General

ELSA is committed to protecting your personal information and your right to privacy.

This Privacy Policy applies to all information collected through the Website, and/or any related services, sales, marketing or events.

We use your Personal Data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this Privacy Policy.

### 3. What information do we collect?

While using the Service, We may ask you to provide us with certain personally identifiable information that can be used to contact or identify You. Personally identifiable information may include, but is not limited to:

- Email address;
- First name and last name;
- Nationality;
- Age;
- Address;
- Professional status - student/graduate;
- Dietary restrictions and any other relevant medical information.

### 4. Use of Your Personal Data

Website Operator may use Personal Data for the following purposes:

- **To provide and maintain the Service**, including monitoring the usage of our Service.
- **For the performance of a contract:** the development, compliance and undertaking of the purchase contract for the products, items or services you have purchased or of any other contract with us through the Service.
- **To contact you** by email.
- **To attend and manage your requests to us.**
- **To create yearly statistics** from the usage of the website.

Under no circumstances do we sell or rent personal data to third parties, as well as share them with others for commercial purposes.

### 5. Retention of Your Personal Data

ELSA will retain your Personal Data for a period of one year. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

## 6. Transfer of Your Personal Data

Your information, including Personal Data, is processed at the Website Operator's offices and in any other places where the parties involved in the processing are located. This information may be transferred to — and maintained on — computers outside your state, province, country or other governmental jurisdiction where the data protection laws may differ from those from your jurisdiction.

Due to the international nature of our activities, your Personal Data could be stored and transferred to parties located in other countries, including those outside the European Economic Area. These other countries will either have different data protection laws than your country of residence, or they will not have data protection laws. They may not be deemed by the European Commission as providing adequate protection for Personal Data.

Your consent to this Privacy Policy, followed by your submission of such information, represents your agreement to that transfer.

ELSA will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy, and no transfer of your Personal Data will take place to an organisation or a country unless there are adequate controls in place, including the security of Your data and other personal information.

## 7. Disclosure of Your Personal Data

We may disclose your Personal Data to third parties:

- Who supplies services to us and who helps us for the purposes described in this Privacy Policy;
- If required to do so by law or in response to valid requests by public authorities;
- Protect and defend the rights or property of ELSA;
- Prevent or investigate possible wrongdoing in connection with the Service;
- Protect the personal safety of users of the Service or the public;
- Protect against legal liability.

## 8. Security of Your Personal Data

The security of your Personal Data is important to Us, but remember that no method of transmission over the Internet, or method of electronic storage is fully secure. While We strive to use commercially acceptable means to protect your Personal Data, We cannot guarantee its absolute security.

## 9. Children's Privacy

Our Service does not address anyone under the age of 13. We do not knowingly collect personally identifiable information from anyone under the age of 13. If you are a parent or guardian and you are aware that your child has provided us with Personal Data, please contact us. If we become aware that We have collected Personal Data from anyone under the age of 13 without verification of parental consent, we take steps to remove that information from our servers.

If we need to rely on consent as a legal basis for processing your information and your country requires consent from a parent, We may require your parent's consent before we collect and use that information.
