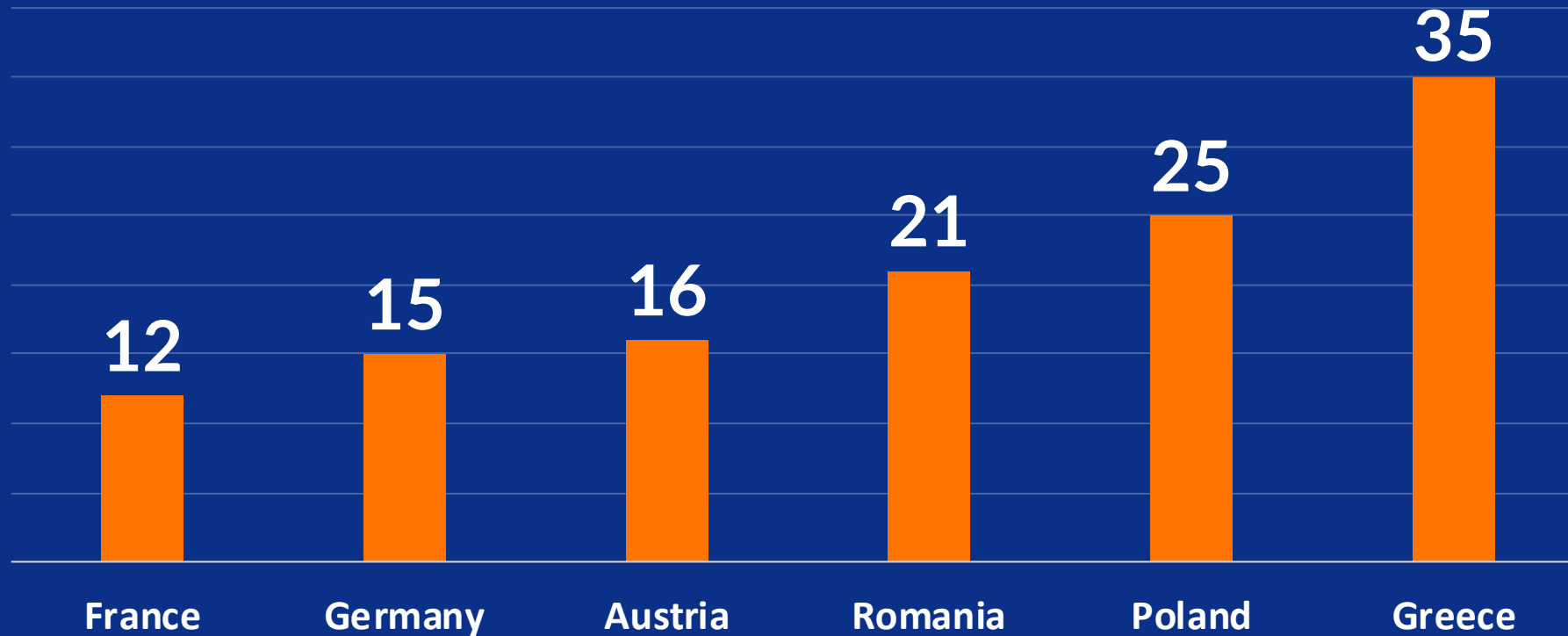

# The solution?

---

- New topic, simple as that

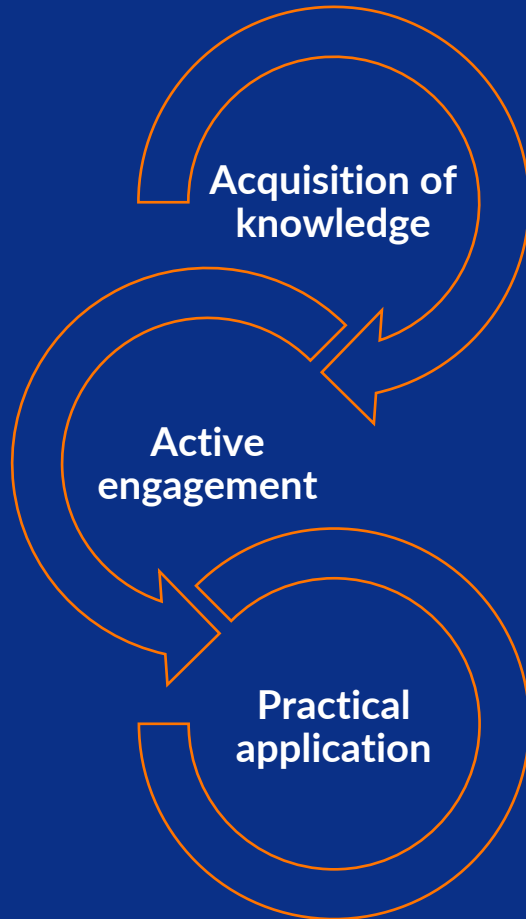
