

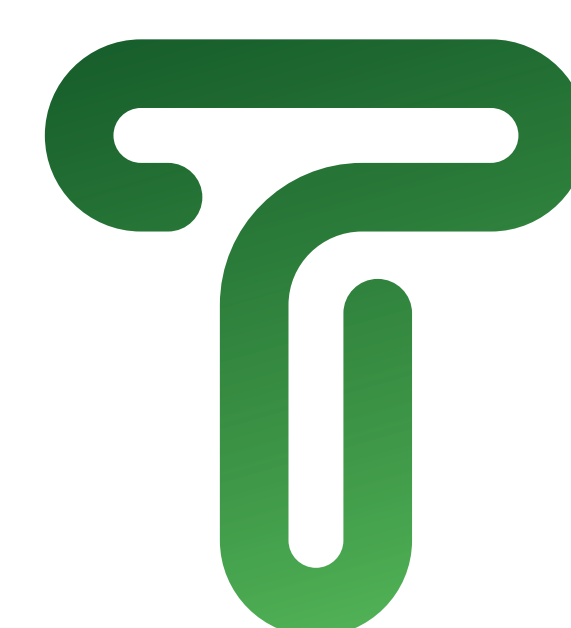

# What is ELSA Traineeships?

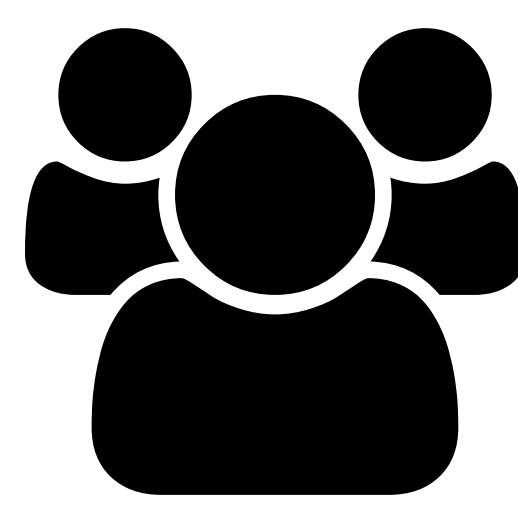

## **FORM**

Fill in the Traineeship Specification Form.

## **FREE**

There are no hidden administrative fees or costs.

## **COMPENSATION**

You must provide the trainee with a salary covering general living expenses.

## **STREAMLINED**

ELSA does all the administrative work, including the screening of applications.

## **PROMOTION**

Your organisation becomes visible to and known by ELSA's global network.

### **Shortlisted Candidates**

You will receive the short-listed candidates by 15 December 2022.

### **Ranking of Candidates**

You must complete the selection and ranking of the candidates by 9 January 2023.

### **Earliest Start Date**

The earliest start date for the trainees is from 1 February 2023 onwards.

### **Shortlisted Candidates**

### **Ranking of Candidates**

You must complete the selection and ranking of the candidates by 2 June 2023.

### **Earliest Start Date**

The earliest start date for the trainees is from 3 July 2023 onwards.

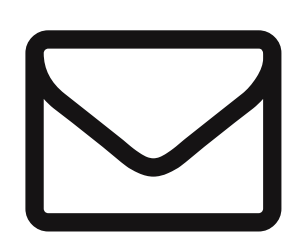
