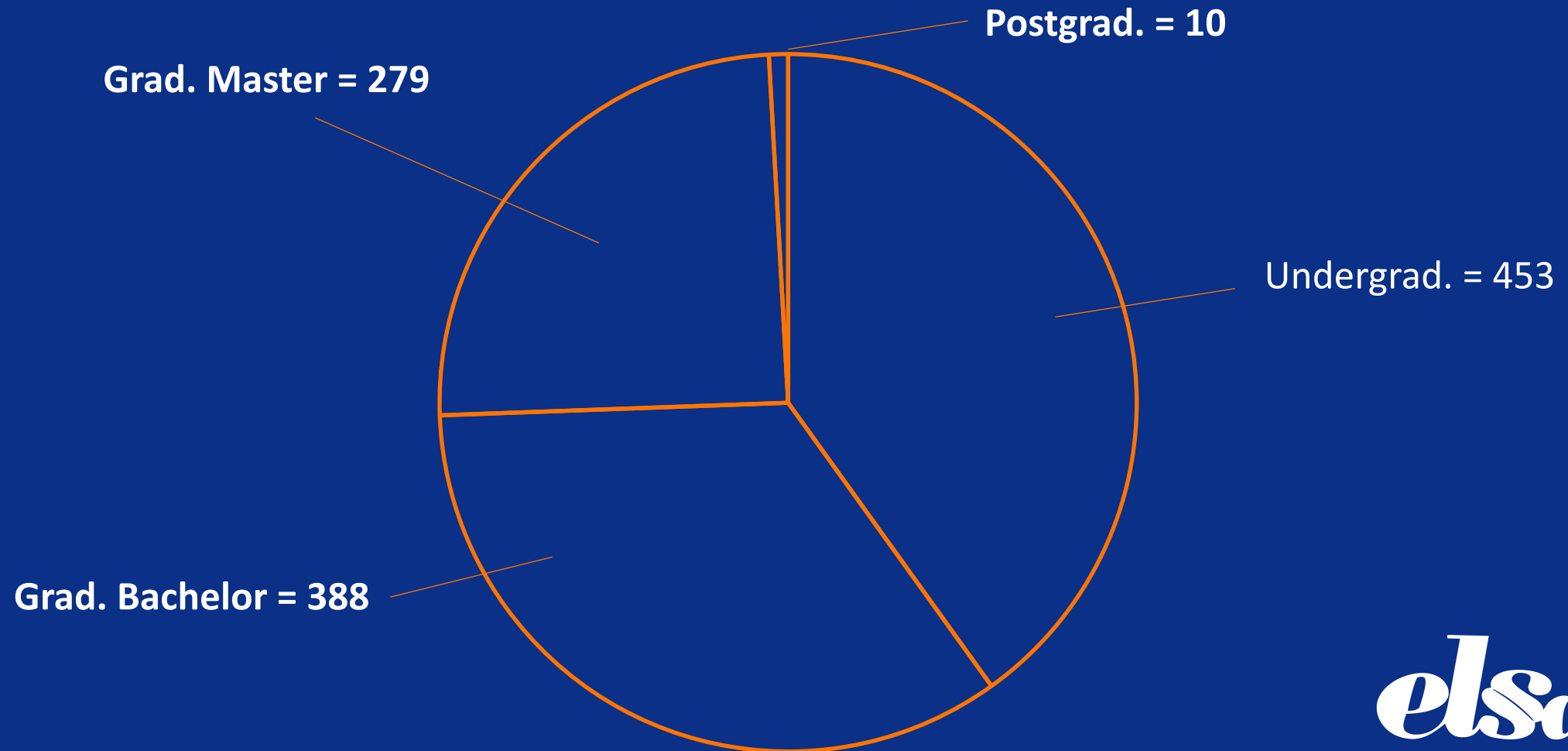
# Age of Applicants



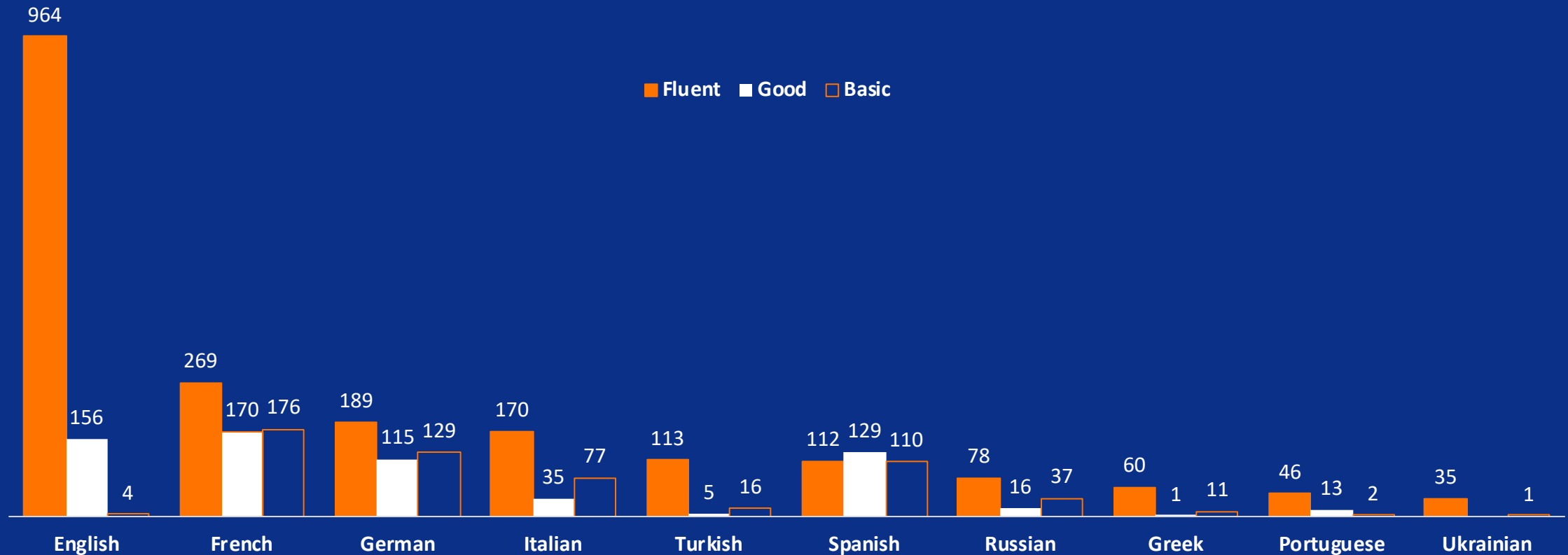


# Study level of Applicants

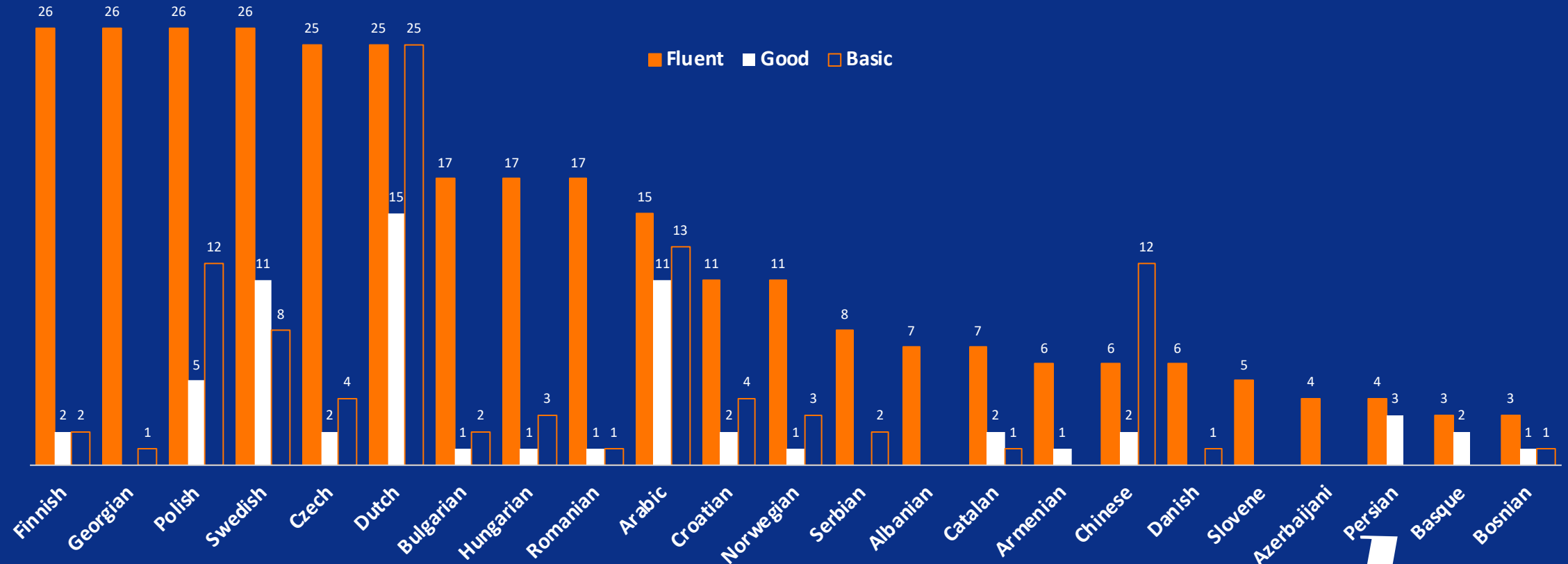

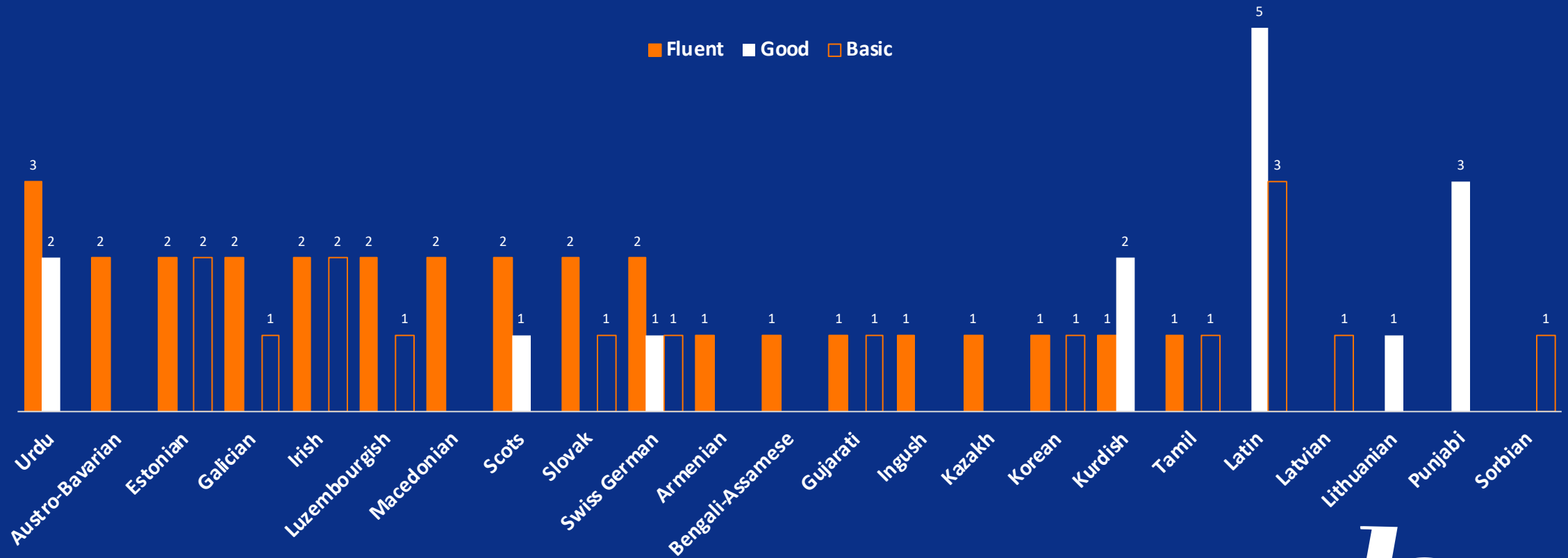
